Burgess Atkinson called the meeting to order and administered the oath of office to Councilmen Walter J. Baker, James H. Dunn and Fr ederick S. McCune and to Borough Auditor, George W. Keller, all having filed their certificates of election with the Borough Clerk.

The Burgess announced that he was ready to receive nominations for President of Council. Messrs. Hunt and Baker nominated Mr. John

E. Reed for President of Council.

Councilman McCune stated that he wished to make a few remarks before the vote was taken for chairman of council and said that he had been making an appraisal of the activities of Mr. Reed and that in his opinion there was a big man, big physically and in other ways one that had received over 1800 votes for councilman, one who had a host of friends that would be glad to see him receive the office of chairman of Council one of the highest offices which could be given to a citizen of the Borough and that he respectfully nominated Mr. Walter J. "To West View Council.

Gentlemen. -

The following members of the Finance Committee, after examining the report of the auditors, make the following recommendations:

l. Considering the sickness of Mr. Keller, we believe the employment of Howard Wilt as clerk to the auditors was necessary and recommend that Council ratify his appointment. We notice on page 2 of the Auditors' Report a footnote referring to street improvements, marked "subject to further audit now in progress." We recommend that the auditors finish the audit of the street improvement accounts and that Mr. Wilt be continued as clerk to the auditors on this improvement account.

2. We recommend that the auditors make a seperate audit of the

Borough books from January 1, 1932, to February 24, 1932.

3. We recommend that the auditors make another seperate audit of the Borough books from February 24, 1932, to the date of the appointment of Harry J. Rahn as Treasurer. We think that this is only fair to Mr. Rahn under all the circumstances.

4. So that proper entries may be made for all transactions from February 24, 1932, to the date of the appointment of Harry J. Rahn as Treasurer, we recommend that Mr. Ray Hall, who was authorized by

Council to make entries up to February 24, 1932, should be re-employed for the purpose of making such entries as should be made from February 24, 1932, the date of the death of the former Borough Treasurer, to the time of the appointment of Mr. Rahn.

5. We recommend that the Borough auditors continue to trace any leads which are in their possession or which have come to their know-

ledge in relation to the shortages shown by the audit.

6. We recommend that the Borough Solicitor take all necessary steps to protect the Borough in regard to shortages as disclosed by the audit.

In making these recommendations, we believe that the best interests of the Borough will be served and at the completion of these further audits, we will have a better understanding of the financial matters of the Borough.

Mr. McCune asked for information about Howard Wilt.

Mr. Dunn stated that Mr. Wilt was capable and familiar with the Borough affairs and a big help to Herr with the audit. Mr. McCune said he realized the work on the audit was a big task and he believed the auditors needed the help of a C. P. A. with a first class rating, that the work on the audit required the services of an expert and not an amatune.

Mr. Hunt stated that he believed the auditors were capable and that the majority of the people were satisfied, he asked Mr. Heer is a C. P. A. had not gone over the auditors findings re the shortages. Mr. Heer stated th t Mr. Seebring had checked some of their figures by various devices and had made no objections or corrections.

Dunn, Baker, - That Council adopt the recommendations of the

Finance Committee. carried, 5 yeas and 2 nays.

McCune asked if the Finance Committee of Council adopted the resolution. Mr. Dunn stated that the majority of the Committee had adopted and signed the resolution.

McCune, Baker, - That application of Mr. Bridewell for work on the

audit be referred to the Finance Committee. carried.

Mr. McCune asked Mr. Heer why he had not mentioned the Liberty Bond in his audits? Mr. Heer stated that he had always considered the bond as part of the Sinking Fund.

Hunt asked if the auditors had seen the bond and when it was last

seen. Mr. Heer stated he had seen the bond in January 1931.

McCune asked where he had seen the bond. Mr. Heer stated that he had seen the bond in Mr. Wagner's home. McCune asked why the bond was in the Treasurer's home. Heer said he believed Wagner had the bond at home for the auditors convenience.

Burgess Atkinson stated that he believed the bond and any other Borough securities should be in the Borough depository and that better plans should be made by Council to safeguard all Borough funds.

McCune asked if the auditors were making a further search for the missing collateral or if they were confining their search only to the Treasurer's accounts. Heer stated that he had been in every broker's office in Pittsburgh seeking information. McCune stated that there had been rumors of other officials being involved and believed all Councilmen's accounts and those of other Borough officials should be investigated. Heer, -"Investigate their personal bank accounts? McCune, -"Yes, There has been considerable smoke about this matter and we would like to see all innocent parties cleared."

McCune asked Heer if he had seen the bond a few months ago. Heer stated that he had seen the bond in January 1931. McCune asked if Heer was sufficiently interested to know that the document was a government bond. Heer replied that he knew a government bond when he

saw one.

Hunt, Baker, - That the Finance Committee and the Treasurer report on a plan of governing the finances of the Borough to stop any possible diversion of Borough funds by any officer of the Borough. c

Mr. McCune questioned Mr. Reed as Chairman of the Finance Comm.

Mr. McCune questioned Mr. Reed as Chairman of the Finance Comm. during 1931. Mr. Reed stated that whenever any matter was referred to the Finance Committee it was attended to and a report made to Council, that for the routine work on the funds of the Borough he did not believe it was the duty of the Committee but of the Treasurer.

Mr. Earl Jones asked if Council intended securing the services of a certified public accountant. Mr. Hunt stated that until such time as the present audit is completed and the present auditors given a fair chance to complete their work, no outside audit would be considered.

Hendler, McCune, - That Council get a (P. C. A.) C. P. A. audit of the Borough books for the years 1929, 1930 and 1931. motion lost by

a vote of five to two.

Mr. Earl Jones read off a list of questions which he asked Council to answer. Mr. Dunn asked for the written list but Mr. Jones stated he preferred to submit a list of the questions later.

Dunn, Hendler, - That Mr. Jones questions be answered at the next

meeting of Council. carried.

McCune asked the Solicitor if it would be possible to petition for an outside audit if the street improvement account audit developed further irregularities. Solicitor said he believed it would be possible and that it was now possible to ask for an outside audit if any citzen or citizens would furnish the necessary bond.

Hunt, Baker, - That Council adjourn. carried.

men and was not paying the wages he had promised when he was awarded
the contract.

Mr. McCune explained that the Joint Swwer Committee had both questions up with the Contractor at the Committee's last meeting, October seventh, and read a portion of the minutes, stating that the Contractor claimed that at the present time he was paying a minimum of 25d per hour for labor.

Mr. Schaffner of Ridgewood Avenue, stated he had been over the sewer job at different times, that the Contractor had his own organized gangs and plenty of machinery, that the maximum number of men working on the job was about 40 and that the way the job was organ-

ized it was impossible to hire very many local men.

Solicitor Gollmar stated that when the sewer bonds were sold Council believed that many local men would be given work, that it was a dissappointment that more West View men were not on the job, that when he received the report that the Contractor was paying 15¢ per hour, he called the Contractor and reminded him of his promise to pay 25¢ per hour, the evening the job was awarded.

Mr. Scheide, Inspector on the sewer job, stated there were three West View and one Ross Township man on the job where he was inspector.

Mr. Kiedaisch stated that he had heard that the Contractor was not fulfilling the requirements of the specifications, that if the Borough cannot have local men employed and if the Contractor is paying starvation wages, that he should at least be made live up to the specifications.

Mr. Dunn stated that if the specifications were not being

followed, the job should be stopped.

Mr. Hunt stated that if the job was not up to specifications, the Engineers should be fired. He asked Mr. McKown if it were true that the Contractor was not following specifications.

Mr. McCune stated that specifications were not followed in the backfill of a street in Shaler Township, and in the branch sewer paralelling Cemetary Lane and that the slag bed for the pipe was insufficient.

Mr. McKown, Engineer, stated that Walker Street, the street mentioned by Mr. McCune was not annimproved street and that was the reason it had not received the treatment specified for paved roads. Mr. McCune stated that it was a travelled roadway.

Mr. Dunn asked Mr. Scheide if all spefications were being carried out on the section of the job which he was inspecting. Mr. Scheide said "Yes. they were."

Chairman Reed instructed Clerk to arrange with the Contractor for

a meeting with Council, Thursday evening, October thriteenth.

Mr. Schaffner claimed that a ditch across North Park Road was draining the road water onto the middle of his property and asked that ditch be moved, at least away from the middle of the lot. Chairman referred the matter to Street Commissioner.

Dunn. Baker .- That Light Company be instructed to move light on east side of Perry Hi-way. just north of Wellington Drive, to the

intersection of Wellington Drive and the Highway. carried.

Hunt, Baker .- That a 400 c. p. street light be placed at the intersection of Perry Hi-way and Chalfonte Avenue and that Chief of Police purchase three white hats or white caps for use of police while directing traffic at the Junior High School after dark. carried.

Minutes of continuation of regular meeting of Council of October 11, 1932. Messrs. B ker, Dunn, Hunt and McCune present. Chairman Reed, Councilmen Hendler and Thompson absent. Burgess, Solicitor and Engineer absent.

Hunt, Baker, - That Mr. Dunn act as Chairman of Council. c.
After taking the chair Mr. Dunn stated the meeting was called
chiefly to confer with the Contractor on the Girty's Run Sewer job,
Mr. Thomas to find out if it would be possible to employ more
Borough labor on the work and to discuss the progress of the job.

Councilman Hunt stated that he felt Mr. Thomas should hire more local labor, that many of the men on the sewer job were not even citizens, that at present there was only one man from West View on the sewer job, that there may have been more but at present there was only one West View man working.

Mr. Thomas said he believed there was more than one man from West View on the job, that the watchman was a West View man.

Mr. Hunt said Mr. Thomas could not claim much credit for the watchman as he was getting a paltry \$50.00 per month, that the other West View men were laid off, that he was not blaming Thomas alone as he had sent a letter down with two West View men and they had both been put to work.

Mr. Thomas stated that he could not hire many local men, that he needed skilled pipe men, drillers and powder men; that the job was a bad one and he needed men who understood sewer work. That he did not know the West View residents and that he would not hire strange labor

unless the inspectors identified them as local residents.

Chairman Dunn asked how many gangs or crews were working on the entire sewer job and how many common laborers.

Mr. Thomas said about 30 pick and shovel men in the six gangs.

Chairman said about 10 men would be West View's quota.

Mr. Hunt suggested that a Committee of Council meet with the Contractor on the job and it was arranged for Councilmen Baket and Hunt to meet the Contractor at 10:30 A. M. October nineteenth.

Mr. Hunt asked Contractor if he could not place the slag base

40 feet ahead of pipe when laying same.

Mr. McCune stated that he would prefer that only the Engineers discuss construction plans with the Contractor, that all other persons

would work with and through the Engineers only.

Mr. Hunt stated that under Mr. McCune's plan the Borough got nowhere, that constant complaints were being made of an inferior job or one not up to specifications; that Mr. McCune was West View's representative and it was up to him to get a good job for the Borough.

Mr. McCune stated that he would not discuss the construction plans with the Contractor, that so far as he know, Mr. Thomas was a first class Contractor, that the trouble was with the Engineers.

Mr. Hunt stated that Mr. McCune as Chairman of the Sewer Committee should recommend firing the Engineers if they could not produce a good job and get new engineers.

Mr. McCune asked the Chairman to close the discussion.

Mr. Hunt asked the Contractor if he was complying with the specifications. Mr. Thomas said he was complying with the specifications and doing more than the specifications called for.

Mr. Hunt asked that Solicitor's letter re sewer job be read. Mr. McCune stated that the letter read as though the writer was responsible for raising the rate of pay on the sewer bob from 15ϕ to 25¢ per hour, that bone man by the name of Griffith had been paid 15¢ per hour as water boy and there had been no further evidence that any other worker had been paid 15¢ per hour; that it looked very much like a frame up when, according to the Contractor, Griffith offered himself for 15¢ per hour and as soon as he was paid, showed his check to the Township Commissioners.

Chairman Dunn stated that he did not like Mr. McCune's use of the words "Frame up" as it was an ugly phrase to use, that he thought Gollmar did right in writing the Contractor. That if the Contractor could have gotten away with paying one man 15¢ per hour, he might

have tried the same rate on other men.

Mr. Hunt asked Contractor if he could get labor at 15¢ per hour. Mr. Thomas said he could get labor at that rate.

Hunt, Baker, - That Solicitor's letter of October 11, be spread on the minutes of Council. carried, Mr. McCune dissenting.

"October 11, 1932.

"Members of Council, Borough of West View. West View. Pa. Gentlemen . -

Under date of October 7, 1932, a sheet edited by a man named Shaw and called "The North Side Ledger" published an article, headed

"Girtys Run Sewer Job is Placed on Political Altar."

In this article, the writer is charged with "using undue persuasion in getting West View laborers on the sewer contractor's payroll." I wish to inform Council that I consider it to be the duty of Councilman McCune, who is chairman of the joint sewer commission and West View's representative on that commission, to see to it that West View citizens are given as many jobs on this sewer contract as they are entitled to by virtue of the fact that West View is paying forty-one per cent of the total cost of this sewer, which I am informed is \$119,000.00. For that reason and because I believe it to be Mr. McCune's duty, I have not used any efforts to obtain jobs on this particular sewer contract for West View citizens.

I was informed by a reputable welfare worker who called at my home that one laborer on the job had received \$7.80 for a little less than fifty-two hours work. This man was paid at the rate of about fifteen cents an hour, which was a violation of the verbal agreement which the contractor made before signing his contract to the effect that he would pay from twenty-five to thirty cents per hour. Upon receiving this information from the welfare worker, I telephoned Mr. McCune and told him that I considered fifteen cents an hour for labor on this sewer job an un-American rate and that even in these times the Borough could not stand by an allow its contractor to pay this small amount per hour. Several days later I reveived a letter from Mr. McCune stating that before he could act, he would have to have proof. I did not want to engage in an academic discussion when citizens of West View were coming to my home for work at the rate of from thirty to forty a day and so I notified the contractor, as your Borough Solicitor, that we had an agreement with him whereby he would not be allowed to pay fifteen cents an hour. I understand the rate has been raised to twentyfive cents an hour and if my so-called interference has caused this raise. I am glad that I interfered.

Mr. Hunt asked how the Borough was going to get a job according to specifications if the matter could not be discussed with the Contractor and the Engineers were not enforcing the specifications. That he felt his suggestion of October 11, that the Engineers should be fired if the specifications were not being followed should benegaried out.

Mr. McCune stated that there had been no motion to fire the

Engineers.

Mr. Hunt insisted that he had recommended firing the Engineers if the specifications were not lived up to, and that it was the duty of the Ch irman of the Joint Sewer Committee to see that the specifications were followed.

Hunt, Baker, - Th t Council adjourn. carried.
