Minutes of regular meeting of Council of November 14th, and the continuation of same held November 21st, and minutes of special meeting of Council of December 2nd, read and ordered approved by Chairman Reed. Mr. McCune questioning the motion to pay \$75.00 for a portion of the rear of lot #1098 corner Vine and State Alleys. Mr. Dunn stating that the Borough saved money by securing the property by agreement rather than by viewers proceedings.
