NOW THEREFORE BE IT RESOLVED, That the Council of the Borough of West View petition the Pittsburgh Suburban Water Service Company to establish some centraly located point in the Borough of West View, at which the residents thereof may pay these bills in quarterly amounts, thereby saving to the citizens of the Borough of West View an unwarranted expense in connection with these payments;

The November report of the Chief of Police was read. The November report of the Fire Chief was read.

On motion by Mr. Dunn, seconded by Mr. Baker and carried, it was, "RESOLVED, That the Fire Chief make arrangements with Brants to deliver the ladders from Fire Company No. 3, in answer to all fire calls."

The Clerk was instructed to inform the Police Chief that the Officon duty is to notify Brants on all fire-alarms.

The November report of the Borough Electrican was read.

The report of the Finance Committee was read on the matter of the offer of Samuel Landis for the purchase of Lots 202 and 203 Hempstead Avenue.

On motion by Mr. Hendler, seconded by Mr. Baker and carried, it was, "RESOLVED, That the Clerk notify Mr. Landis of the result of Councils inquiry into the matter."

Oh motion by Mr. Warren, seconded by Mr. Baker and carried, it was "RESOLVED, That a receipted bill be accepted from the West View School Board for a certain number of wheel barrows and that we give them a receipt for the use of the tractor and grader."

Mr. Warren stated that the representative of the Bell Telephone Company had discussed with him the matter of Borough signs on Company poles and had requested that the signes be put up in such a manner as to be removable by workmen who are required by their work to climb the poles.

On motion by Mr. Baker, seconded by Mr. Dunn and carried, it was, "RESOLVED, That the matter be referred to the Public Works Committee and also the removal of the pole in front of the residence of Omar Richey, Center Avenue, with power to act."

Mr. Warren called attention to the importance of Botough employees being on the alert for accidents on Borough sidewalks and reporting such cases to the Solicitor at once.

Mr. Warren expressed his appreciation of the opportunity of serving in Council with Mr. Dunn and Mr. Baker and said he had enjoyed the association and that it had been a pleasure to work with them.

Mr. McCune also spoke to the members about the work done by Mr. Dunn and Mr. Baker during Mr. McCune's term as President of Council and thanked them for their cooperation.

On motion by Mr. Warren, seconded by Mr. Baker, Council adjourned.
