Meeting of council was called to order by the President of Council, a6 8:30 PM, Tuesday, December 16, 1941.

Roll call - present - Messrs. Macdonald, Stroje, Sweeney and Grey.

Minutes of the preceeding meeting were read and approved.

Payroll - was next passed among the members and on motion by Mr. Macdonald, and seconded by Mr. Stroje, that they be accepted and approved. Carried and so ordered.

On motion properly made and carried, that the Secretary be authorized to issue an extra payroll, on the day before Christmas to the Labors, for any time they had coming up to this time.

West View Park - Lr. Cane, took the floor to discuss the statement they received from the Borough as being out of line, due to the fact there was a gentlemen's agreement to some adjustments they felt were allowable and they were anxious to obtain corrected statement, so that they could make proper payment of same before the end of the year. After send discussion on the subject with Mr. Cane, it was suggested they mail a check to the Borough for what they thought was a correct amount, along wit' a notation of any deductions as made by them, and that it could be worked out satisfactorily by Council, and he premised the check within the next couple of days.

Mr. Zepp - from the audience tool the floor to learn just what was the distance between street lights in the Borough, as he was anxious that an additional light be placed on Ashford Avenue, near his home. The Chair enlightened him and he was requested to write his request to Council so that this matter could be considered by them in the 1942 Budget. At t is time in Stroje gave a complete detail on the Light situation, and he thought at this time, it was quite doubtful if the Light Co. would, place any additional lights in the Borough, due to the National Defense. However, he suggested that the Borough Secretary, write them to learn if they will place a one-hundred candle power light on the last pole on Beechmont Avenue, and one at about 256 Ashford A enue. Lotion seconded by Ir. Macdonald Carried and so ordered.

Mrs. Robinson from Ashford Avenue, also gave an appeal for such a light on this same street.

Hr. Hamburg, from the audience, spoke in behalf of Lr. Heindermeyer, in reference to his request that the Borouch give him permission to tan his sewers on to our main line, as he was putting the preperty (:ecch) into lots of 50 x 110. Both Mr. Fulton, the Boro Engineer, and Mr.S. roje, discussed this an on motion by Mr. Stroje, and seconded by Macdenald, that this matter be brought up at the next Council meeting, carried and so ordered.

No. 1 Fire Dept. - Mr. Stanger asked permission in behalf of the Fire Department No 1 for the priviledge of placing a bell on the lawn at the Boro hall to help celebrate the Christmas season, and on motion by Mr. Stroje, and seconded by Mr. Sweeney, it was carried and so ordered.

W.C.Fisher - The bore dog catchers application was read for 1942, and it was referred for consideration of the new incoming Council

Suburban Realty - The sewerage at the Gulf Building at Perry Highway and Highland Ave. was discussed and on motion by Mr. Stroje, and seconded by Mr. Macdonald, this matter be referred to the Solicitor, Engineer, and our Street Commissionor, for their recommendation to Council. Carried and so ordered.

Major Eichholtz - A letter was read from him requesting the payment of his balance due for services rendered and on motion made by Mr. Macdonald and seconded by Mr. Stroje, that we learn the amount that was paid and obtain from the subject our copies of Pland and Specifications. So ordered and carried.

A letter was read from the Fire Department requesting that the Photo of Mr. Martsolf, the first President of Council, adorn the walls of the Council Chambers, in a prominent place. It was advised that this was complied with before the receipt of this letter.

A letter was also read from the Fire Department requesting a new FIRE ALARM HORM be installed, and on motion by Mr. Stroje, and seconded by Mr. Macdonald that this letter be referred to the incoming Council Carried and so ordered.

Sam Landis - from the audience to ask council what was doing in behalf of the Borough toward Civilian Defense, He suggested we get busy on this program and work out some plan. Get a group of men together and organize such groups as FIRE DEPARTMENT, POLICE DEPARTMENT, PUBLIC SCHOOLS, PASTORS ETC. It was suggested a meeting be called, of all men and women who volunteered their services from the letter, sent out by the Secretary, and organize the CIVILIAN DEFENSE COUNCIL. Motion was made by Stroje, and seconded by Mr. Macdonald, that the President of council appoint a committee to begin this work. Messrs Stroje, Donaldson, Kaesmeier, Gollmar, Prof. Horsch, Farley and Ralph Moore, be appointed, and begin to function. Carried and so ordered.

On motion by Stroje and seconded by Mr. Macdonald, that we go into the reading of Resolution #293, so ordered and carried.

Resolution #293 read for the first time and on motion properly made and seconded that it be accepted as read. Ayes - Macdonald, Stroje, and Grey. Nays. Sweeney. Carried and so ordered.

Second reading, and on motion by Mr. Macdonald, and seconded by Mr. S^T roje, it was accepted as read. Ayes - Macdonald, Stroje, and Grey. Nayes - Sweeney.

On motion by Mr. Stroje, and seconded by Mr. Macdonald, that we suspend all rules to consider Resolution #293, Ayes - Macdonald, Stroje, and Grey. Nayes - Sweeney. So carried and so ordered.

Third and final reading of Resolution #293, and on motion by Mr. Macdonald, and seconded by Mr. Stroje. Ayes - Macdonald, Stroje and Grey. Nayes - Sweeney. So ordered and carried.

The Solicitor explained that this resolution in no way increased the expense of the Borough as of November 30th.

Mr. Sweeney at this time explained his reason for voting NO on this resolution and the Borough Solicitor advised him that an Act of Assembly permitted such transfers three months after the Budget being passed and approved.

On motion by Mr. Stroje, and seconded by Mr. Macdonald, that we return to the regular turn of business. Carried and so ordered.

On motion by Mr. Stroje and seconded by Mr. Macdonald, that the boro make a refund to Mr. Turick, covering the difference between a deposit that he had left with the boro, and the cost of materials that was used on sewer connections. This refund being approximately \$4.71. Carried and so ordered

Mr. Stroje, took the floor to discuss DEFENSE BONDS and went on to explain what a golden opportunity it was for the Boro of West View to do their part on this by taking a certain amount of cash out of the Sinking Fund and convert it into BONDS. He explained the various types of Bonds and what the interest were and that our Sinking Fund could be rarning a greater amount of interest due to this conversion. After some discussion on this it was suggested that it be brought up before the new Council, and that the Borough Solicitor be instructed as to the legality of such actions and report to Council.

Mr. Sweeney brought up several subject for discussion on what he termed unfinished business, that has been on the books for some time. Some of these were as follows: Curtis Avenue; the Athletic Field, Sewer and the Freehold. Mr. Sweeney said that Curtis Avenue, was a public Highway, and what about the lot that was involved in it. The Boro Solicitor advised that we could obtain a QUIT CLAIM DEED from Mr. Heintz, on this piece of property and on motion by Mr. S roje, and seconded by Mr. Macdonald that if this is to be continued as a Public Highway that the Borough Solicotor be instructed to obtain this from Mr. Heintz. Sarried and so ordered.

Engineer Fulton - reported on the Sorgi Surface Water Drainage, and it was suggested that the Pittsburgh Rwy. Co. be contacted and have them connect the drainage in the present sewer. Mr. Stroje, made a motion which was seconded by Mr. Macdonald, that the Pgh. Rwy. be authorized to do the work on Sorgi property as outlined in plan 3279, as presented by Mr. Fulton. Carried and so ordered.

The Heibner property on Park Avenue, was discussed as being too low for drainage out of their basement. Messers Martsolf and Fire Chief Kaesmeier also discussed this subject. On Motion by Mr. Sweeney, and seconded by Mr. Macdonald, that our Engineer Mr. Fulton, talk of this situation with The Heibner people. So ordered and carried.

Meeting adjourned on motion properly made and carried at 11:30 PM to meet on regular meeting January 13, 1942.
