Gentlemen:

I am returning Ordinance No. 839 without my signature and vetoing same, partly for the same reasons that I did not sign the Budget Resolution, Schedule C-1, and Resolution No. 377.

Those reasons, as given to you in my letter of Mar. 4, 1944, were "Because of the opinion given us by our Solicitor that it is illegal to assess an amusement park as a source of revenue and that we could charge the Park Company only for services rendered, such as police protection, etc." And because Section IV of this Ordinance which reads as follows: "Any person or persons, firm or corporation giving such entertainment or amusement as aforesaid, without first obtaining the necessary license or permit therefor, shall be fined not less than \$250.00 nor more than \$350.00 for each and every day on which such entertainment or amusement takes place."

And because the penalty fixed in Section IV of this Ordinance is in excess of an act of assembly passed May 4, 1927, P.L.519 Article 31 Section 3108 - which prohibits a fine or penalty of over \$100.00 for the violation of any Ordinance, therefor I do not think this ordinance could be legally enforced.

RE: Unexpended or unconsumed portion of bond issues.

Dear Mr. Smith:

I am advised by D. H. Peet, Treasurer of The Borough of West View that bond issue number 19 was authorized by Ordinance No. 765, by the Town Council, for street improvements in the sum of \$20,000.00. Mr. Peet has further advised me that there is a balance in this account of \$8,484.43. Council has requested me to prepare an opinion as to what disposition, if any, could be made of this anexpended sum.

The legislature of Pennsylvania passed what is known as "The Municipal Borrowing Law" in 1941, P.L. 159, which regulates and controls the entire question. Section 2011-216 provides, "The proceeds of the balance of general obligation bonds shall be used for the purpose of purposes specified in the Ordinance authorizing said bonds except where a change of purpose has been authorized under the provisions of 216 of this article. If for any reason any part of the proceeds is not applied to, or is not necessary for, such purpose or purposes, such unexpended part of the proceeds shall be paid into the sinking fund for such issue of bonds unless otherwise applied under the provisions of Section 216 of this article."

Section 216 provides, "Whenever any municipal authority has heretofore increased or authorized the increase of its debt with or without the assent of the electors of such municipality or shall hereafter so increase or authorize the increase of its debt, and the purpose or purposes of such increase or authorized increase have proved or shall prove to be impracticable, impossible or inadviseable the coporate authorities of the municipality may by their ordinance where such debt was increased without electoral assent or after electoral assent has been secured, as hereinafter provided, so declare and may provide for the use of the money so borrowed or authorized to be borrowed or any part thereof for any other purpose for which debt could have originally been lawfully increased."

It is my opinion that Council can either, by motion, direct the transfer of the \$8,484.43 to the sinking fund for such issue of bonds or Council may, by proper motion, direct that said sum be used for any purposes for which such debt could have originally been lawfully increased.

Bond Issue Number 17 was an electoral issue for \$75,000.00 and as of February 1st, 1944, there is a balance in this account of \$1422.09. The original issue was \$75,000.00 and after the payment of the Borough's liability for its share of installing the joint trunk sewer there was the sum of \$12,229.72 remaining in said fund. The people of the Borough of West View voted that said sum be used for the reduction of certain judgments held against the Borough of West View by the Hilltop Bank. An ordinance was duly passed and the unconsumed sum of \$12,229.72 was so used. The present amount of \$1422.09 represents the return to the Borough of its proportionate share of benefits recovered against property owners for which liens have been filed but for which the claims had not been paid.

Since this was an electoral issue the present balance could not be used for any other purposes except by the securing of the consent of the electorate. However, this sum of \$1422.09 could be transferred into the sinking fund for bond issue 17 by action of Council without taking the matter before the electorate.

to render an opinion regarding the disposition of the sum of \$4,365.06 carried in the Borough's account and designated as "Street Indemnity Fund."

I have attempted to inquire as to the origin of this fund. I have been advised by one of the former Solicitors of the Borough and by the attorney who represented the bonding Company, that this sum was paid to the Borough of West View in compromise of any claims which it had on a Maintenance Bond. Since the streets have been maintained out of the general funds of the Borough and since this money did not originate as a result of any bond issue, it is my opinion

that this fund can be used for any legitimate borough purpose.

Dear Mr. Smith:

Council has requested the undersigned, as its Solicitor, to make a study of all the Ordinances of the Borough of West View creating and authorizing all the bond issues of the Borough.

I have made a complete examination of each and every ordinance and I find that none of the Ordinances contain a "Callable" provision. In other words, each Ordinance contrains a provision setting forth explicitly the maturity date of each bond. It was the intention of Council, I believe, to refinance some of its issues upon which the Borough is paying a higher rate of interest than is now normally being paid, as a means of reducing the carrying cost of its bonded indebtedness. Since none of these issues contain a callable provision they could not now be called and refinanced. To do so would impair the original contractual obligation.

The Munitipal Obligation Act of 1941 provides that if the bond holders are agreeable they can surrender the bonds and take the new bonds of a municipality that is likely to or has defaulted in the payment of the interest on its bonds. Of course, the purpose of that provision was to give relief to municipalities who were or are in embarrassing financial status. Fortunately, this does not apply to West View Borough.

Therefore, I regret to inform you that you cannot call your bonds, but must pay them in assordance with the provisions of the various Ordinances authorizing and creating them.

The following report was presented to Council by the Special Committee which was appointed to investigate the manning of the fire alarm system in the Municipal Building.:

To The Town Council of The Borough of West View:

The President of Council, Mr. H. L. Smith, appointed the undersigned as a Committee to investigate the necessity of appointing two additional watchman for The Borough of West View by reason of the fact that the Fire Alarm System is unmanned at various hours each day.

While we are mindful of the fact that it is the duty of the Burgess to supervise generally the working hours of the Police Force, the question raised in his letter of September 20, 1944, has made it necessary for us to investigate the working schedule of the Police Force as well as that of the other Borough employees who work in

the Municipal Building.

Having made a thorough investigation of the conditions, we find that as of January 1, 1944, Council has furnished ample man hours to efficiently man The Borough Municipal Building and Police work at all times, and as of this date, Council is still furnishing ample hours. Therefore, The Borough could be effectively patrolled and the fire alarm system could be effectively attended with the present five man Police Force and the two Borough employes now employed in the Municipal Building.

Under the present system of working hours, there is at various times but one police officer on duty. This officer is assigned to the Municipal Building; consequently in the event of the receipt of a police call that would require him to leave the building, the fire alarm system would remain unattended during that period. Furthermore, under the present system, The Borough is not patrolled at certain hours. We believe that this is a serious matter; should the lack of patrolling become known, it undoubtedly would attract sneak thieves, holdups, robberies and other unlawful acts.

We believe too that every possible effort should be made by the elected officials of The Borough to curtail any additional or unnecessary expense. The employment of two additional watchman would increase the monthly expenses of The Borough by at least \$250.00, or the annual expenses by \$3000.00. Consequently the Borough Tax Millage would have to be increased.

It is therefore the opinion of a majority of your Committee that it is not necessary for two additional watchman to be employed by The Borough, provided the Burgess rearranges his schedule of working hours of the Police Force and uses the full amount of man hours which Council has provided.

Respectfully submitted, Signed Walter J. Baker, Walter G. Kress."

In answer to the question of the President of Council as to whether the Committee had been able to work out an efficient schedule, the Chairman of the Committee, Mr. Baker, replied "Mr. Chairman, the conclusion in this report of the Committee has been made after first making up a sehedule of man hours furnished by Council, of which there are ample."

The President of Council asked if the Committee was willing to submit a schedule. Mr. Baker replied:

"Being mindful of the Act of Assembly that the Council is empowered to hire and also to establish the amount of pay that Police are to receive for the number of hours they are to work, and the discharging, as provided in the Act, and the Burgess as to the time and place they are to work; I feel that the schedule is the responsibility of the Burgess and that he is responsible to the citizens through his neglect in not using the number of hours provided by Council; but, as I feel that Council is always desirous of first looking after the welfare of the citizens of The Borough, and should the Burgess desire to cooperate with Council to efficiently man and protect the lift and property of the citizens of The Borough, upon his written request to the Council, I will be glad to present to Council that Schedule."

RE: Transfer of funds in the Official Budget.

Gentlemen:

Mr. R. G. Ford, Chairman of the Finance Committee, has requested of me an opinion regarding the propriety of transferring funds in the Official Budget of The Borough, after its adoption, but before the expiration of the current year from one classification to another.

The Borough Code of 1927 made no provision for the transfer of funds from one classification to another. However, Section 1006 of Article X of that Act was amended in 1929, 1931, etc, and finally in 1943. As now written, the Act provides: "During any fiscal year, the Council may make supplementary appropriations or transfer appropriations from one classification to another, for any lawful purposes from any funds on hand or estimated to be received, including the proceeds of any borrowing theretofore or thereafter authorized by law, and in cases of emergency or in palpable cases of error, omission or other fortuitous circumstances, Council may make or ratify expenditures for lawful purposes and thereafter supply or augment the funds necessary therefor. Except in the manner and in the cases aforesaid herewith provided, and expect to pay expenditures that have accumulated and were not paid at the close of the previous fiscal year, and also for the payment of ordinary operating expenses pending the final adoption of the budget and tax ordinance, the council or other officers shall

not hire any work to be done, purchase any material, make any contract or issue any order for the payment of moneys by any agent of the Borough which will cause the sums appropriated for specific purposes to be excluded."

I have, as your Solicitor, from time to time advised you as to the propriety of transferring funds in the Budget from one classification to another. Each transfer was made to accomplish lawful purposes.

It is my opinion that this section of the Borough Code is somewhat ambiguous. Nevertheless, I interpret it to mean and so advise you that it is proper for the Town Council of the Borough of mest View to transfer appropriations from one classification to another, for any lawful purpose. The Legislature, however, has imposed a restriction on this broad power. Once the Budget has been adopted Council may not make any contract or purchase any material or hire any work to be done which will cause the sums appropriated for specific purposes to be exceeded. In other words, it would appear that it is the intention of the Legislature to require Boroughs to live within their Budget and not to over-expend the Budget.
