SECTION 1. That The Borough of West View make a temporary loan, the proceeds to be expended after January 1, 1945, from North Side Deposit Bank in the sum of Thirty Thousand, (\$30,000.00) Dollars, with interest at 2-1/2 percent, on the credit of The Borough of West View, in anticipation of 1945 Borough taxes to be collected and to be repaid out of the first monies available from the 1945 Borough taxes in such amounts, and at such times as monies may be required for Borough purposes.

SECTION 2. The proper Officials of the Borough of West View, namely, The Burgess, President of Council and Chairman of Finance Committee, are hereby authorized and empowered to execute such note or notes as may be required to borrow said sum of Thirty Thousand (\$30,000.00) Dollars to be used for Borough purposes.

SECTION 3. Be it further resolved that the Finance Committee of The Borough of West View is hereby authorized, directed and empowered to make the necessary arrangements to negotiate said loan.

We have received your letter of January 23, with respect to the action of Council regarding the proposed improvement of Highland Avenue in your Borough which is traversed by our Route 02089.

Our program of projects proposed for post war improvement, particularly, in the first few years, is confined to modernization of highways on the primary system which as you know are badly in need of reconstruction in this district. Therefore, the secondary roads in which Route 02089 would be classed has not been included at this time, however, we appreciate the value of this highway as a connection between the Ohio River Blvd and the Perry Highway and we will be glad to give it proper consideration.

It, No doubt will be necessary to make a complete location survey and a thorough study of the alignment and grades and we will start something moving at once to get this important phase of the work going.

We will confer with you just as soon as we have something definite to show you.

"Collectively and individually, the County Commissioners gave us plenty of encouragement about the project of paving of Center Avenue and said they were for it 100 percent. They referred to the problem connected with the Pittsburgh Railways Company who have the present Right of Way, and asked us to approach the Railway Company and sell them the idea.

We told the Commissioners we had an approximate figure of

\$320,000 for the cost of paving Center Avenue. This figure less about one third, or \$75,000, making a net of \$255,000 for paving Center Avenue, which amount they have already proposed for improving the Bellevue Highland Road.

Mr. Kane said "Do you have the Railway Company Consent", to which we answered "No."

He advised to get their consent - plead poverty - plead anything to sell them on the idea of paving Center Avenue and what it would mean to The Borough of West View.

Two days ago I got a letter from the County Commissioners outlining our conference. They told us what we had accomplished and what we have yet to do."

****Note**** The following is a copy of the letter Mr. Bernoulli refers to in the above statement:

"April 26, 1945.

West View, Pa.
Dear Sir:-

As a result of conference with committee from the Borough of West View yesterday, concerning the improvement of Center Avenue, from #14 Alley to the Perry Highway, a distance of approximately 12,705 feet, The Board of County Commissioners directed me to instruct John B. Sweeney, Director, County Department of Works, to meet with your engineers and go over this project and get some idea of costs from our standpoint, and to make a preliminary survey of the physical cost exclusive of the Pittsburgh Railways Right of Way. It was also suggested that your committee contact the Pittsburgh Railways Company to determine what disposition they will make of their right of way or what contribution they will make toward this improvement.

Chief Clerk."

Mr. Bernoulli continued his report as follows:

"We have an appointment with Mr. Fitzgerald of the Pittsburgh Railways Company for 3 o'clock Wednesday. We want as many Members of our Committee and Council and other Officials of The Borough to go to that meeting and present data in order to convince the Railway Company.

Today I had a call from Mr. Sweeney's Office, telling me that the Director and County Engineer will be at The Borough Building at 1:30 Thursday afternoon to go over Center Avenue to verify the cost it might entail.

It is the opinion of the Post War Planning Committee that if we are ~~not~~ successful with the Railway Company, the County Commissioners may hedge on their part; but they may go along with either side of the Railways Tracks.

We believe you people, as Officials of The Borough of West View, would rather give something to the people of West View rather than take away from them - the only way we can do this is to go to that meeting tomorrow and sell the Railway Company. If not, the Post War Planning Committee believe it will be necessary to recommend to Council the idea of a Bond Issue next fall.

The matter of doing to job tomorrow rests with this

Committee and as many of you people as possibly can be present at the meeting with the Railways Company and think of arguments to present. If you do not expect to be there, and you have some good points to present, we would like to hear from you tonight."

President of Council, Mr. Baker, said that he believed it would be advisable to try to sell the idea of "Good Will" to the Pittsburgh Railways Company at their meeting. Mr. Keist stated Mr. Bernoulli had covered the matter pretty thoroughly in his report.

Mr. Wilt stated that what impressed the County Commissioners was the fact that we knew what we were talking about, and that we were one organization that really came in there with plans in detail showing just where we were at and they asked Mr. Justema for his plans to work from.

Mr. Bernoulli said some of the points they had told the County Commissioners were Center Avenue is the main artery throughout West View, and from 14th Alley to Perry Highway is a distance of 12,705 ft. varying in width from 70 to 80 feet - the Pittsburgh Railway Right of Way being 30 feet. Center Avenue is a connecting link with Route #88 and Route #19.

Center Avenue is a natural connecting link with Route #88 and Babcock Blvd.

Center Avenue would relieve traffic on Babcock Blvd.

Center Avenue would relieve traffic on Perry Highway between Ross Township Municipal Building and Perry Highway & Center Avenue, a congested area with sharp curves.

Center Avenue would relieve traffic from Cornell Avenue & Highland Avenue.

Center Avenue would create very little, if any property damage, and West View no doubt would assume this.

Paving of Center Avenue would increase property values and stimulate building, thus increasing assessments and taxes.

Mr. Bernoulli continued as follows: concluding the report:

"We must have a very definite talk tomorrow afternoon. The Planning Committee is interested and hope you might enlighten us and if you plan to be at the meeting tomorrow afternoon." (referring to the meeting with the Pittsburgh Railways Co.)

Mr. Baker again stressed the idea of approaching the Railway Company with the idea of "Good Will".

Dear Mrs. Guckert

You have asked me for an opinion regarding the propriety of paying from the funds of The Borough of West View, members of the regular police force of the Borough for time worked by them as guards in West View Park.
In preparing this, my opinion, I have considered the "Salary Ordinance", The Borough Code, as amended, and the adjudicated cases. Section 3 of the Salary Ordinance provides in part -- "While the Chief of Police and the Patrolmen shall serve not less than 48 hours for each seven day work week--". The Borough Code of 1927 provides in part as follows:

"The Borough police shall receive a stated salary to be fixed by ordinance, and it shall be unlawful for any borough policeman to charge or accept any fee or other compensation, in addition to his salary, for any service performed pertaining to his duties or office except public rewards and legal mileage allowed for traveling expenses." Act of 1927 P.L.519, 53 P.S.13204.

The Act of 1927 was amended by the Act of 1937 and condensed to read

"The borough police shall receive compensation to be fixed in the same manner as the compensation of other appointed borough officers is fixed."

The time during which, the place where and the manner in which the Chief of Police and the police force shall perform its duties is under the control of the burgess of the borough. 1927 P.L.519, 53 P.S. 13,201. However, the Town Council has the power to determine the number of hours and the salary to be paid its police officers. The Ordinance, as now written, provides that the police shall not work less than 48 hours for each seven day work week. It is my opinion that the intention of the Town Council in employing the language set forth in the Ordinance was to protect the Borough by having its police officers available in the event of an emergency even though they may already have worked 48 hours in that particular week without extra compensation. I believe that it has been the experience of the Borough in the past for its police officers to work

more than 48 hours in one work week where an emergency or the exigencies of the case demanded without claim for extra compensation. It is the custom and the general practice for salaried personnel to work more than the minimum number of hours when necessity demands it; the consideration for this policy or practice is the security that an employee receiving a definite salary is assured. Therefore, it is my opinion that when a borough police officer has completed his allotted days work that he has the right to seek other employment. Under the Borough Ordinance, the people of the Borough are interested only to the extent that the police officer discharges his duty and is available in the case of an emergency, otherwise he can devote his 'off-time' as he sees fit. If, therefore, after having performed his regular duty for the Borough and thereafter works in West View Park, I believe that the Town Council can without danger or possibility of surcharge, pay him for the time worked by him on his 'off hours' as a Special Guard in West View Park.

The decided cases give us little help in reaching our conclusion, except that they indicate the general attitude of the Courts regarding police officers.

In Aliquippa Borough - vs - Hall, 21 District 774-1911, the Town Council paid two of its police officers in addition to their regular salaries, witness fees, fees for serving subpoenas and fees for making arrests. The Borough Auditor refused to approve the report and took exceptions to the payments mentioned. An appeal was taken to the Common Pleas Court of Beaver County which held that the policemen were entitled to witness fees, fees for serving subpoenas but not for making arrests while on duty. The court said, "In reference to the enforcement of Borough Ordinances, the duty of a policeman ends when he has made an arrest and delivered the accused into the custody of the proper officer or keeper of the Borough lockup or jail. It is no part of his duty to serve subpoenas or to attend hearings as a witness; if he performs such services or attends as a witness, he is entitled to fees the same as any other person."

The same conclusion was reached in Commonwealth - vx - McCafferty 20 Dist. 29 (1910), Commonwealth Ex rel McGandrew - Vx Jones, 14 Dist. 350, (1904).



I have just had submitted to me for signature, checks for payment of the wages of Special Guards employed by The Borough of West View Park.

While I am mindful of the importance of preserving the peace and protection of life, limb and property from injury and damage not only in West View Park but also in The Borough of West View, I am concerned about the increase of the cost of maintaining Special Guards at West View Park during the picnic season. I have checked the records and find the payroll for the period ending May 31, 1943, was \$281.10 and the payroll for the similar period ending May 31, 1944, was \$396.51, and finally the payroll period ending May 31, 1945, was again increased to \$519.41. I find that the payroll for the period June 1 to June 15, 1944, for Special Guards was \$750.13 and it was again increased for the same period, June 1 to June 15, 1945, to \$790.08.

Upon further examination I find the names of men acting as Special Guards who have not been appointed by Council. Also that two of the largest picnics which were formerly held at West View Park have not been booked for the past few years and the ones being held are the usual school picnics, from which I can see no emergency. As I understand it, these men can only be employed in the event of an emergency. Otherwise they must first be appointed and approved by Council.

Since taxpayers' funds are being used to defer the expenses of this special services, I am writing now to notify you that I will approve no further payrolls for persons who have not been appointed by Council as Special Guards, except in case of an emergency, when an explanation shall accompany the check. I feel further that you should exert every effort to maintain peace and tranquility at West View Park at the minimum expense to West View Borough.

Sewage The following report was received from The Municipal Authority of The Borough of West View.

"August 11, 1945.

To The Town Council of The Borough of West View:
Gentlemen:

You recently wrote this Authority regarding the sewerage disposal system of the Borough of West View and enclosed a copy of letter from the Department of Health of the Commonwealth of Pennsylvania dated May 16, 1945.

We have made such investigation as the records and facilities permit, have had the advantage of advice of our consulting engineer, and submit the following, not as a report on the matter, but as a statement of the facts disclosed and a request as to the course to be followed in such future investigation and action as you request us to take.

At present the sewerage system of West View area drains via Girtys Run through Ross and Shaler Townships and the

Borough of Millvale to the Allegheny River. These municipalities and The Borough of West View constructed the Girtys Run Trunk Sewer some years ago and have operated it since. West View Borough paid 36.74% of the cost of the installation, and at present pays 27.5% of minor repairs to trunk sewer in Millvale, 39% of the cost of such repairs in Shaler Township and 50% of such costs in Ross Township or West View.

Four possible courses for future disposal of sewerage appear available to West View Borough:

1. Independent action, including the construction and operation of a treating plant. This plant, if installed, should probably be located near the present point of delivery to Girtys Run. Girtys Run could thus be used for the outfall. In considering this plan, it must be remembered that a high degree of treatment would be required and operating costs would be borne entirely by West View consumers.
2. Joint action with other municipalities in the Girtys Run Trunk Sewer. This would have the advantage of utilizing the natural watershed and availing yourself of a gravity flow and also spreading the cost of the treatment plant over many consumers. One disadvantage is that the present trunk line (due to increase in population of some of the other municipalities) is becoming inadequate and an additional or new line may be required in the near future.
3. Joint action with the proposed centralized County Agency. This would no doubt require a number of large plants but no definite plans of the County are now available. In considering any such centralized agency evidence should be required to show that the additional cost of supervision does not increase the unit cost to consumers.
4. Joint action with the North Boroughs. This would require a pumping station to pump the sewerage from the Girtys Run area to the Ohio River Area. This plan, as in No. 2, has the advantage of spreading the cost over many consumers. It would be located in an area whose water requirements are not serviced by this Authority.

In considering the foregoing, the hilly topography of West View Borough must be kept in mind. In addition West View Borough has a very substantial investment in the present Girtys Run Trunk Sewer. If a system not draining through Girtys Run is considered attention must be given to the possibility of the sale of West View's interest in this sewer. This would require negotiation with the other interested municipalities.

We trust the foregoing will enable you to make the report to the Pennsylvania Department of Health which is required to be made by September 1, 1945. A sewerage disposal system would make a splendid post-war project.

The cost will be substantial. You will be interested to know that sewer systems and sewage treatment plants have a relatively high capital cost and relatively low operating costs depending on the degree and type of treatment.

Please advise us your thoughts with reference to what further investigation and information you desire and we will endeavor to obtain it.

Post War Plans ... The following letter was presented to Council by the President of Council, Mr. Walter J. Baker.

"August 16, 1945.

Members of the Town Council,
West View, Pennsylvania.

Gentlemen:

I sincerely regret that plans previously made prevent my attending the Adjourned August Meeting of The Town Council of The Borough of West View.

Council has made Post War Improvement Plans. The time for immediate action has arrived now that the war is over.

The improvement of Center Avenue is of greatest importance. Members of Council share with me, I am sure, the opinion that the grading, paving and curbing of Center Avenue through the entire Borough will contribute immeasurably to West View's advancement as a modern, leading community in Pennsylvania. It will create an attractive business district and will unite the districts of West View Borough into a common bond. It will increase the taxable value of the community.

The Borough Manager, at the direction of Council, has already drawn preliminary plans for this improvement. He has estimated the cost to be slightly in excess of Three Hundred Thousand Dollars.

Accordingly, I would recommend that Council immediately direct the Borough Manager to make a complete detailed plan of the improvement and the necessary specifications.

Council has already discussed the improvement of the other unpaved streets in The Borough of West View and it is its desire, I believe, that these streets be improved at the earliest possible moment.

We have also considered generally the building of recreational facilities on the Municipal Building Land which would include a swimming pool that could be used not only in the summer but during the winter months as well.

Money will be needed to finance these much needed improvements. Fortunately, The Borough is in sound financial condition and has the power to raise sufficient funds to finance this work. Council has the authority to raise, of its own motion, more than ninety thousand dollars by Councilmanic Bond Issue. The people of The Borough have the power to raise more than two hundred fifty thousand dollars by Electoral Bond Issue. Council should institute promptly action to bring this matter before the people in the November Election to determine whether or not it is their desire to approve the creation of a Bond Issue to cover the costs of these improvements. I have instructed the Solicitor to prepare an ordinance for your consideration, the purpose of which is to have placed upon the November Ballot, the choice of the people of West View to decide whether or not the sum of upwards of One Hundred Thousand Dollars should be raised for not only the improvement of Center Avenue and other unpaved streets, but also for creating and installing recreational facilities for The Borough. Although the One Hundred Thousand Dollars would not cover the original and complete cost of all this work, The Borough, under the law can recover from the abutting property owners at least two thirds of the costs of grading, paving and curbing our streets by Councilmanic Action.

It would be my further recommendation that in connection with the improvement of Center Avenue that Council further explore the possibility of securing County, State and Federal aid. I am satisfied The Borough can qualify for outside aid and no time should be lost in this respect.

I have instructed the Secretary of The Borough, and she has prepared petitions to be signed by the majority in

interest and number of property owners on the unpaved streets of The Borough, and would recommend that the first petition received signed by the majority in interest and number of the property owners asking for the improvement of their street be given first attention, and that other petitions received thereafter be given the attention of The Borough in the order in which they are received. It is entirely possible that at least one of the streets could be improved before the end of 1945. This depends upon the action of the property owners on unpaved streets in securing and having executed a signed petition.

The assistance of the various civic, business and patriotic organizations of West View should be enlisted.

West View Borough stands on the threshold of creating one of the most complete and best planned communities in the State of Pennsylvania. During the last several years, we have acquired a new Municipal Building which is complete in every detail and something for which each of us can be proud. Council has assisted in the securing of a Post Office in the Borough, which has been sought by us for many years. I believe that you should solicit not only the assistance of the business men but all of the people in The Borough for the creation of a banking institution in the community.

WE MUST NOT STOP NOW. The completion of these improvements will advance The Borough of West View. It will also afford employment for many people, particularly during the reconversion period.

LET US THEREFORE, ALL WORK TOGETHER FOR THE COMMON GOOD AND FOR THE BEST INTERESTS OF OUR BOROUGH.

Federal & ... The following letters were sent to The Federal Government, the State Government and The Board of Commissioners of Allegheny County as a follow up of the letter presented to Council by President of Council, Mr. Baker, at the August Meeting:

"September 11, 1945.

Honorable Walter S. George, Chairman,
Senate Finance Committee,
Washington, D. C.

Dear Sir:

I am writing at the direction of The Town Council of The Borough of West View to enlist your support in securing for it financial aid that will enable the completion of a much needed municipal improvement. If aid is to be given by the Federal Government we should like to have West View Borough be a recipient of financial help.

The Borough of West View is more than thirty five years old. It is located in Allegheny County, Pennsylvania, and has a population in excess of ten thousand. It has an assessed valuation of eight million, seven hundred thousand dollars. It is exclusively residential and has no industry whatsoever from which it can derive large amounts of taxes.

The topography of The Borough is rather unusual in that there are three distinct sections. However, we have what is known as Center Avenue which completely bisects The Borough, and on which there is operated an electric street railways system owned by The Pittsburgh Railways Company. Parts of this street have been improved by The Borough at its own cost and expense. It is generally believed that if Center Avenue could be graded, improved and paved from one end of The Borough to the other, that it would not only serve as a bond that would bind The Borough together but it also would attract commercial

enterprise, afford a convenient accessible shopping district and would increase the assessed valuation of The Borough. It would also serve as a connecting link for through traffic in this area.

Our Borough Manager has made a preliminary survey of the improvement and it is his opinion that the cost, exclusive of the improvement between the street car right of way, would amount to approximately four hundred thousand dollars. A group of our Borough Officials together with the Post War Planning Committee met with the Pittsburgh Railways Company regarding the improvement of their right of way. The Railways Company, as a result of this conference, caused a survey to be made and it estimates that its share of the cost of the improvement would be approximately three hundred thirty thousand dollars. Because of the estimated amount of the cost and because the company has not paid for similar improvements, it is our opinion that we can expect little help from the Railways Company. However, it is generally believed, that should the improvement be made, the Railways Company would grant to The Borough the right to use the improved portion of Center Avenue between the car tracks.

From the foregoing you can see that the cost of this worth while and much needed improvements far exceeds our financial ability and it is for this reason that we are writing to you for the purpose of enlisting Federal aid if available, to make this installation possible. In this Post War period, when the matter of unemployment is receiving Nation wide attention, we believe that should this project be approved and effected that a great deal of work and employment would be afforded to men in our community. It is significant to note that more than eight hundred ninety of the youth of our Borough served in the Armed Forces and it is entirely possible that many of the men would be interested in securing employment on public works.

Will you be kind enough to give this matter your attention and consider it not merely as a simple request without basis but rather as a sincere plea for help.

This same letter was also addressed to the State Post War Planning Commission.

The following letter was sent to the Board of Commissioners of Allegheny County:

"September 11, 1945.

Honorable John J. Kane, Chairman,
Allegheny County Board of Commissioners,
Pittsburgh, Pennsylvania.

Dear Mr. Kane:

You will no doubt recall that some months ago Members of the Official Family of The Borough of West View, together with our Post War Planning Committee, had a conference with the Board of County Commissioners of Allegheny County, the purpose of which was to enlist financial aid and assistance from Allegheny County in the installation and improvement of Center Avenue in West View Borough. You will also probably recall that the estimated cost of this improvement to The

Borough of West View was approximately three hundred twenty five thousand dollars.

At the suggestion of The Board of Commissioners the same group visited with and a conference was held with the Officials of The Pittsburgh Railways Company. The purpose of this conference was to determine what aid or assistance The Borough could expect to receive from The Pittsburgh Railways Company by virtue of the fact that their right of way is within Center Avenue. The Pittsburgh Railways Company caused a survey to be made and their estimate of the cost to the Railway Company for the paving of the right of way and the installation of new ties and rails is approximately three hundred thirty thousand dollars.

Because of the large cost to the Company and because of the fact that it is in receivership, it is generally believed we cannot expect too much help from the Railway Company. However, we do feel that should the improvement be made that they will grant to The Borough the right to use, as a public thoroughfare, the improved portion between the rails.

We are informed by newspaper release that The County intends to improve Center Avenue from Fourteenth Alley to Cornell Avenue, the purpose of which, we are informed, is to install an accessible connecting link with the Bellevue Road and the Ohio River Boulevard and the Perry Highway and the Rochester Road and the Babcock Boulevard. It is our sincere belief that this proposed improvement should continue at least as far as Township Road to more effectively connect the thoroughfares within mentioned.

From the foregoing, it is clearly apparent that the cost of this proposed improvement far exceeds our financial ability. Consequently we need aid and assistance. The Officials of The Borough of West View are determined to do everything within their power to make this improvement. It is with us not a mere whim or fancy but rather a determined plan.

Will you be kind enough to take this up again with the Planning Commission and The County Department of Public Works for their further consideration. Both the Post War Planning Committee and the elected Officials of The Borough will be pleased to attend any additional conference or conferences. We believe too, that it is significant that the amount of claim for damages, should this work be done, would be small. The cost of the work would also be proportionately small because of the width of the Right of Way and because of the fact that the grade is fairly well established and not too many cuts and fills would be required.

May we thank you again for your consideration in the past and may we further assure you that we will appreciate your further cooperation and assistance.

These items have been carried from year to year and represent what would be construed as "Assets". However, with the exception of the Joint Trunk Sewer item of \$990.40, the remaining items which total \$674.17 are not collectable and should be eliminated from the records. I recommend this action for the following reasons:-

1. There is nothing in the records of the Boro. to legally substantiate these alleged assets.
2. They are old and the Statute of Limitation of six years has outlawed their collectibility.

Another item of record, namely, "Unpaid Credit Balance, F. I. Gollmar \$784.38", should be eliminated as there is no evidence supported by any records or papers that would justify the Borough to assume this item as an obligation.
