Gentlemen of Council:

The Board of Assessment, Appeal and Review, of the County of Allegheny has completed its triennial assessment for the years 1947-1948-1949, for property situate in The Borough of West View for tax purposes.

When I received word that the new assessment had been completed, I caused an examination of the assessment records for West View to be made. It has, to me, disclosed startling information,

The total assessed valuation for all land and buildings situate in The Borough of West View, for the year 1947, for tax purposes, is \$8,198,070.00

There are in West View Borough, exclusive of the land comprised by West View Park Company, 3784 lots, which includes 26 undivided lots in the Voeghtly property and approximately 20 undivided lots in the Dr. Foreman, etal, property. 1812 of these lots are improved or have buildings erected on them.

The West View Park Company has the assessed valuation for lands and buildings for the years 1947-1948-1949 of \$159,145.00, made up by the following:

The average lot in West View Bor ough contains 4500 square feet of land, allowing for a street in front thereof and an alley in the rear thereof. Therefore, if the 32.129 Acres of land owned by West View Park Company were divided into building lots, the total of 310 lots would be realized. Consequently the total number of lots owned by West View Park Company would be 341 individual lots.

It is therefore, apparent that the 1812 improved lots which

comprise 47½ percent of all the lots in West View Borough are paying 89½ percent of the taxes. On a lot basis, the land occupied by the West View Park Company is assessed at an average of \$134.00 per lot.

It is my opinion that all of the land occupied by West View Park Company should be assessed for tax purposes on a par with improved property.

The West View Park Company is big business. I am informed that all of the stock of West View Park Company is owned by a holding company known as the T. M. Harton Company. Because of this involved corporate structure, it is almost impossible to determine its net worth or the profit realized from its operation on an annual basis. It would be helpful, I am sure, in reaching a fair assessed valuation of its property for tax purposes if the West View Park Company would disclose its corporate earnings and profits.

This is particularly true when you realize that for the year 1947 the assessed valuation of the land owned by the West View Park Company was not increased in value. The total increase on its assessed valuation was \$3,000.00, which was placed upon either amusements or buildings. By comparison, the Board has increased the assessed valuation of some of the residential properties in our Borough, used exclusively as a home, as much as three thousand dollars. The home owner is being penalized as shown in the following schedule:

West View Borough is essentially a residential area and the West View Park Company should be required to pay for its fair share of maintaining the cost of government.

A comparative analysis of taxes conclusively indicates, in my opinion, that it is not paying its fair share of the tax load. On a basis of an assessed valuation of \$8,198,070.00, with the Borough tax millage set at 12 mills, the total Borough Taxes for the year 1947 will be \$98,376.84. Of this sum \$1,909.74 will be the tax bill for the West View Park Company. In other words, the West View Park Company is paying 1.9 percent of all the Borough taxes. If we consider the 341 lots of the West View Park Company as improved and add to the total number of lots on which dwellings or business properties are prected, there are a total of 2153

improved lots in The Borough of West View, of which the 341 owned by the Park Company is equal to 16 percent of improved lots. The Park Company, therefore, on 16 percent of the improved lots is paying less than two percent of the Borough taxes.

I have read the Act of 1939, which relates to the method of assessing lands in Allegheny County for tax purposes. It is my opinion that The Borough of West View, in behalf of every home owner, owes a duty to file exceptions to the assessed valuation of The West View Park Company. If the assessment of the Park Company is increased, as in my opinion it should be, the home owner would not be required to pay an unfair share of the Borough taxes. Furthermore, if West View Park Company were required to pay its proper share of the taxes, we would have additional funds with which to make needed improvements in our Borough.

Accordingly, I would respectfully request the Town Council to direct its Solicitor to file exceptions to the assessed valuation of The West View Park Company for the years 1947-1948-1949 with the Board of Assessment, Appeal and Review, of The County of Allegheny, with the hope that this injustice may be corrected.
