#Allegheny County .. NOTE** At a Meeting of some of the Members of The Town Council and Mr. Horn, who has been assigned by Mr. Duff, relative to the earth fill from lots abutting along Perry Highway which might be available for Center Ave: the following is a brief summary:

All that the County can do on a contract would be to stipulate to the contractor that there is available at a given site some fill, and that if the contractor wanted that fill, he could take it. The contractor would require that, even though the County may not actually be engaged in the activities, a release from them for all damages for taking the fill. The first time reference was made to a date as to when Center Avenue would be developed was that they would not have anything ready for advertising before early fall of 1948, meaning that should it be advertised and accepted, the work would be started in the winter months. They have gathered the engineering data and are plotting on the detail paper for cuts and fills. Should the Borough proceed to make any changes in cross sections, etc, it would detain the County by them having to replot, refigure, etc; thus we would lose that time. Between now and the time for advertising, Council should be very careful as to what they do on Center Avenue.

That the proper officers of the Borough of West View, namely, the Burgess, the President of the Town Council and the Chairman of the Finance Committee, are hereby authorized and empowered to execute such note or notes as may be required to borrow said sum of money as may be necessary to carry on the affairs of The Borough of West View, provided the total amount does not exceed the sum of Thirty Thousand (\$30,000.00) Dollars.

We, the undersigned, residents of The Borough of West View

herewith present our earnest request to have the unpaved sections of the south side of Highland Avenue, lying between Bronx and Columbia Avenues, paved with a material and width to conform to any existing ordinances and in a manner comparable to other sidewalks throughout the Borough.

We believe this request to be urgent for the following reasons:

1. The lack of paved sidewalks has the tendency to entice school children to walk on the paved street to avoid mud and slush.
2. Very small children do walk on the paved street without realizing the ever present danger.
3. The area of the sidewalks, above referred to, not being defined, is therefore open to question, and are being used as private driveways for automobiles, thereby creating an ever present dangerous condition for children compelled to follow that course on their way to school.

We, therefore, pray that your august body give heed to this petition and have this dangerous condition remedied at the earliest moment by the employment of the provisions now contained in Ordinances of prior enactment.

Roll Call - Ayes: Messrs Ford, Hurley, Kallenbach, Kress, Stroje, Winter and Herrington. Nays: None.

Carried and so ordered.

(Ordinance No. 889 is the Ordinance providing for an Admissions Tax.)

Councilman Ford made the following statements:

"If Council reduced the amount of the Admissions Tax, Council would be compelled to forego some of the improvements contemplated to be made in The Borough. If we are to go ahead with the contemplated improvements, we must have more money, as indicated in the report of the Borough Manager. For example, we need a highlift and other equipment of that type and we want to install black top surface on some of our streets. The Manager of the theater was contacted and he is not in favor of 10 percent, but he has stated his willingness to go along and accept the 5 percent. The President of the West View Park Company was similarly contacted and he likewise objected to the 10 percent tax and also expressed his willingness to accept, without contest, a tax of 5 percent. However, the West View Park Company, as a consideration to the 5 percent tax, imposes the following conditions:

1. That the tax be calculated on the Federal Tax Basis at 1/4 of one cent on each 5 cents or major portion thereof.

2. That children under twelve be exempt where admission is less than 10 cents.

3. That the cabaret tax be eliminated.

4. That the amount of the Amusement License Fee be reduced to the amount actually paid by The Borough of West View for special guard duty.

5. That the current litigation with West View Park with reference to its assessment for tax purposes, which is now in the Courts, be withdrawn.

6. That no increase or other tax be put into effect that will affect West View Park Company.

Consequently, we are in a position where we must either raise taxes on real estate or levy a tax from ~~other~~ ^{some} source, as is provided by Act 481 of 1947.

It is my opinion that West View Park is attempting to drive a hard bargain. I say that in the presence of the representatives of the Park who are here tonight. I ask that you please bear in mind that this is not a tax paid by West View Park, but my people who are customers of West View Park."

Motion by Mr. Hurley, seconded by Mr. Kallenbach, that the remarks made by Mr. Ford be placed on the Minutes of this Meeting for a matter of record.

Carried and so ordered.

Mr. Bergstrom, Attorney for West View Park Company, made the following statements:

"Mr. Ford, there are a couple of matters I would like to discuss with reference directly to the remarks you made. You mentioned that there has been a lot of unfavorable publicity in the newspapers about The Borough. Surveys show that approximately sixty amusements taxes have either been adopted

or considered throughout Pennsylvania, and it was a surprise that there was not one municipality in the State of Pennsylvania that had proposed or adopted a total of 20 percent. The highest is 10 percent and the amusements tax seems to run from 2 percent to 10 percent. If there is a reasonable tax that will permit the poor people to come out to the Park and spend their money, the Borough will then be able to collect the tax.

As to the license fee, when I was asked by the Park Company as to whether it was legal, my answer was that I did not feel that it was. However, I recommended that no legal action be taken.

The Park complains of inadequate protection and claims at times the lack of police protection was due to other reasons than neglect.

As to the Real Estate Assessment, an attempt is being made to raise that, and the matter is now in Court.

It was proposed by both the School District and Council to each levy a 20 percent tax; now each has come down to 10 percent.

You can see the whole thing is more or less a pattern and we do not know where it is going to end. We feel that all the difficulties of the past and the causes should be removed, and the Park and The Borough work together as a happy family - we would like to achieve this.

The Park is willing to go on a five and five basis providing the conditions that have been stipulated will be met. We can be friends. We are going to improve the Park. The more successful we are, the more you will get for your public improvements."

Mr. Gollmar, Attorney for the Gerard Theater, made the following statements:

"I think I said, at the last Meeting held, everything I need to say in behalf of Mr. Nash in relation to this Ordinance. Mr. Ford said the Park is driving a hard bargain, and that, of course, is a matter for your consideration. As far as the theater is concerned, we haven't anything to bargain with. We only argue the theater is a very important part of the recreational part of your Borough and the people you collect taxes from, even though not paid by the management, it is paid by the people of your community and as such should be given consideration.

If the admissions tax would be put on at 10 percent, it is quite likely the attendance would drop considerably and competition would be so keen it is just a question of whether or not it could be met. It has been said by the Attorney from the Park that they are willing to accept a five and five proposition. I think I can say for Mr. Nash that he will accept that, although we still say the children under 12 years of age should be exempt. The 10 percent will be to our disadvantage, but regardless, Mr. Nash has said if this body will agree to a five percent, and if the school will agree to that, he will be willing to go along. We realize the Borough must raise some money. I am authorized by Mr. Nash to say he hopes you will be able to arrive at this 5 percent basis and it will be

satisfactory to him."

After questions from Mr. Kallenbach as to what Mr. Bergstrom meant in his statement of the matter taking on a "Pattern."

Mr. Gollmar continued - "Mr. Nash has just said a survey has been made by Allied Theater Owners of the U S and so far as the movie business is concerned, if there were a tan of 20 percent, i. e., 10 and 10, it is the highest in the U S that has been put on movies."

Mr. Baker, the Burgess, remarked relative to the complaints about protection for the Park being unjust in that an incident arising in 1947 was never referred or reported to the Burgess by any Member of the Park Company, and he stated that after he became aware of the incident, there was a lack of cooperation by the Park Company Officials. Mr. Bergstrom assured the Burgess that the matter of guards and protection would always in the future be taken up directly with the Burgess.

Mr. Herrington - "Mr. Bergstrom, on the points given to me on the phone in an effort to compromise this matter, the first item is the 1/4 cent on each 5 cents. It has been pointed out by Mr. Brandt that the amount of the tax must be imposed in amounts divisible by our monetary system."

There was a discussion about the other items, particularly in RE: the Tax Assessment Case, and Mr. Bergstrom stated the Park would not drop that item.

Motion by Mr. Kress, seconded by Mr. Hurley, that Section 3 of Ordinance No. 889 be amended to read:

"SECTION 3. There shall be levied, assessed, collected and paid, and shall become effective immediately upon the adoption hereof, as provided by law

(a) SINGLE OR SEASON TICKET: SUBSCRIPTION.

(1) RATE - A tax of 1 cent for each 10cents; or any portion thereof of the amount paid for admission to any place, whether paid in the form of a ticket, donation, subscription or other form of admission arrangement. In the case of persons (except bona fide employees, municipal officers on official business, children under twelve years of age and members of the military or naval forces of the United States when in uniform) admitted free or at reduced rates to any place at any time when and under circumstances under which an admission charge is made to other persons, an equivalent tax shall be collected based on the price so charged to such other persons for the same or similar accommodations, to be paid by the person so admitted. No tax shall be imposed on the amount paid for the admission of a child under twelve years of age if the amount is less than 10 cents,"

Also, that Section 15 be stricken from Ordinance No. 889 in its entirety.

The President of Council, Mr. Herrington, declared a five minute recess.

The Meeting was again called to order after the recess by the President of Council.

Mr. Bergstrom - "I have discussed this problem with Mr. Fencker and Mr. Newman, and I will take the responsibility squarely on my shoulds, a job I will have to sell to the Park Officials, if this group here tonight will drop to the 5 percent admissions tax; I will on behalf of the Park withdraw the remark with reference to the police fee or permit fee and the real estate tax case, and I assure you gentlemen if you will do that, I will do everything within my power to avoid litigation of their real estate appraisal case. I am going to recommend to my people that without delay, they promptly get together with your committee and your solicitor, or whomever you may appoint, to attempt to adjust that case and get it off the records in Common Pleas Court, or in other words, try to get that case settled.

Gentlemen; I wish you would kindly consider this proposal I have made, and I realize that it is a matter for The Borough, but I assume that the motion can be withdrawn and a new motion made for 5 percent. I am asking you sincerely and in good faith, that you do pass a 5 percent admissions tax because I think it is the just thing to do for all parties concerned."

Mr. Brandt was asked by a Member of Council, if the Ordinance is adopted now, can it be amended later. The answer was "Yes."

He was also asked, "Can the Members of Council go into Executive Session?"

The Answer was "Yes".

Mr. Brandt asked the following questions of Mr. Bergstrom:
1st - "If Council decides to go along on a 5 percent Admissions Tax, with respect to your amusement license fee, will you withdraw any exception to it? Mr. Bergstrom answered "Yes."

2nd - "With respect to the matter of the appeal from the assessed valuation of the Park, I understand you propose that if Council will agree on a 5 percent basis, you will assume the responsibility of recommending that a compromise be reached so that the matter would not have to be litigated."

Mr. Bergstrom answered - "Yes".

Mr. Brandt: - "You know who made our appraisals. Would you agree if this Council reduces the Admissions Tax to 5 percent, with respect to the compromise, would the West View Park Company be willing to designate an expert, and he and our expert select one more expert, and the three of them settle the question?"

Mr. Bergstrom:- "Attorneys usually settle matters. I would be willing to sit down with you and talk this over and make recommendations to our clients, and clients often follow their attorney's recommendations. I will go so far as to say I will recommend settlement as litigation creates enemies and I am going to try to get this case settled on a friendly basis."

Mr. Kress: - "If we grant this proposition, I want to know if Mr. Bergstrom can give us a definite time when they will agree to get together on the talks on the assessed valuation. Can you give us your word of honor that you agree to do this in ten days?"

Mr. Bergstrom: - "We did not institute that litigation. If it is going to be dropped, The Borough will have to drop it, but I will assure you I will do everything possible to get this litigation disposed of within ten days."

The President of Council, Mr. Herrington, called for an executive session for five minutes.

Meeting called to order at 11:55 by President of Council.

Mr. Kress withdrew his motion relative to Ordinance No. 889.
Mr. Hurley withdrew his second to the motion.

Mr. Herrington addressed Mr. Bergstrom as follows:
"We have done this, and ask that you have a committee in authority meet with a committee of The Borough Council on Saturday afternoon, April 17, 1948, at 2:30 in this building. Our Committee will be the Solicitor, the Burgess, the Chairman of the Finance Committee and myself."

Mr. Bergstrom consulted with Mr. Newman as to whether Mr. Harton would be available and Mr. Newman assured him he would be, and Mr. Bergstrom agreed on the Meeting.

Mr. Gollmar and Mr. Nash were asked if they would be available on a half hour's notice if needed on Saturday, and the answer by Mr. Nash was that Mr. Gollmar would be and that anything Mr. Gollmar did would be satisfactory to Mr. Nash.

Motion by Mr. Kress, seconded by Mr. Winter, that this Meeting adjourn to an Adjourned Meeting, Tuesday, April 20, 1948, at eight o'clock.

WEST VIEW BOROUGH COUNCIL MEETING

April 20, 1948

Minutes of an Adjourned Meeting of The Town Council of The Borough of West View, held Tuesday Evening, April 20, 1948, in the Council Chamber at the Municipal Building. This was an Adjourned Meeting of the Meeting of April 13. Meeting was called to order at 8:17 by President of Council, Mr. L. L. Herrington.

Roll Call Was answered by the following Members of Council: Messrs Ford, Hurley, Kallenbach, Kress, Stroje and Herrington. The Solicitor, Treasurer, Manager and Secretary were also present.

Ordinance #889 .. Mr. Herrington asked Mr. Bergstrom, Attorney representing West View Park Company, if he had any remarks to make in reference to the amount of Admissions Tax.

Mr. Bergstrom's reply was as follows:

"I represent West View Park Company and it is our desire that you gentlemen, this evening, pass a 5 percent admissions tax on the same basis as in the same language contained in the resolution as has previously been introduced. In our opinion, 5 percent is a reasonable tax and if you gentlemen will pass the 5 percent admissions tax, West View Park will not take any action against either the imposition or collection of a 5 percent admissions tax."

Mr. Herrington asked Mr. Gollmar, Attorney representing the Gerard Theater, if he had any remarks to make.

Mr. Gollmar's reply was as follows:

"I agree with everything that Mr. Bergstrom has said except I want it clear that if you pass the same thing next year and financial things would change for my client, he would have every right to appeal it."

Mr. Brandt: - "This Ordinance is not limited to the present year.

Mr. Gollmar: - "Then if in ten years from the date of this ordinance, if it were still in existence, the 5 percent would stand."

Mr. Brandt, to Members of Council - "As I understand from the statements made, the effect of it is they will not take any action from the imposing of the tax at this time and that they consider the 5 percent tax to be reasonable at this time."

Mr. Bergstrom - "That is correct."

Mr. Gollmar - "That's all I have to say."

Mr. Brandt to Mr. Gollmar - "Then do you agree with what Mr. Bergstrom has stated and are you willing to state the same?"

Mr. Gollmar's Reply - "If you pass the 5 percent admissions

tax in accordance with the terms of Ordinance 889, my client will not take action to the Court of Quarter Sessions or Court of Equity, but I make this qualification, that if next year, in the opinion of my client, he feels 5 percent is too much, he is in no way restrained from taking an appeal to Council to reduce the amount."

Mr. Brandt - "The purpose of the statements tonight is to clarify the attitude of the West View Park Company and Mr. James Nash, in behalf of the Gerard Theater, with respect to the reasonableness of the 5 percent admissions tax."

Motion by Mr. Strojce, seconded by Mr. Hurley, that Ordinance No. 889, Section 3, be amended so that it reads as follows: "There shall be levied, assessed, collected and paid an Admissions Tax, and it shall become effective immediately upon the adoption hereof, as provided by law:

(a) SINGLE OR SEASON TICKET: SUBSCRIPTION.

(1) A tax of 5 percent of the amount paid for an admission to any place, whether paid in the form of a ticket, donation, subscription or other form of admissions arrangements, is hereby imposed,

and that Section 15 be deleted from the Ordinance."

Roll Call - Ayes: Messrs Ford, Hurley, Kallenbach, Kress, Strojce and Herrington. Nays: None.
Carried and so ordered.

Mr. Brandt, quoting from a conversation he had with Mr. Bergstrom, - "With respect to the provisions of sub paragraph (b) of Section 3, it is my opinion that no admissions tax is to be imposed on any refreshments, service or merchandise sold in connection with a cabaret, roof garden or dance floor if an admission charge is made and a tax imposed and paid on that charge."

Motion by Mr. Strojce, seconded by Mr. Ford, that Ordinance No. 889 as amended pass third reading and final passage.

Carried and so ordered.

Motion by Mr. Ford, seconded by Mr. Hurley, that Ordinance No. 889 be advertised in the official paper of The Borough, The Allegheny Journal.

highways of The Borough, that mar the beauty thereof, which I believe the citizens of our Borough have the right to expect.
