Dear Mr. Herrington:

You have asked us to determine the liability, if any, of the elected tax collector of the Borough of West View and her surety to account for tax monies collected by her in the event of theft, robbery or larceny or in the event of the liquidation of her depository before the tax collections are actually delivered to the Borough.

In order to fix the rights of the Borough should the tax collections be stolen or in the event of the liquidation of the depository before the funds reach the Borough it is necessary to determine the legal relationship between the Borough and the tax collector.

The relationship between a tax collector and the Borough is peculiar; in some respects it is that of bailee - bailor, but with far greater care and responsibility. A tax collector may be said to be a Trustee, but yet, the exercising of the utmost care and diligence is not the limit of his responsibility.

A bailee or trustee would not be responsible to his principal if the subject of the bailment or trust were stolen from him without any negligence on his part, but it was held many years ago in an action against a town tax collector and his sureties on the official bond brought for the default of the collector in not paying to the County Treasurer the money required to be collected by the annual tax list and warrant issued by the Board of Supervisors. that it was no defense that the tax collector had collected the money and that the same had been stolen from his dwelling house "without any fault, want of care or ommission of duty" on his part. Muzzy -v- Shattuch, 1 Demrio, 233 New York State, 1845. In that case, the statutes imposed a definite liability on the tax collector and his sureties for the ommission to collect and pay and whether that ommission is the result of misfeasance, negligence, unavoidable actions, or felony committed by another furnishes no defense to the action.

The statute in Muzzy -v- Shattuch required a "bond conditioned for the faithful performance of his duties as collector". That statute is similar to the Pennsylvania statute which requires a Bond to be filed by the tax collector.

While there has been no decided listed cases on this question of law in the State of Pennsylvania, it has been repeatedly affirmed in a long line of cases in other jurisdictions in the United States.

The most recent case on this question was decided on April 12th, 1938, in Bird -v- McGoldbrick, City Comptroller, 277 N. Y. 492 (New York Supreme Court), where by statute the Clerk of Courts was required "to assume charge and control of, and be responsible for, the general conduct of business of his office and for the faithful discharge of the duties of the deputy and assistant clerks and other officers connected with the court; collect and receive all fees, and account for and pay the same into the City Treasury monthly". It was held in that case that where through no fault of his own there was a shortage in the money due the treasury, that the comptroller and his surety were responsible.

It is, therefore, our opinion, that if the tax collector of the Borough of West View has money in her possession which she collected from taxpayers and the money is thereafter stolen, without any negligence on her part, that both she and her surety, under its faithful performance bond, would be liable.

Our final question resolves around the liability of the tax collector in the event of the liquidation of her depository before the tax funds are remitted to the Borough. The Supreme Court of the United States had this question before it in 1937 and held that a public officer who alone had the authority to select the depository for funds handled by him was not relieved of liability in the event of loss through the closing of the depository. The rule would be otherwise if the depository was fixed by law (Ordinance) or selected by the municipality.

In West View Borough the depository is chosen by the Town Council of the Borough of West View Borough, as the governing body of the municipality. Consequently, the corporate surety of the tax collector would not be liable for any loss sustained by the Borough in the event of the liquidation of the depository. However, the Borough of West View is protected, because, under the Borough Code, the depository is required to deposit United States Government Bonds, in escrow, to guarantee the payment of all demands made upon it by the Borough through its several accounts.

It would be our suggestion that a copy of our opinion be forwarded to the tax collector's surety for the purpose of having it verify our conclusions.

Police & Public Safety: RE - Women's Volunteer Safety Patrol: Mr. Baker, Burgess, Mr. Hurley, Chairman Police & Public Safety, and Mr. Brandt, Solicitor, directed notices to each of the several civic groups in The Borough of West View requesting them to attend a meeting to be held at the West View High School on Tuesday night, March 7, 1950, at eight o'clock. In response to the notice, 21 ladies attended, as well as representatives from No. 1, 2 and 3 Fire Dept and the Wellington Heights Community Association.

Cards were passed out to each person in attendance after the proposed organization, its purpose and the plan had been submitted to them and everyone present indicated a favorable answer. It was noted that on Wednesday Morning, March 8. the Pittsburgh Post Gazette carried a release with respect to the proposed plan.

The plan was submitted to the persons present with instructions to carry it back to their rexpective organizations and a meeting was planned for the night of March 21, 1950, at which each of those present were requested to endeavor to be present and be prepared to express the attitude of their respective organizations and to bring with them any members of their organization who would be willing to serve. It was suggested that the Borough of West View would underwrite the cost of whatever type of uniform that might be agreed upon. They were told that it was the desire of the Borough of West View that the organization be organized and officers elected by the persons interested without any interference from the Borough itself; that they should adopt their own by-laws and decide themselves as to what form of an organization it should be, either a volunteer association or a non-profit corporation.

It was suggested that the matter of the service or work schedule should also be worked out by the organization itself, and by way of suggestion, we recommend that the Borough be divided into three districts to correspond to the several districts in the fire department, and from each district, the organization would elect a captain and a lieutenant, together with volunteer patrol personnel. Since the meeting last Tuesday night, we have made cursory study into the law with respect to the prospects of securing workmen's compensation insurance protection for the women in the event they suffer injuries while serving on duty. Ordinarily, the test of whether or not a person is protected by workmen's compensation is whether or not they are service for or employed and receiving compensation. The provision with respect to Volunteer Firemen is the exception under the law as provided by statute. However, we are of the opinion that and would recommend that, should the plan be adopted and the organization formed, that the Borough itself should make a request to its surety or workmen's compensation insurance to determine from it whether or not they would include the volunteer personnel and if so, at what additional premium.

Mr. Kress stated that the Burgess and the Police Committee and the Solicitor should be commended for their time and effort in this work.
