"January 8, 1951

Honorable Members of The Town Council of The Borough of West View, West View, Pittsburgh 29, Pa. Gentlemen:

I am returning herewith, unsigned by me, Resolution No. 537, which would continue Rent Control in The Borough of West View. The following is my veto message:

After making a thorough investigation as to the availability of

rental properties, my findings are:

First: A strictly modern four room apartment with garage, on the street carline at Center Avenue and Norwich, renting under the Rent Control Board for \$84.50 per month, stood vacant for two months, after which it was rented at a much less price than set up by the Rent Control Board, and then only after concessions were made, such as furnishing paints, new floor covering in the kitchen and other considerations.

Second: A modern four room apartment on Cornell Avenue was rented

during that time for \$60.00 per month.

In discussing the matter with the various real estate operators, I find they are all in accord: that an emergency does not exist and that there is a choice of rentals at this time. I am told the same condition exists in the surrounding communities. For example, the Perry Highland Apartments have a great turnover. I am also told that apartments in the City of Pittsburgh, on Fifth Avenue, which were set up under Rent Control Board at a rental of \$250.00 per month, are going begging at \$150 to \$175 per month. New modern apartments on Lincoln Avenue in Bellevue have been displaying vacancy signs for months.

In as much as the Federal Government has extended rent control until March 31, 1951, I do not feel that it is necessary for The Borough of West View to adopt a resolution pertaining to Rent Control, and thereby endorsing keeping people on the Federal payroll who are

badly needed in essential industry.
