The President shall decide all questions of order without DEBATE, but Members shall have the right to appeal from the decision of the CHAIR, when the question shall be, SHALL THE DECISION OF THE CHAIR STAND AS THE JUDGMENT OF COUNCIL, majority of Members present will decide.

When any Member disturbs the order of the Meeting, or refuses to obey the Presiding Officer, he shall be asked to leave the room, and if he refuses to leave, he will be excluded from the room.

No Member shall be interrupted while speaking except it shall be to call him to order, or for the purpose of explanation.

All Members when addressing the Chair shall stand and respectfully address the President. He shall confine himself to the question which is under debate, and avoid all personal and SARCASTIC LANGUAGE.

No motion shall be subject to debate until it has been seconded and has been stated so from the Chair.

On the call of three Members Debate shall cease, and a vote shall be taken on the subject under debate.

Before putting the question the President shall ask is the Councilready for the question, and if no Member rises to speak, he shall put the question. After he puts the question, no Member shall be permitted to speak.

The person named first on any Committee shall act as Chairman.

A motion to lay on the table shall be decided without debate.

When a motion is postponed indefinitely, it shall not be acted on during that Meeting.

No motion for reconsideration shall be in order if made by a Member who voted in the minority in the first instance.

It shall be the duty of the Secretary to record the names in the Minutes of all Officials of The Borough who attend Council Meetings, recording the time of their departure.

Any Borough Official desiring to leave the Council Chamber during any meeting of Council before adjournment shall obtain permission of the President of Council to retire.

Discussion of the Grade for hard surfacing Marquette Road at the Meeting of Council on June 10, 1952:

W. T. Corbett spoke for a group of the residents of Marquette Road as follows:

He advised that the residents on the low side of Marquette Road entered into a contract for the instllation of a curb along their properties. Before the work was begun, they requested of the Borough Manager, the line and grade of Marquette Road and he gave it to them, using the established grade.

Mr. Corbett further stated that because one of the residents on the high side of Marquette Road would be affected by the change from the travelled grade to the established grade, the work of installing the curb has been stopped three times. It is his opinion, (Mr. Corbett's) that the improvement on the street should be at the established grade and to the full width of 25 feet even though it does affect the residents of the high side. He believes that the Borough has been dilatory in allowing houses to be built on Marquette Road that do not conform to the grade levels.

Councilman Kressoffered a motion that the Borough Manager be instructed to by-pass Marquette Road, move the equipment onto Lakewood Avenue and proceed with the improvement there until such time as a decision can be reached by the residents of Marquette Road.

Councilman Kress explained that if they put in the curbs at the established grade when the hard surfacing goes in, the curbs will be lower than the street.

Mr. Corbett said you could not put this improvement on the travelled grade without damages.

Mr. Love, a resident of the high side of Marquette Road, then spoke, advising that in order that Council get a clear picture of the situation, if they cut that road 25 feet wide, there will be a drop at his ribbons of 34 inches. He then asked if this improvement which is going in is a temporary job or a permanent job, and if the work is put in at the established grade, who is responsible for the damages?

Mr. Kress answered by saying that since it is not a permanent improvement and no assessment is being made, no damages can be claimed.

Mr. Love said that he thought if they are going to change the grade to the established grade, the property owner should be assessed for the improvement and damages should be assessed against all the owners.

Quoting Mr. Love - "I came down here to ask for help."

Carl Brandt:- "The grade of a street is something like our children, we take them as we receive them, and the grade on Marquette Road is an established grade. I would presume that the person of average intelligence builds his house or has it built to conform with the established grade. Ted made the remark that the Borough has been dilatory in not requiring the houses to be built to the established grade. We have no control over that. If you want to build your house five feet below the grade or five feet above the grade, that is up to you. We can control that you conform to our building lines and that the house is built of such construction as to comply with the building code.

"From your words, and confirmed by the Borough Manager, if Marquette Road is graded to the established grade, you find yourself with a drop off of 34 inches and you asked if there wouldn't be damages. That is not the law. It is only when we conform to the grade that we are not liable for damages. If we improve the street, so long as we go to the established grade, no one can claim damages from the Borough. There is a fine point here. That would certainly be true if we went in and assessed benefits.

"Three years ago, when we met with the property owners on Marquette Road, Mr. Graham took the length, width and square feet of the street, telling you that if it is improved with concrete, it would cost you so much, if it is black top, it will cost so much. My recollection is that the cost of the concrete was objected to as being too expensive. We finally ended up with Improved Maintenance. An offer was made by the people of Marquette Road to pay for this work and the Borough declined for the reason that this type of work is improved maintenance and not a permanent improvement and we did not feel we could accept any contribution or aid in the improvement.

"I am familiar with the hardship upon you. I know Carl Jenny, with whom you have your contract as individual property owners.

"The Borough cannot change the grade of the street without being liable for the damages unless each abutting property owner be advised and agree. They cannot change the established width of the road or change the dedication of the street contained in the recorded plan.

"As late as last Saturday morning, I dictated to the Borough Secretary, a form of agreement. I think you ought to be able, with the advice of the Borough Manager, who is a registered, recognized engineer, that if this change of grade is going to work a hardship upon you, then certainly among people like yourselves, there ought to be a compromise. If all of the property owners will agree to the new grade to conform more particularly to the property that abutts on Marquette Road and do the least damage to the greatest number, that is what you ought to do.

"Due to the circumstances, I can hardly blame Mr. Kress for his attitude tonight. Here we are, on the threshold of doing the work and you cannot agree. The Manager tells me that he can work out an amended grade that would more particularly conform to the topography of the land. If he prepares the plan of that grade and all of you people will accept his services, which are given you, of a registered qualified engineer, — if you can accept that and agree to waive damages, the work can be done. If you do not, you will find yourselves in the position of watching the train go by."

Mr. Brandt then directed the following to the Borough Manager: "If you draw the profiles of the travelled grade, the established grade and the recommended grade, and if they will agree to the recommended grade, can you go ahead and proceed with the improvement?"

Mr. Marsh answered by saying, "It is impossible to get a level which will be level with the porches on the low side and be 25 feet wide and still allow use of the driveways on the high side."

Mr. Adrian Supple said he wanted to ask two questions with reference to the petition. One is do they have to get the signatures of the owners of the vacant lots. The maswer is yes.

Mr. Supple then advised that a month before they knew about the street, they thought it would be a good thing if they had the curbing in so that the new road could be pressed in. They had no idea how far down or how high it would be. They went ahead with it with Mr. Marsh knowing about it. He had told them it would be well to put the curb in and then the street could be pressed into it. Mr. Supple went on to say that they did not want to put the curb in to block the street improvement.

Hr. Jenny stated that he had the contract for the curbing and before he got the contract, the owners made him afree to finish by the 10th and he thinks someone ought to find out what they are doing. "I have a street opened and have to light lanterns every night, which is costing me money. I don't want to be putting lanterns on for two months while someone is trying to decide something that has already been decided."

Mr. Ford replied to Mr. Jenny - "That is a matter between you and the people you have the contract with; The Borough does not enter into it. We have to iron it out with the property owners as to what they want on this grade so there will be the least amount of damages for the people on the high side and the low side."

lir. Love stated as follows: " Mr. Marsh intended to put the street in at the travelled grade and Mr. Marsh, Mr. Kress and the property owners agreed on the travelled grade last fall. Last Saturday morning, these people told Mr. Marsh to drive the road to the full 25 feet width. I would like this made a matter of record."

Hr. Jenny - "Then Mr. Marsh came over and we went over the pins and checked them, he told me he was going to take the cut off the top and that would be the established grade and that he could not make the cut without going down to the established grade."

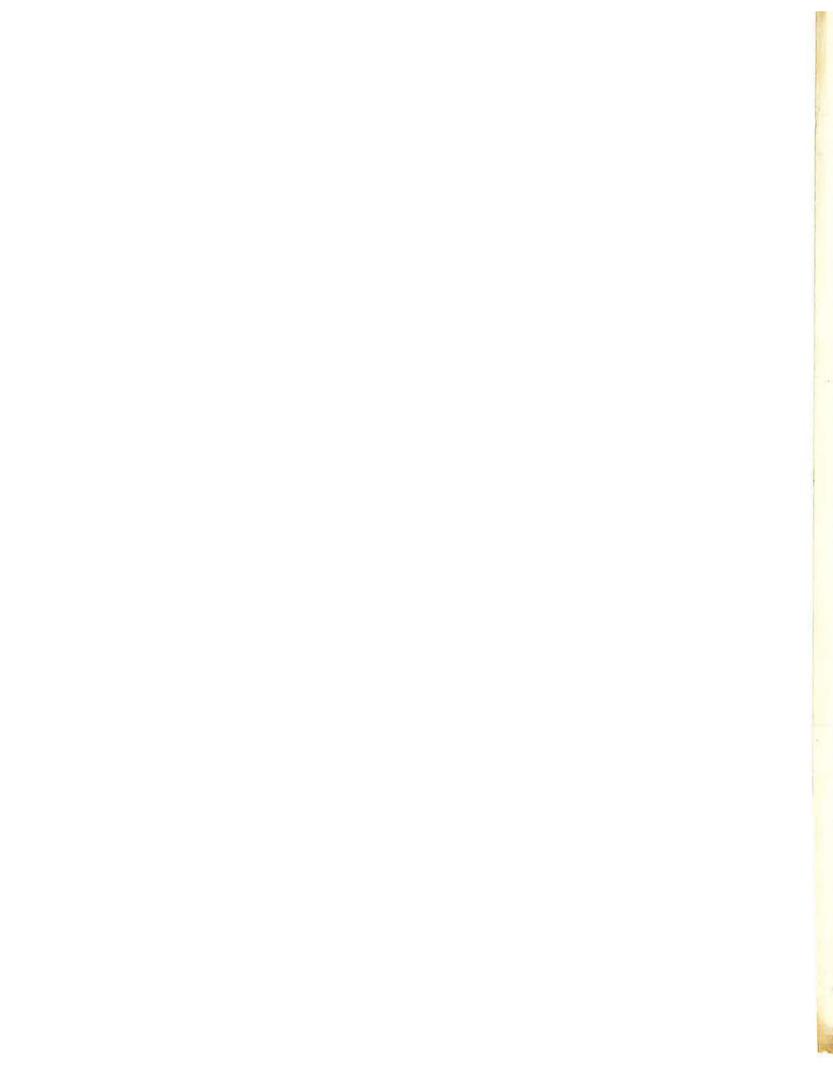
Hr. Kress - "In order to bring this thing to a head, let us move our equipment to Lakewood Avenue until we can satisfy the majority of the people and then see what can be done."

lir. Fringe: - "We agreed to compromise and the petition was to be made out, but one member of the high side said he would refuse to sign the petition. How far can the low side go? We agreed, he backed away. We said "All right", what do you want?" "Mir. Marsh put on new Levels on Saturday and the Member who started the complaint refuses to sign the petition. Heantime, my driveway is not usuable. I have a new car and it has not been in the garage yet. The Borough advised Mr. Johny the established grade. If the man who registered the complaint will not sign the petition, the only thing we can do is fill the ditch. But the ditch has been dug and the fill has been hauled away. If the people on one side are willing to compromise, then the ones on the high side should do the same. Meantime, I have an 18 inch ditch in front of my place and it was established by your Borough Manager. I did not establish

that ditch or Mr. McArdle."

Mr. Love - "Then I agreed, he never intended to drive the road 25 feet. They asked him to drive the road 25 feet."

Nr. Corbett - "I think we should adjourn and try to work out something in this matter."

The Town Council of The Borough of West View, after considering the proposed extension of State Route O2211, connecting the Ohio River Boulevard with Perry Highway at Highland Avenue in The Borough of West View, has requested me to advise you of its objection to the proposed extension.

The Borough of West View objects to the extension because:
FIRST: The Borough of West View in conjunction with the
County of Allegheny by a Bond Issue approved by the electors of
Allegheny County, proposed to improve Center Avenue in the Borough,
through Ross Township and connecting onto Balph Avenue in Bellevue,
which will serve as a connecting highway between the Ohio River
Boulevard and the Perry Highway. Therefore, this proposed
improvement would constitute nothing more than a duplication of
a connecting road between these two points.

SECOND: Highland Avenue in the Borough of West View as now located and improved is wholly inadequate in width to accommodate any substantion amount of vehicular traffic.

THIRD: Highland Avenue is not only limited in width, but also follows the natural terrain of the ground and therefore results so that the grades on the road are subject to wide fluctuations.

FOURTH: Highland Avenue has sections where the sidewalk is directly adjacent but several feet below the roadway. The majority of children attending the Highland Avenue Elementary School travel this walk to and from school. Any substantial increase of vehicular traffic is going to create a very hazardous and dangerous threat to the life and safety of these children.

If the proposed extension is completed, it will result in the creation of a "bottle neck" in traffic at the intersection of Highland Avenue and the Perry Highway, which is already being surcharged by the normal local vehicular traffic.

The intersection of Perry Highway at Center Avenue, by virtue of the width of these two intersecting streets will afford a much larger and safer intersection.

The Borough feels that before final plans for Route 02211 are completed and adopted, consideration should be given to the objections to the project as described herein.
