AN ORDINANCE AMENDING ARTICLE II, SECTION 3, OF ORDINANCE NO. 852 OF THE BOROUGH OF WEST VIEW, OFFICIALLY KNOWN AS THE ZONING ORDINANCE, ADOPTED MAY 26, 1946, BY DEFINING A TWO-STORY BUILDING.

"Story: Two: A two story building is one that complies with and meets all of the following requirements:

(1) Second story floor area must occupy at least 75% of the first floor's usable area.

(2) All second story rooms must have three verticle walls meeting the ceiling at a height of 7 ft. 6 inches and a 90 degree angle.

(3) The fourth, or outside wall, of a second story room may have a sloping roof provided that;

The horizontal area beneath the sloping wall may not be more than 25% of the floor space of that particular room, and provided that the wall plate of such fourth side must be at least three feet above the floor level.

- (4) The outside wall of a second story room may be set back from the first story outside wall, provided the conditions of 75% usuable area hereinabove mentioned is maintained.
- (5) Roof lines may start below the floor line of the second story provided that the pitch of the roof is not less than 1.33 vertical feet per horizontal foot, and provided that the gutters do not extend below the top of the first story window or door frames."

Minutes of a Special Meeting of The Town Council of The Borough of West View held Tuesday Evening, September 1, 1953, in the Recreational Center, 439 Perrysville Ave., West View.

Meeting called to order at 8:16 by President of Council, R. U. Ford. Roll Call was answered by the following Members of Council: Messrs Hurley, Kress, Link, Stroje, Tiernan, Winter and Ford. Burgess -Walter J. Baker; Solicitor - Carl Brandt; Controller - F. W. Huebner; and Secretary - Mrs. Guckert; were present.

Municipal Grounds

Hearing - Re-Zoning The meeting was held at the Recreational Center due to the fact that this evening, September 1, 1953, was the date advertised for a hearing to be held RE: the changing the zoning of the property occupied by the Borough as a Municipal Building. The proper notices were advertised and posted on the property - and proofs of publications were on the President's desk.

> President of Council, Mr. Ford, announced to the audience (About 100 persons) that Council had been approached on occasions regarding the sale of the Municipal Building and Grounds, for the purpose of erecting thereon garden type apartments. He pointed out that Council has been offered \$40,000.00 for the property and that the apartments to be erected would yield approximately \$5000 per year in taxes to the Borough and \$7500 to the School District. He announced that the sale of the property depended upon whether the property could be or would be rezoned.

Mr. Ford then asked if anyone in the audience had any comments.

Mrs. Roberts requested that Mr. Abel, from the State Recreational Planning Board be permitted to show a movie on "Recreation".

Mr. James Maloney, 86 Martsolf Avenue, asked "What are Council's reasons for putting the property up for sale?"

Mr. Ford's answer was that approximately 4 Acres of ground would be put to more advantageous use than now. The property can be converted into an income property as well as bring about 100 dwelling units into the Borough, at a cost of approximately a half million dollars, bringing additional income from taxes to the Borough and to the School District. Business would also benefit or profit by the addition of approximately 100 families. Also, the present building is in a state of disrepair and will require some expenditure to make it habitable again.

Mr. Maloney said that was all right so far as the Borough is concerned, the the School Board will be affected. For every child enrolled in West View Schools, ow North Hills Joint Schools, today, the cost for corrent expenses allowed is \$252.00. Add \$7.00 more for debt service and \$70.00 more for expenses of administration, secretary's salaries, etc, and you come up with a figure of about \$335.00 per pupil.

Mr. Ford asked Mr. Maloney, "Are you here as an individual or as a Member of the School Board?" Mr. Maloney's reply was "As an individual". Mr. Maloney further remarked that he does not believe this re-zoning is the corfect measure for Council to take. A lot of people bought homes in West View and paid a high price for them." I do not think it is going to do them any good or the community either, speaking as an individual." Referring to the Borough property, he stated it is the last $3-\frac{1}{2}$ or 4 Acres left and he does not think Council is wise in selling it as it is going to create a serious problem.

Mr. Ford remarked that the School Board missed a good bet when they did not take the property to be used for school purposes.

Mr. Maloney remarked that the property had been purchased and put into condition at a cost of \$30,000.00 eleven years ago and eleven years ago, \$15,000.00 bought a lot more than it does now; so that there will not be even a paper profit if sold at \$40,000.00. If it is re-zoned and apartments built, it will definitely result in an increase in school taxes. Mr. Maloney does not think Council has considered that part of the problem.

Mrs. Roberts, 148 Chalfonte Ave., said her Committee circulated a petition and had 1208 signers. Many people are away on vacation or they may have gotten more.

The Committee would like Council not to re-zone the property until Mr. Stoker from the Commonwealth of Pennsylvania Department of Planning and Recreation has had an opportunity to make his survey.

Mr. Bach, 17 Wentworth Avenue, remarked that the Borough is paying \$5,000 per year for this Recreational Hall as rent.

Mr. Ford clarified the financing of the Municipal Authority Building. Also the advantages of having the fill that was excavated from the ground for use to ard the improvement of Center Avenue between Bellevue Avenue and Horse Shoe Bend.

Mr. Maloney - REL Center Avenue Improvement - asked "Is it a fact the County will not move until the time the Railways Company agrees to pay their share of the paving of the railways tracks?"

Mr. Ford remarked that the Railways Company say they are broke and cannot make the improvement. The County set a precedent in taking over the Railways property in Brookline. They are dickering with the Railways Company to try to get as much toward the improvement from the Railways Company as they can.

Councilman Hurley remarked that he had been rattending meetings with Representatives from the School Board, together with other Members of Council, regarding recreation.

Mr. Maloney said he had never seen Mr. Hurley at a Meeting with School Board Members.

Mr. Hurley assured Mr. Maloney he had the meetings, together with other Councilmen, that if those School Board Members had not taken the word back to the Board, they they do not know what is going on - the meetings having been long before the Municipal Authority Building was ever erected.

Mr. Ley, Westfield Avenue, said it is his understanding this meeting was called for the purpose of finding out if the property occupied by the Borough should or should not be re-zoned, and that re-zoning would then authorize the sale. He remarked he had been in touch with an eigent party of this Borough

who was instrumental in getting in touch with the property when it was purchased by the Borough. He advised the property was bought for the purpose of a playground for this community. If that is the case, you still have it and have it at a very insignificant amount of money. He cited some experiences he had in helping to organize playgrounds, specifically the Wilson Avenue Playground on the North Side of Pittsburgh. He stated he believes that due to the influx of people into suburban areas, there is a need for playground areas. In suburbs where formerly a hundred houses stood four or five years ago, there are now possibly as many as five hundred. He believes West View is going to have to have a playground if we are going to save the lives of our children. You have this property (addressing Council) at a very insignificant figure and why do you want to throw it away?

Mr. Ley believes that in allowing apartments to be erected in a community, you do not get a very desirable class of people.

Mr. Heerlein - 205 Montclair Ave., said "You have a representative group of people of West View and you are interested in knowing how they feel about the re-zoning of the Borough Property with the idea of the sale. So that you can get an idea, why not ask for a hand vote"?

Mr. Patterson - Yale Avenue - said there were a number of problems. The first one, the petitions were drawn up at the suggestion of Council on the re-zoning in as much as the re-zoning of the property is the first step toward the sale. He believes Council has a moral obligation to hold up the sale until after the survey has been made - this is only a matter of time.

Mr. Ford asked if he would want to hold up the re-zoning of the property if it means the losing of the sale.

Mr. Patterson replied, "Withhold re-zoning as a moral gesture until some investigation can be made as to what the facilities amount to." He said there is only a question of time so that the entire Borough may know what is best.

Joseph McDonald - Highland Avenue - remarked, "If you re-zone the property, you are going to sell thirty days after. The only alternative is an injunction; why should you put the taxpayers to that expense?"

Mr. Good - Homekort Ave - remarked that \$40,000.00 has been offered and he thinks Council has been mislead on what you can do with \$1,0,000.00. He says he believes that if Council were to get estimates for a town hall, they would find out that you cannot even get a home for 35 or 40 thousand dollars.

Mr. Patterson said if you look around you will find that apartment dwellers are a group whose interests are not West View, but merely a sleeping quarters.

Mr. Maloney wanted it recorded that the School Board question was not brought up by him but by Council and he resents bringing in the School Board and putting them on the spot.

Mr. DeMaria - Ann Arbor Avenue - asked if Mr. Baker had a change in his original thoughts relative to the Borough property and recalled that Mr. Baker has said on more than one occasion that it was always his dream to have a Recreational Center up at the Municipal Grounds.

Mr. Baker replied that he has not changed his mind and would still like

to see it made into a Recreational Center.

Ed. Marciniak - Center Avenue. Personally, he believes people are not in favor of selling or re-zoning the ground into a lower use value. He also believes there may be other more suitable sites for recreational centers in the Borough. He believes that most people would be willing to seal the property at a right price for the right use if they had some assurance that Council is going to do something about providing playgrounds.

Mr. Jackson - Ridgewood Avenue - sees no advantage in selling the property.

Mr. Patterson remarked that he is taking Mr. Ford's statement as a truthful fact that Council wishes to serve the people of West View. He sites they have 1200 signatures which are voting signitures out of a population of 7500 people. He believes if more people were contacted in two weeks' time, the majority of the adult population would sign the petition.

Mrs. Stanier asked what happens to the petitions after they are presented is it up to the people?

Mr. Kost - Highland Avenue - believes it unwise to re-zone the property for apartments - better to have individual homes.

Mrs. Roberts - "I offer these petitions to become a part of the records of this meeting, consisting of 1215 signatures of residents of West View Borough who object to the re-zoning of the Borough property until a survey can be made by Mr. Stoker."

Mrs. Roberts then requested the petitions be returned to her so photostats could be made of them - they will be presented to Council at the Regular Meeting, September 8, 1953.
