Reports of Burgess, Treasurer, Controller, Chief of Police, Fire Chief, Electrician, Secretary and Manager. The Solicitor did not enter the meeting until later.

Mr. Winner added to his report the following, verbally: He reports the new Truck is delivered to Langers.

He calls attention the balance from 1960 is \$13,114.58 instead of approximately \$20,000.00 which he anticipated. (This was due to the payment of an additional \$6,000.00 on the \$15,000.00 Note of 1959). Mr. Winner has a request from Edwin Bairhalter, the Contractor at the Wright property, for payment of \$1,000.00 to meet payment of materials delivered. This was discussed. Upon questioning Councilmen, the following opinions were expressed:

Mr. Powell does not favor advancing the \$1,000.00. Mr. Richey is surprised at what is being done, it does not look like much of a structure for \$2200.

Mr. Winner says the work is being performed in accordance to specifica-

Mr. Freese would favor advancing \$1,000.00 to help the contractor.

Mr. Hurley is of the opinion that a contractor going after a job like this should have the finances to carry on the job.

Mr. Duncan wonders if the matter is referred to Mr. Wright if he will pay what advance is being requested.

Mr. Nash favors referring this request to Mr. Wright to see if he wants to advance the amount.

Mr. Hurley says Mr. Wright may want to see if the completed job meets specifications before he spends money.

Mr. Richey favors advancing \$1,000.00 to help out.

Mr. Duncan agrees.

Mr. Jones agrees.

Mr. Hurley will go along with the majority even though he is opposed to i.t.

Mr. Nash wonders how Mr. Wright will feel about it and asks if he knows of the request.

Mr. Richey suggests we defer action until the arrival of the Solicitor since we do not have a precedent of this kind.

Mr. Freese says this work was going on when the weather was against the contractor and that is the reason he feels we should advance \$1,000.00. Motion by Mr. Duncan, seconded by Mr. Freese, that \$1,000.00 be advanced to Edwin Bairhalter providing this action meets with the approval of the Solicitor, on the recommendation of the Borough Manager.

Reports

Committee ---- FINANCE COMMITTEE - Chairman, Mr. Duncan, nothing to report other than a vote of thanks to the Borough Manager and Secretary for helping achieve the financial condition as shown by the Reports, there being balance from 1960 of \$13,114.58.

> Mr. Duncan suggests an informal meeting of Members of Council to discuss the Salary and Wage Schedule and Budget for 1961.

The meeting is set for Tuesday, January 17, 1961. Notices will be sent by the Secretary.

PROPERTY AND PURCHASE COMMITTEE - Chairman, Mr. Nash, reports Members of Council attended the installation of Officers at Nos. 1, 2 and 3 Fire Companies. The work the boys are doing at No. 1 Engine House is progressing and looks pretty good.

He further reports we have a set of specifications prepared by Mr. Winner for Engine Houses Nos. 1 and 2, and Mr. Nash thinks it would be in order that if we feel this is on the right track, we should get together with the Officers of the Fire Companies Nos. 1 and 2, together with the Borough Manager, and determine what we can do, as soon as we can.

Mr. Winner told Council there are some things in the specifications that takes the cost above what was anticipated. The specifications now call for about \$3000 whereas originally it was \$1600.

Mr. Hurley thinks we should get together and decide what in these specifications we will do, and the sooner we get together, the better it will be.

Mr. Nash would like to see Council decide to do the whole thing. Mr. Hurley agrees it should not be a half job and suggests Mr. Winner get estimates of cost in time for discussion at the Budget Meeting. Mr. Nash asked about the furnace and Mr. Winner advises it is going to be repaired as soon as the new part needed is received. The trouble causes a noise but does not interfer with the heat. Mr. Nash says we should find \$3000 somewhere to fix this building up and that No. 2 cost will not be to great.

PUBLIC WORKS COMMITTEE - Mr. Freese, Chairman, read a letter received from Frank Fischer, Secretary of the West View Savings and Loan Ass'n, in which he praised the Public Works for the efficient manner in which the snow situation was handled.

POLICE & PUBLIC SAFETY COMMITTEE - Mr. Richey, Chairman, read a letter received from Members of the Police Department requesting increases and certain other considerations for 1961. Mr. Richey reports that since the full Council will be at the Budget Meeting, this letter should be held until that time.

FIRE & WATER COMMITTEE - Mr. Jones, Chairman, read a letter received from the Fire Department requesting \$800.00 for Convention Expenses this year. Also, reports are received covering expenditures at the Conventions for the years 1958, 1959 and 1960.

Motion by Mr. Jones, seconded by Mr. Powell, that the reports become a part of the Minutes of this Meeting.

RESOLUTION NO. 755

BE IT RESOLVED BY THE TOWN COUNCIL OF THE BOROUGH OF WEST VIEW, IN REGULAR SESSION ASSEMBLED, AND IT IS HEREBY RESOLVED BY AND WITH THE AUTHORITY OF THE SAME:

FIRST: That E. M. Hurley President, and Maomi Guckert, Secretary of the Town Council of The Borough of West View, be and they are hereby authorized and empowered to borrow, from time to time, as needed from the Pittsburgh National Bank, West View Branch, the sum or sums of money not exceeding in the aggregate ONE HUNDRED THOUSAND DOLLARS, (\$100,000.00), for the purpose of meeting the ordinary and/or current running expenses for the Borough of West View for the year 1961; such loan or loans to bear interest at the rate of 2-3/4 percent.

SECOND: That the President and Secretary of The Town Council of The Borough of West View be and they are hereby authorized and empowered to execute such notes, certificates of indebtedness or other obligations, under the seal of West View Borough, to evidence the said loan or loans and to certify to the Pittsburgh National Bank such information relating to the indebtedness of the Borough as may be required.

THIRD: That the monies so borrowed by the Borough of West View from the Pittsburgh National Bank by virtue of this Resolution shall be paid out of the receipts and/or revenues of the Borough from taxation and/or from other current revenue during the calendar year of 1960 and/or from the liquid assets of the Borough, and/or from any taxes levied or to be levied during the current year, and/or from any other source of income of the Borough.

FOURTH: That there is hereby appropriated and set aside and apart out of the said revenues, receipts, liquid assets, taxes and/or other sums received and/or to be received by the Borough of West View from any source whatsoever, the amount necessary to repay the Pittsburgh National Bank the said sum or sums so borrowed, together with interest that may be due thereon.

FIFTH: That all resolutions or parts of resolutions inconsistent with the provisions hereof, be and the same are hereby repealed.

Bairhalter

Edwin ----- Mr. Brandt was asked for his opinion with reference to the Borough advancing payment of \$1,000.00 to Edwin Bairhalter, Contractor on the Wright Project.

> Mr. Brandt advised Council could pay the Company who furnished the concrete direct with permission of Mr. Bairhalter and also permission of the bonding company.

Mr. Richey said it is his opinion that Mr. Bairhalter is looking for a little more money than the cost of the cribbing materials, and he asked the Solicitor if payment can be made to Mr. Bairhalter for 90% of the work when the Manager certifies his approval of the work. Mr. Duncan and Mr. Freese withdrew their previous motion to advance \$1000 to Mr. Bairhalter.

Motion by Mr. Freese, seconded by Mr. Nash, that the proper Officers of the Borough pay Mr. Bairhalter an amount equal to 70% of the fair value of the work done to date upon the written approval and consent in writing by the Bonding Company. The reason for requiring the consent of the bonding company is they may ask, if the work is not done correctly, why did Council pay for the work. Mr. Brandt said as an added precaution, that \$1080 be paid to the Concrete Pipe Company to be sure it is paid, upon the written approval of the bonding company.

Motion carried and so ordered. The further suggestion that the Borough Manager call on Mr. Wright regarding the matter was made.

J. S. Nudi ---- The following letter was presented to Council: "January 10, 1961

Wm. L. Wunderly, Tax Collector 440 Perrysville Road Pittsburgh 29, Pa. In re: Tax Collector's Bond Dear Bill:

The Borough of West View has just had an unfortunate experience in connection with the collection on the bond of former Tax Collector, James S. Nudi. The Bonding Company has now agreed to pay us the full amount of our actual monetary loss, however, it has refused to pay us for the cost of the audit made by Hosack, Specht, Muetzel & Wood, to determine the amount of the loss, and the claim of J. Wm. Jordan Record & Tax Services for services performed by that firm in the collection of taxes which Mr. Nudi failed to collect.

Accordingly, the Town Council of The Borough of West View has instructed me to determine from you, through your Bonding Company, whether or not it will issue an endorsement to the effect that the surety will reimburse the Borough in the event of loss for the actual cost of services rendered by the agent of the Borough in performing the duties of the Tax Collector, and the cost of any audit which might be required to determine the amount of such loss.

We would have no objection if the underwriting department of the Bonding Company would want to put some limitation on its liability under the endorsement, and we would think that a maximum of \$5,000 would be reasonable. In the event the Bonding Company is willing to add such an endorsement, we would like to know what additional premium charge, if any, would be made.

Minutes of a Special Meeting of The Town Council of The Borough of West View held Tuesday Evening, January 31, 1961, in the Council Chamber at the Municipal Building.

The purpose of the Special Meeting, which is called by President of Council, E. M. Hurley, is to discuss and take action on the Salary Ordinance for 1961 and the 1961 Budget.

Meeting called to order at 8:07, after a moment of Silent Prayer, by the President of Council, E. M. Hurley.

Call Letter read.

Roll Call was answered by the following Members of Council: Messrs Duncan, Freese, Jones, Nash, Powell, Richey and Hurley.

Burgess J. L. Gahring; Treasurer - A. L. Seethaler; Manager - Wade

Winner; and Secretary - Naomi Guckert were present.

Salary Ord. -- Mr. Hurley asked Councilmen to express their opinions in RE: salaries and wages.

Mr. Nash stated his position at the informal meeting and has not

changed his opinion.

Mr. Richey, who was unable to attend the informal meeting due to illness, was brought up to date as to what took place. The anticipated receipts and expenditures for 1961 were discussed and due to the amount of balance left as of December 31, 1960, in the General Fund, the Manager has had to reduce substantially the money to be spent on improvements in the Public Works, if raises in amounts originally talked of were to be given. After discussion, figures agreed upon by the majority of Members of

Council were set up in the proposed Salary Ordinance which was taken up later in the meeting.

Car Allowance - The following letter was read to Council:
Burgess "January 31, 1961

E. M. Hurley, President Borough of West View Municipal Building Pittsburgh 29, Pa.

In Re: \$300.00 Car Allowance to Burgess

Dear Mr. Hurley:

The question which you have asked me to give a legal opinion upon is whether or not the Borough is authorized in appropriating a \$300.00 car allowance for traveling expenses to the Burgess.

The pertinent provisions of the Borough Code applicable to this problem are sections 46024 and 46025 of Title 53 Purdons Pennsylvania Statutes Annotated.

Section 46024 provides in part that in a Borough whose population is less than 10,000, the salary of the Burgess shall not exceed per annum \$100.00 per thousand for the first 10,000 population or fraction thereof.

Section 46025 provides as follows:

"Any salary paid pursuant to an Ordinance shall be in lieu of all costs and fees allowed a Burgess . . ."

An examination of the cases interpreting these Statutes indicates that it is the general rule that a person accepting a municipal office with a fixed salary is bound to perform all the duties of the office for the salary, and that he is not entitled to any extra compensation for performing such duties. See Commonwealth ex rel School District of the City of Bethlehem vs. Tice, 282 Pa. 595.

The cases also indicate that where a municipal officer lays claim to compensation for the performance of the duties appertaining to his office, he must be able, in order to support his claim, to point to some provision of law authorizing him to demand it, and where compensation is not provided by Statute or Ordinance, a municipal officer is not entitled to recover on an implied contract to pay him what his services were reasonably worth. 37 Am. Jur. Section 255.

In light of these applicable statutes and the various cases interpreting them, it seems obvious that in the absence of any statutory authority expressly conferring upon the Borough the right to appropriate an amount for traveling expenses, the Burgess would not be entitled to \$300.00 as a car allowance.

POLICE & PUTLIC SAFETY COMMITTEE - L L Richey, Chairman, reports he has been in touch with Mr. Mockenhaupt and there will be a meeting of the Pension Committee.

Mr. Kircher, Patrolman, is now under the pension plan and Officers Buchlmayer and VanLeet are now up to full pay scale which affects their insurance. There will be a full report submitted at the March or April Meeting, depending on when the Committee can get together.

Park Guards West View Park opens shortly after the April Meeting and Mr. Richey thinks it would be well to get the applications for jobs as Guards lined up for the March Meeting so that the Burgess, Chief of Police and Police Committee can review them.

Mr. Richey recommends consideration be given to men who are unemployed and also to residents of the Borough.

Motion by Mr. Richey, seconded by Mr. Freese, that Council advertise for applications for jobs as Park Guards in the Official paper, the Allegheny Journal. Carried and so ordered.

FIRE & WATER COMMITTEE - Chairman, Mr. Jones, no report.

Fire Alarm Also, the Firemen would like to have, in the Police Car, a Mine Safety Company device for measuring gas fumes, the cost of which is \$125.00. The Fire Chief said it would be a good idea to keep it in the Police Car as usually the Police get to a call first. They would measure the gas fumes and then get in touch with the Gas Company.

Mr.Powell also reports the roof leaks at No. 3 Engine House.

Mr. Nash asked if Council is going to have a Meeting with the Fire Companies to determine what Council is going to do about repairs to the engine houses. Mr. Hurley says there is to be a meeting as soon as a meeting is arranged by the Chairman of the Fire & Water Committee.

Mr. Nash says the request for the device for measuring gas fumes is reasonable and should be taken into consideration.

Mr. Hurley says if it is going to save a life, it certainly should be obtained and Mr. Nash says if it is needed at once, we should spend the \$125 and buy it.

Mr. Hurley requested Mr. Jones to arrange a meeting with the Members of the Fire Department.

Tax Exonerations A list of property tax exonerations was presented by Wm. L. Wunderly, Tax Collector. The reason for the request is these taxes were included under "Corporations" whereas they should have appeared in the Tax Duplicate under "Exempt". The amount of the taxes is \$776.20.

Motion by Mr. Powell, seconded by Mr. Duncan, that the request be granted. Carried and so ordered.

Audience

Mr. & Mrs. Brennan, 230 Stanford Avenue, spoke from the Audience in reference to the opening of Third Alley from Stanford to Kenyon Avenues, as per petition of Mr. Gruber.

Solicitor

The deed is also prepared for the property for Mr. Wright. Mr. Wright will return from Florida about the middle of March and when the deed is delivered, payment to the Borough is to be made. Mr. Wright is to receive a letter setting forth what his responsibility will be in the future and what the Borough's responsibility will be.

Mr. Hurley says Council is in accord with that.

Mr. Winner reports he took the deed for the property being given to Mr. Wright and expected to get a check in the amount of \$2900.00, in accordance with the Agreement. Mr. Wright claims a car was damaged when, while the Contractor was doing the work on the crib wall, etc., a rock rolled down striking one of his cars. Mr. Winner says this was reported by Mr. Bairhalter to his Insurance Carrier. Mr. Wright claims a valve was destroyed, a string of lights damaged and the asphalt scratched. All of these things Mr. Bairhalter agrees to repair. Mr. Wright then advised he does not want a deed but wants a bill in the amount of \$2900.00 for damages to the lot so that he can take it off of his income tax.

Motion by Mr. Freese, seconded by Mr. Powell, that the Manager advertise for 2000 Ton, more or less, air cooled slag, 20,000 gal more or less road oil, gasoline requirements for one year, 3" and 4" surfacing. Carried and so ordered.

This motion is in compliance with Mr. Winner's recommendations to surface Center Avenue from Bellevue Avenue to Ashford Avenue, Lehigh Avenue, Linden Avenue, widen the intersection at Center and Hawthorne Avenues and at Bellevue and Glenmore Avenues.

Under Question on the motion - Mr. Nash states as follows:
"for the last three years, I brought to this Council the suggestion
and request that Ridgewood and Martsolf Avenues should be paved. I
realize we are in a difficult financial condition now, but I would
suggest that any future Members of Council consider the paving of
these two streets. They are badly in need of repair and should be
repaired or resurfaced. These streets have been postponed for three
years. They have been on the list but we never seem to be able to
get them through. I would suggest whoever might be here in Council
this time next year, that they consider the paving of these two streets.
"I am not against paving the other streets but I think you will find
these two streets were mentioned before some of the others and I
feel they are just as important.

"I will vote for the advertising of bids as I am certain that this Council will, in the future, take care of these two streets."

Mr. Winner continued with his report as follows:

The Hot Mix Plants will open Monday, March 20 and the Public Works will then do the patching.

Mr. Winner reports he would like to use our own labor and save money on the two intersections and the front steps, if Council has no objections.

Members of Council are agreeable to this.

Mr. Brandt being absent, there was no Solicitor's Report.

Reports

Committee ---- FINANCE COMMITTEE - Mr. Duncan, Chairman, advises we have borrowed a second Twenty Thousand Dollars in Temporary Notes.

Motion by Mr. Duncan, seconded by Mr. Nash, that \$2,000 be transferred from the General to the Sinking Fund.

Carried and so ordered.

Motion by Mr. Freese, seconded by Mr. Richey, that the premium in amount of \$1,606.21 for Workmen's Compensation Insurance be paid. Carried and so ordered.

Motion by Mr. Nash, seconded by Mr. Freese, that the premium of \$225 for the Wage Tax Collector's bond be paid to T. E. Benson. Carried and so ordered.

PROPERTY AND PURCHASE COMMITTEE - Mr. Nash, Chairman, advises Council had a meeting with Company No. 1 and 2 and we arrived at what we are going to try to do in the future with these fire houses. Mr. Winner covered this pretty well in his report. Mr. Nash is glad to hear about the steps to this building.

PUBLIC WORKS - Mr. Freese, Chairman, says Mr. Winner has very well covered the report for this Department.

Surplus Food - Mr. Freese added to the report by advising there has been a 30% increase on Surplus Food, there being 248 people from West View. It is necessary for a person wanting surplus food to make application thirty days prior to the date of distribution. We are expecting a 50% increase.

Mr. Richey has a recommendation from the Chief of Police and the Burgess recommending that parking be prohibited on one side of Hempstead Avenue and changing the parking from the northerly side of Lansing to the southerly side of Lansing, from Hawthorne to the Borough Line.

Mr. Richey recommends these regulations be put into effect and Mr. Brandt be directed to prepare an amendment to the Traffic Ordinance. Mr. Powell advises the residents on Hempstead Avenue have asked for the parking regulation. These people reside on the side where the paving to accommodate parking is located.

Mr. Richey showed Members of Council the type of Courtesy Card to be given to residents who have a parking problem. This card will show the owners of cars who live there.

Mr. Richey also showed Members of Council a type of warning card to be used by the Police to war residents of traffic violations.

Mr. Richey advises the Park opens the last Saturday in April and Council should take action on the applications for Park Guards.

There are sixteen applications - five from men who are out of work.

Mr. Richey recommends that the sixteen be employed as Park Guards.

Motion by Mr. Richey, seconded by Mr. Nash, that the sixteen men from whom applications as Park Guards in the Park were received be hired to work where and when as assigned by the Burgess.

Carried and so ordered.

FIRE & WATER COMMITTEE - Mr. Jones, Chairman, No Report.

PUBLIC RELATIONS COMMITTEE - Mr. Powell, Chairman, Mr. Powell reports that Mr. Duncan, Mr. Winner and he attended the last meeting of the North Boroughs Planning Commission on Feb. 24. The main topic was the filing of liens for delinquent sewage charges. Solicitors of some of the communities are getting together to endeavor to have the Borough Code amended to provide that the liens may be filed in blocks or groups instead of paying \$3.50 for each

individual delinguent sewage account.

Lee Donaldson, Legislator, will back this and bring it up before

Legislature.

Commissioner Anderson of Ross Township questions a municipality's right to spend taxpayers' money to pay these delinquent charges but Mr. Bruek said Under the Act, these municipalities have the authority to spend the money.

At the Meeting, it is suggested to set up an "Inter-Borough Street Department", for the purpose of lending another community one or

more of their trucks for a clean-up operation, etc.

Mr. Powell also was advised by Mr. Higbee of Columbia Avenue that we can obtain Free Cinders for the Borough, they will be loaded on trucks for the Borough. It was called to attention of Council that one time the Borough had received free cinders but they were not clean having foreign materials such as glass, nails, wire, etc. that made them unfit to be used on Borough Streets.

Tr. Winner also questions if the Borough could haul the cinders from this source as cheaply as they purchase them and have delivered

at the present time.

Mr. Nash suggests a letter be sent to Mr. Higbee thanking him for the offer.

Audience ---- Mr. Nagy, North Park Road, objects to the heavy trucks, particularly Brant's Trucks, travelling North Park Road.

Mr. Dave Kennedy, representing from Sun Oil Company, asked about Sunoco ----Service Mr. Vincent J. Cersosimo who operates the Sunoco Station on Perrysville Avenue at Chalfonte, recapping tires. The operation does not give off any smoke, odor and anything else noxious. Chief Clogan and Mr. Winner made an investigation and agree there is nothing noxious or noisey about the equipment. Motion by Mr. Freese, seconded by Mr. Powell, that Mr. Cersosimo be permitted to carry on this work. Under question - Mr. Richey asked if there has been any unfavorable comment about this work being done. The answer is no. Motion carried and so ordered.

No. 2 Engine - Mr. Duncan referred to the question about the electric wiring at House No. 2 Engine House and suggests the Borough Electrician go over the wiring and if necessary, even if it means re-wiring, that the condition be corrected for safety sake.

PROPERTY & PURCHASE COMMITTEE - Chairman, Mr. Nash reports his report has been well covered by Mr. Winner. He is glad Council is going ahead with the lighting and also pleased to know about the Fire Houses.

PUBLIC WORKS COMMITTEE - Mr. Freese, Chairman, says Mr. Winner has covered his report.

Mr. Freese reports the number of persons on the Surplus Food List has increased.

POLICE & PUBLIC SAFETY COMMITTEE - Mr. Richey, Chairman, reports he has a request from Officer VanLeer to permit him to work during his vacation and be paid.

He recommends the request be granted.

Mr. Richey also reports four more applications for positions as Park Guards have been received, making a total of 20. Mr. Richey says his Committee has tried every way they know of to handle this matter, but the Committee does recommend that people out of work be given first consideration in this work.

Motion by Mr. Richey, seconded by Mr. Jones, that Messrs Klinge, Branney, Schmitt and Watkins, be appointed Guards at the Park to work when and where as directed by the Burgess, for the picnic season of 1961.

Carried and so ordered.

Mr. Richey advised he had hoped to have a report from the Police Pension Fund Committee. However, the Members of the Committee will have a meeting on April 18, and report will be made at the next Meeting of Council.

FIRE & WATER COMMITTEE - Mr. Jones, Chairman, no report.

PUBLIC RELATIONS COMMITTEE - Mr. Powell, Chairman, reports at the last meeting of the North Boroughs Planning Commission it was decided to appoint a Committee to check into bus service. The following is the letter received from the North Boroughs Planning Commission:

"March 29, 1961

Mrs. Naomi Guckert, Secretary, Municipal Building, West View, Pittsburgh 29, Pa. Dear Mrs. Guckert:

At our last meeting, held Friday, March 24, the matter of public transportation was brought up for discussion. As you are, no doubt, aware, this matter is now being studied very thoroughly by the Allegheny County Port Authority, with the idea of coming up with an over-all plan to relieve this situation. It was suggested, therefore, that each of our member municipalities appoint one of its officials to serve on a Committee under the auspices of the North Boroughs Planning Commission to go into the situation as far as we are concerned, and then make our recommendations to the Port Authority.

Will you therefore, please bring this matter before your governing body promptly, and request them to appoint such a representative who will serve on this Committee, advising me accordingly.

The following is an extraction from the Minutes of the Planning Commission Meeting of $March\ 24$:

"Under new business, Mr. Powell called attention to the fact that the State Milk Control Commission had recently granted some price concessions in the Philadelphia district, and suggested that we write a letter to them advising them that it is the opinion of the North Boroughs Planning Commission that similar concessions in the price of milk be granted in the Pittsburgh district. Mr. Powell then put this in the form of a motion which was seconded by Mr. Schreiver and carried unanimously."

The above was reported to Council by Mr. Powell.

Mr. Powell reports that at the April Meeting, the topic of Garbage Disposal will be discussed and all Borough Officials are invited to attend.

Mr. Powell reports that at the VFW Post 2754 Meeting, held April 10, 1961, it was brought up about conducting a Polio Clinic and it is suggested that shots for persons out of work be cheaper. The following letter is received from the Board of Health of West View:

At our meeting on March 28, there was a discussion relative to holding a Polio Clinic in the summer of 1961. The Board of Health is willing to take charge of such a program this year under the supervision of the Borough of Council, with the same financial support as was given the Clinic last year.

Mr. Hurley suggested to Mr. Powell, in view of this letter, that Mr. Powell contact the Board of Health.

Mr. Powell asked Mr. Winner about the pot holes in Lakewood Avenue and Mr. Winner advised he had been using Komac as a temporary measure, but this does not hold up long. However, the Industries will be about to make Hot Mix and all of the pot holes will be taken care of.

Edgar L Wright Mr. Winner advised the Solicitor, Mr. Brandt, that Mr. Wright wants instead of a deed to the property in the amount of \$2900, a bill in this amount for damages, for income purposes.

Mr. Brandt advised it does not make much difference as long as we get the \$2900. If Mr. Wright takes deed for \$2900, it is for land for which there will be no depreciation. Mr. Brandt has discussed this with other lawyers who advise it makes no difference so long as the Borough receives the money for the work, and that unless someone in Council can think of any basis for objection, he will re-draft the deed and show a consideration of \$1.

FINANCE COMMITTEE - Mr. Duncan, Chairman, who entered the meeting at this time, advises there is not much to report excepting a little note of warning we now have to go to the bank for another loan, this being the third time, and is earlier in the year than in 1960. He suggests department heads be a little cautious.

Fire Pre- --- Mr. Powell reports there is to be a film on Fire Prevention in vention Schools on Thursday Evening, April 13.

Film There is a notice of this event on each Councilman's desk.

Audience ---- Mr. Nagy, 57 North Park Road, again complained about Brant's trucks being overloaded and speeding on North Park Road. Chief Clogan has been to see Brant's Builders Supply Co. However, Mr. Richey suggests he again talk with Mr. McCandless calling his attention to the speed limit and weight limit.

Mr. Brandt said perhaps Council should consider the feasibility of a written communication advising Mr. McCandless of these complaints, telling him Mr. Nagy is keeping a diary of when loaded trucks go up and down the hill at excessive speed and asked Brants to cooperate and abide by the laws of the Borough, or otherwise, action will be taken.

This is to be written by the Secretary and it will then be entirely up to Brant's to see that these instructions are carried out.

John Downes -- In Re: Building Permit for sign. Mr. Downes explained that through a misunderstanding, the base for the new sign has been installed 15 feet from the curb line rather than 15 feet from the property line, which is contrary to the decision of the Board of Adjustment. Mr. Brandt advises that Council can grant this permit in as much as there are other signs in the Borough within the right of way but it would have to be with the understanding on the part of Mr. Downes that in the event the State widens the Highway to its full width, Mr. Downes could not claim damages against the Borough. Also, in view of the fact people will be going in and out or near the cite of the sign board, Council should consider the feasibility of asking Mr. Downes to have his property damage and liability insurance include a rider protecting the Borough from any damage claim, and that this protection be renewed from time to time. Mr. Brandt can see nothing wrong in permitting the sign to be erected with the qualifications and exceptions he suggested. However, there is one other thought that Mr. Winner had in his report and that is the proximity of the sign to the entrance of North Park Road. The question is if that sign goes in there whether it will interfer with traffic coming from North Park Road. I assume this was considered by the Board of Adjustment. Mr. Brandt thinks it was proper that Mr. Winner brought this matter before Council. Motion by Mr. Richey, seconded by Mr. Powell, that on the advice of the Solicitor, Council grant the request for a permit to erect a sign to Mr. Downes. Carried and so ordered.

Recreation --- Mr. Brandt submitted a list of the lots, (Polatka, Magnolia & Keating Avenues) that the Recreation Board was interested in and suggests a copy of the list be sent to each Member of Council, and that Mr. Winner make a plot plan showing the ones on which the redemption period has expired and the ones that will expire in 1962.

Mr. Richey also advised the Recreation Board again will want to employ a Director to supervise the Field during the summer, and Mr. Winner will take care of this.

Mr. Winner also reported on the last meeting with the Committee on Air Pollution.

Mr. Winner reports the check in amount of \$2900.00 has been received from Edgar L. Wright. There are a few minor things the contractor has to do to finish the work, to which he has agreed.

Mr. Winner advises the application for work to be paid from the 25% Gasoline Fund Account has been approved by the Pittsburgh Office of the State Highway Department and being forwarded to Harrisburg for final approval.

Committee --- FINANCE COMMITTEE - Mr. Duncan requests that \$2000 be transferred Reports from the General Fund to the Sinking Fund for June obligations.

Motion by Mr. Nash, seconded by Mr. Duncan, that \$2000 be transferred in accordance with the above request.

PROPERTY & PURCHASE COMMITTEE - Mr. Nash, Chairman, advises that Mr. Winner covered his report and it looks like things are shaping up well.

In RE: Surplus Food - Mr. Freese advises there are now 242 individuals on the rolls, or 69 families. Today, calls came from three more families and they will also receive food next Wednesday, May 17. Mr. Freese advises the mother of a mute child in the Borough is in need of help. He called the School for Deaf and talked with Dr. Craig. The mother desires to wait until the child is eight or twelve years of age before enrolling but Dr. Craig advises they now have 35 children between the ages of $2\frac{1}{2}$ and six year. The problem is transportation to and from school each week. Several suggestions were made to Mr. Freese to endeavor to arrange for this.

POLICE & PUBLIC SAFETY COMMITTEE - Chairman, Mr. Richey, reports the Police Pension Fund Committee met with Mr. Mockenhaupt and had hoped to have the report ready for each Councilman this evening. However, they will be distributed later. The report indicates there is a balance of \$49,886.59 in the Fund.

Mr. Richey referred to the request of the Members of the Police Department that employees who have worked ten years or longer, have vacations of three weeks instead of two.

Motion by Mr. Richey, seconded by Mr. Nash, that the Solicitor be requested to draw up an ordinance amending the vacation ordinance to provide that employees of the Borough for ten years or over be given vacations of three weeks.

Mr. Richey reports that in RE: the complaint of Mr. Nagy regarding Brant's trucks on North Park Road, the Police Department checked for a week on the trucks and found that only two times were there any loads on the trucks, one time some plaster and another forty concrete blocks.

Mr. Richey reports the Committee on Recreation had a meeting last Tuesday evening. Mr. Winner advised he and Mr. Duncan had met with Mr. Nichols of the County and he thinks he may be able to pursuade the County to exonerate the back taxes if we could get the School Board to do the same, and we could take over the lots at a very little expenditure. Mr. Richey was referring to the lots on Palatka, Magnolia and Frankfort Avenues.
Mr. Duncan advised that during his meeting with Mr. Nichols, he was advised the County is willing to put lots up for sale and we will pick out lots that are substantial building lots and could be sold.

PUBLIC RELATIONS COMMITTEE - Mr. Powell, Chairman, attended the meet-

ing of the North Boroughs Planning Commission where the topic of the Incinerator was discussed. The Commission is still endeavoring to get a meeting with the County Commissioners.

Mr. Powell also reports a letter had been sent to the State Milk Commission regarding the price in Pittsburgh of milk in comparison to that in Philadelphia. Some milk dealers attended the North Boroughs Planning Commission Meeting. There will be a hearing before the Milk Commission in Pittsburgh on May $2l_1$.

There was a demonstration of a Home Incinerator at the meeting which sells for approximately \$125. There is no odor to the burning in the incinerator but there would still remain the problem in the Borough of hauling away tin cans. It takes about four hours to burn the refuse.

Mr. Powell attended a meeting of the Board of Health and it is

Mr. Powell attended a meeting of the Board of Health and it is agreed the Clinic will be the same as last year but it will be at No. 3 Fire Hall. There will not be a reduction in cost but through the Surplus Food Board, Mr. Freese will distribute notices to persons unable to pay for the shots they can obtain them free of charge. Mr. Powell reports Mr. Safarik will be Chairman of the Clinic and it is recommended that persons aged to forty years get the shots.

Mr. Powell advised the Judge in charge of the Allegheny County Port Authority suggests a Member from each municipality be appointed. He, the Judge, is acquainted with Councilman Nash and suggests that Mr. Nash be appointed to the Port Authority. President of Council, Mr. Hurley, appointed Clarence J. Nash to the Port Authority in response to the above request.

Mr. Jones - no opinion other than if the Animal Control cleans up the dog situation in a short time, he would have to be pretty efficient.

Mr. Richey calls attention that half of the year is now gone, and if the Animal Control is employed, it only means an increase in the Budget of \$150.00 and it would be worth it since we are having so many complaints.

Burgess Gahring advised Council he has many, many calls at his home about dogs and he does not feel we are getting satisfactory services from the present Dog Agent.

Chief Clogan agrees with this opinion.

After discussion, Mr. Hurley advised the Borough Manager to use his own judgement and if he feels we are not getting services at the present time, then to employ the Animal Control.

Brant's Horseshoe Bend

Catch Basin -- Mr. Winner reports there is a catch basin below Brant's Garage on Perrysville Avenue, Horseshoe Bend, that is clogged. This basin carried the water down across Perrysville Avenue to Glenmore Avenue. However, Mr. Winner cannot find any easement for this.

Sewers

Ross ----- Mr. Winner reports that Ross Township has enacted an ordinance whereby the charge to tap into their sewer by a resident of the Borough will be \$525.00 plus \$30.00 for each fixture in excess of eight. Mr. Kampus, a property owner on the Old Perry Highway, wanted to connect into the Ross Township Sewer, but the costs to Ross Township in addition to the labor to make the installation, would be very costly.

This completed Mr. Winner's report.

Reports

Committee ---- FINANCE COMMITTEE - Mr. Duncan, Chairman, calls attention the funds are running low and it is hoped Council will not have to go to the bank for another loan before the taxes begin coming in.

> PROPERTY & PURCHASE COMMITTEE - Mr. Nash, Chairman, advises Mr. Winner covered his report well and he deferrs any further report until later in the Meeting.

PUBLIC WORKS COMMITTEE - Mr. Freese, Chairman, advises that Mr. Winner covered his report but referred to the weeds along the

carline. He advised Council Mr. Winner had contacted the Pitts-burgh Railways Co. two or three weeks ago and Mr. Clogan advised the Railways Company started cutting weeds today.

Mr. Freese asked about the condition of the crossings being corrected, and Mr. Winner advised he notified the Railways Company but that Mr. Martin, who usually handles this for West View, is away. However, Mr. Holbein promised that the work would be done by June 14.

POLICE & PUBLIC SAFETY COMMITTEE - Mr. Richey, Chairman, advised he has the report from the Police Pension Fund Actuarian and requests the Secretary to send a copy to each Member of Council. Mr. Mockenhaupt submitted his bill in amount of \$250.00, which will be held until July Meeting.

Mr. Richey reports in RE: the RECREATION COMMITTEE: At a Board Meeting held Tuesday Evening, June 6, it was recommended that Mr. William Martin be hired as Director at the Recreation Field this year, and that the program be the same as carried out in the past.

Mr. Richey, at request of two residents of Princeton Avenue, investigated a small play area on the dead end of Columbia Avenue, part of the area extends onto private property. (Columbia Avenue is unopened at this point.)

The younger children have been playing and the Borough has been requested to provide for some kind of a backstop. Mr. Winner feels we can get some wood and wire mesh for approximately 30 to 35 dollars.

Mr. Richey recommends that this be done. Two of the residents in the area will erect the backstop.

Motion by Mr. Nash, seconded by Mr. Duncan, that a reasonable amount of money be spent to purchase lumber and wire mesh to provide the backstop for the benefit of the small children as a play area.

Carried and so ordered.

In RE: The School District's equity in the lots in the area of Palatka, Magnolia and Keating Avenues, Mr. Carson advised the Committee that there was no actual commitment made by the School Board, but it will be discussed to see what the attitude is, if the Borough decides to go through with the project.

Mr. Nash called attention to the forty acre plot between the Borough Line and Cemetery Road and suggests Mr. Brandt explore the possibilities that this land being annexed to the Borough or acquired by the Borough for recreation purposes.

Mr. Winner reports that he investigated the feasibility of acquiring this land. There are approximately 43.06 acres and the owner or owners were asking a thousand dollars per acre, it is assessed at five hundred dollars an acre. Mr. Winner also contacted the Hahn heirs, Mrs. Rooney, who contacted the others and they want to sell the whole thing. Mrs. Rooney did not give Mr. Winner a direct answer because there are so many heirs to the property.

Mr. Duncan said that Mr. Hauck, now says he feels that it is not feasible to develop the property and desired to get out from under. Mr. Nash suggests we get into the matter and see if we can negotiate for the land.

Since Mr. Hauck feels it not feasible to develop the land, it is possible the heirs would like to get rid of it.

Mr. Hurley says the small area used for a ball field is used extensively and if we can get a forty acre plot, it would really mean something.

Mr. Richey again referred to the lots on Palatka, Magnolia and Keating Avenues and Mr. Duncan suggests maybe if we can get a block or eight or ten lots together it would make a nice little field for now.

FIRE AND WATER COMMITTEE - Mr. Jones, Chairman, no report.

PUBLIC RELATIONS COMMITTEE - Mr. Powell, Chairman, reports that at the meeting of the North Boroughs Planning Commission, Mr. Griffith, a Member of the Committee for Garbage Disposal, advises the report on the findings of the Committee was in the May 11 issue of the Suburban News.

NOTE: Mrs. Lillich, Publisher of the Suburban News, is providing a copy of this issue for each Member of Council.

Mr. Powell reports that at the last meeting of the Fire Department, they requested that a check for the Borough's contribution for the 1961 Convention be forwarded to them.

He is requested to advise the Fire Department that at this time, just prior to time of taxes, the funds are not such that the Borough can conveniently mail the check and that if the Fire Department will use their money to make reservations, etc., the check from the Borough will be mailed to them when taxes begin to come in.

Mr. Powell advises that boys are playing ball up in back of No. 1 Engine House and several windows have been broken. Mr. Richard Smith recommends placing chicken wire over the windows. Mr. Winner does not think this is satisfactory but that perhaps Mr. Smith could discuss with the boys about having one boy being the "leader", who would oversee the playing and no more windows would be broken. The ones that are now broken will be replaced.

Audience ---- Mr. Bairhalter reports the engineer he hired does not recommend his building a home over the sewer on the lot adjacent to his property. He now requests permission to move the sewer to the side of the lot. He is advised that in as much as the Solicitor is absent from this meeting, no decision will be made by Council at this time.

Sidewalk ---- Mr. Richey referred back to the sidewalk on Highland Avenue from
Highland Bronx Avenue to the School and advised Council the Chief of Police
Bronx to talked with the people adjacent to the walk and feels the problem

Roll Call was answered by the following Members of Council: Messrs Duncan, Freese, Jones, Nash, Powell, Richey and Hurley. Burgess - J L Gahring; Controller - W H Douglas; Treasurer - A L Seethaler; Solicitor - Carl Brandt; Manager - Wade Winner; and Secretary; were present.

6/12/61 Mins - Motion by Mr. Duncan, seconded by Mr. Powell, that the Minutes of June 12, 1961, be approved.

Carried and so ordered.

Under question - Mr. Nash objects to payment of bills for services or parts to the 1957 Jeep.

Motion to pay bills carried and so ordered.

Reports ---- Motion by Mr. Richey, seconded by Mr. Jones, that the reports of the following Officers be received and filed: Burgess, Treasurer, Controller, Chief of Police, Fire Chief, Secretary and Manager. The Solicitor deferrs his report until later in the meeting. Manager, Mr. Winner, added the following to his report, verbally: The Johnston Construction Company had to lift the sidewalk next to the home he was erecting on Clairmont Avenue, after which he replaced the walk. However, the walk has sunk and they seem to be reluctant to repair or replace it for the owner, and Mr. Winner feels he is responsible for this adjustment. The Solicitor, Mr. Brandt, directed Mr. Winner to notify the Johnston Construction in writing according to the Act, he is to replace this sidewalk within thirty days. If he does not comply, the Borough will install the walk and bill him for the cost plus 10%, as provided, and penalties. Mr. Winner asked the Solicitor if it is in order to require Raimondo Construction Company to furnish Release of Liens from the subcontractors who have been doing the work at No. 1 Engine House. Mr. Brandt said to demand them.

> Mr. Winner also advised Council of three cases of complaints about trees obstructing the street lights. These matters are to be referred to the Shade Tree Commission, with whom Mr. Winner has a meeting Wednesday evening.

Committee --- Finance Committee - Mr. Duncan, Chairman, pleased to announce it Reports was not necessary to go to the bank for another loan. Motion by Mr. Duncan, seconded by Mr. Nash, that the amount of \$2000 be transferred from the General Fund to the Sinking Fund for bond obligations August 1, 1961. Carried and so ordered.

> PROPERTY & PURCHASE COMMITTEE - Mr. Nash, Chairman, under subject of the Borough obtaining the Hauck property for recreational purposes, understands from Mr. Winner's report that the property is for sale for about ten thousand dollars (building value) but he thinks the price for recreational purposes will be the same.

He recommends that Council hire an appraiser, suggesting the name of Leonard Kane for his experience and reputation in this field,

to make an appraisal.

Motion by Mr. Nash, seconded by Mr. Powell, that Mr. Kane (or another appraiser equally as competent) be hired to make an appraisal of the land and report to Council, and if the report is favorable, the property be purchased for the Borough of West View for Recreation if it will be beneficial to the people of the Borough, the cost of the appraisal not to exceed three hundred dollars.

It is suggested that the Manager contact the appraiser, or whoever Council decides to hire, as soon as possible and after receiving the report, Council call a special meeting to receive the report in its entirety.

Under Question - Mr. Duncan is in favor of acquiring the property but questioned the necessity of paying a fee for an appraiser. However, Mr. Brandt ruled that for the protection of Council, an appraiser should inspect the property and submit his report to Council.

Under Question - Mr. Richey advised this property was brought up at the last meeting of Council by Mr. Nash, and the Manager directed to look into the matter. Since that meeting, Mr. Richey was advised that Mr. Winner had a letter in which the price quoted is a lot different than the last time it was brought up, when they were asking a thousand dollars an acre. Mr. Winner asked if Mr. Richey thought we could call Council together to look at the property but he suggested that we might want Mr. Schafer and the other Members of the Recreation Board to look at it because if we acquire the property, it will come under the jurisdiction of the Recreation Board. The Board, with the exception of Mr. Corson met, and looked at the property.

Mr. Richey described the property.

The Recreation Board came to the conclusion that it is a nice piece of property. However, some questions - Are we going to get into trouble buying property outside of the Borough? Are we going to have to permit Ross people to come into the property as a deal to exonerate the taxes? We should have legal advice on these questions.

Mr. Hurley says there are many potentials, such as picnic grounds, etc.

Mr. Nash asked Mr. Brandt's opinion.

Mr. Brandt talked with Mr. Hauck and he told him that they found that to go into the cost of getting water in and streets, the price is so prohibitive they did not feel it feasible. The impression Mr. Brandt got and still has is they have this property and cannot dispose of it. Mr. Brandt then spoke about the new road that is to come out through the North Hills area and wondered if and how it would affect the area.

Mr. Brandt, in response to a question of Mr. Duncan, suggested "Is the price quoted the final price or just the asking price?" Mr. Duncan suggested that he is in favor of making an offer of five thousand dollars. It is not a salable property and they

may think it is better to take five thousand dollars and get rid

Mr. Brandt emphasized that when you are handling public funds, you ought to be fortified with an appraisal.

Mr. Hurley asked if we are a little premature in making the deal and Mr. Freese advised that Ross Township will take it if we do not act soon.

Mr. Richey asks if, as Mr. Freese suggests, Ross Township wants the property, could it be while we are having the property appraised we might lose it.

Mr. Brandt advises to get the appraisal and have Mr. Duncan, as a Real Estate Man, negotiate with Mr. Hauck. Motion carried and so ordered.

Public ----- Chairman, Mr. Freese, advises his report covered by Mr. Winner. Works

Public Safety

Police & ---- Chairman, Mr. Richey - Motion by Mr. Richey, seconded by Mr. Nash, that Council advertise for a new police car to replace the 1959 car. The old car is giving us quite a bit of trouble. The bids to be opened August 8, 1961, the car to have the same specifications, size, etc.

Carried and so ordered.

Mr. Richey says there has been some talk of compact cars but the Police and Mr. Richey feel we have different problems and the larger cars are more suitable.

Mr. Richey recalled that the radio in the 1959 car has to be replaced to meet requirements of the FCC.

Motion by Mr. Richey, seconded by Mr. Nash, the radio system in the new car be brought up to date to meet specifications of the FCC.

Carried and so ordered.

Mr. Richey called attention that the cost of the Park Guards is high and thinks we should talk with the Park in the next few months about their permit fee.

Fire & Water -Mr. Jones, Chairman, reports he has a letter from the Fire Department asking for the money for convention costs. Motion by Mr. Nash, seconded by Mr. Jones, that a check in the amount of \$800.00 be sent to the West View Volunteer Fire Dept. & Relief Ass'n for Convention Expenses, the convention being held in Motion carried and so ordered.

Relations

Public ----- Chairman, Mr. Powell, reports the North Boroughs Planning Commission sent a letter to the County Commissioners asking for a meeting to find out about the disposal plant. The Chief Clerk sent a reply that the three Commissioners are studying recommendations and it will take four to six weeks for them to complete the study, and a letter will be sent out containing the probable estimate when they have finished.

> Mr. Powell advises the Planning Commission's picnic will be in August (tentative date - August 23), and Members will receive more information when plans are completed.

Mr. Hurley suggests as many Officials, with their families, attend the picnic as can do so. Mr. Powell has had favorable comments for Council on the new street lights that have been installed so far.

- Audience ---- Mr. Nagy, North Park Road complained again about trucks travelling North Park Road causing a vibration in his home.

 This matter was discussed and Mr. Richey asked Burgess Gahring if a STOP sign could be placed at Linwood Avenue. Burgess Gahring agreed and will use his sixty day emergency powers to have it erected and enforced.
- Polio Clinic -Mr. Hurley read the report on the Polio Clinic there were four hundred paid innoculations given and a number of free innoculations.

Mr. Brandt said the Borough would have the right to go into the property and make the repairs, and it would be a question as to whether the owner could recover damages resulting from this action. Mr. Brandt also stated if the Borough were to give a waiver and it was filed in Court, then there is the question of whether anyone would every buy the property.

Mr. Duncan concurred with this.

Mr. Winner asked what would happen if the pipe goes bad about 25 feet under the fill.

Mr. Brandt asked Mr. Bairhalter about the Engineer's report. Mr. Bairhalter replied that he has placed a heavier pipe and when asked if the job of laying the pipe had been inspected, Mr. Winner said he had seen seven lengths of pipe but did not see three of them, which were covered. The pipe is two foot, reinforced #5

Mr. Brandt asked "Roughly, what was the cost of the Job?"

Mr. Bairhalter said about five hundred dollars, the cost of the pipe, four days' time laying it and the use of the hi-lift. Mr. Brandt then asked why it was the Borough Manager did not see the three sections. Mr. Bairhalter said he had to cover it up because the sides of the excavation were sliding and the Manager was not working on Saturday.

Mr. Winner says he cannot certify he saw the pipe, and there is now 23 feet of earth on it.

Mr. Brandt said it is not a question of the Officials seeing it but for the people of the Borough, they want to know what is happening. Based on circumstances as they are now, Mr. Brandt said he will have to advise Council not to grant the permit. Mr. Brandt asked Mr. Bairhalter if, in the event the Borough of West View grants a permit, recognizing that Mr. Bairhalter knew the sewer was there when he acquired the lot, and recognizing it affects a number of residents so far as health and welfare, in the event the sewer became stuffed or collapsed, would he, Mr. Bairhalter, his successors or heirs agree to make an agreement to repair the sewer and have that agreement become a matter of record in the Recorder's Office.

Mr. Bairhalter said he cannot answer that question, and following this remark, he said "If something happens to it, I would expect the Borough to move the sewer to the street where it belongs."

Mr. Bairhalter referred to Dr. Heyl's property on Center Avenue and said that the plan shows the storm sewer ran through the lot and when Dr. Heyl built, the sewer was not there, it was moved along Center Avenue before Center Avenue was paved.
Mr. Brandt said Center Avenue was paved before 1929.

Mr. Brandt asked Mr. Bairhalter if he wanted the people of West View to assume the cost of moving that sewer when they now have an easement.

Mr. Brandt asked if the engineer gave an opinion about the repairs to the sewer with the building over it and Mr. Bairhalter said you could put an auger into it to repair it.

Mr. Hurley asked Mr. Bairhalter if he will agree to an agreement such as Mr. Brandt outlined and Mr. Bairhalter said he does not want to stick this on his children.

Mr. Hurley said he believed Members of Council will be guided by the opinions of the Solicitor and the Manager.

Mr. Bairhalter said he would get 'revenge' if he loses his money on this.

Mr. Brandt advised situations like this occur in Pittsburgh but he does not know how they are handled.

He also said he is sure every Member of Council is sorry Mr. Bairhalter used "revenge" as they are willing to help in spite of his attitude.

Mr. Brandt said he is willing to meet with the Engineer, Borough Manager, Mr. Bairhalter and his Attorney to see if there is any solution to the problem.

Mr. Bairhalter advises he has about five thousand dollars tied up in the lot and that he is now having the title searched. Mr. Richey asked Mr. Bairhalter if he means to say he has five thousand dollars tied up in the lot without having first had the

title searched and Mr. Bairhalter's reply was "Yes". Mr. Richey does not feel it is the responsibility of the Borough's if Mr. Bairhalter laid the sewer without first having had the title searched.

Defense in West View. Mr. Richard Smith, Director for West View,

Florence M. Gerber is the owner of property situated at the corner of Cornell Avenue and Princeton Avenue. She has an opportunity to sell this property to Alfred E. Thomson, III, who would like to develop it by placing three duplexes thereon. This would require the following to be done:

> 1: Vacate Bragg Alley from Cornell Avenue to a point where it intersects with Monfort Alley

> The Borough to permit redivision of lots 605, 604 and 603 in such a manner that there will be two lots each having 45 foot frontage on Cornell Avenue with a depth of 95 feet running parallel to Princeton Avenue, the balance of the 110 ft. on Cornell Avenue going to Lot 623 which, with the 10 ft. alley, would then make this lot 70 ft. in frontage on Cornell.

Permit a double duplex on Lot 623 which will be a 70 ft. lot.

It is Mr. Thomson's and Miss Gerber's thought that they take the total frontage on Cornell of 160 ft. including the 10 ft. alley, divide it into three lots, two of which would be 45 ft. lots and one a 70 ft. lot. Motion by Mr. Freese, seconded by Mr. Powell, that a building permit be granted to Mr. Nagel for the erection of the building as per plan submitted to Council.

Carried and so ordered.

Air ----- Mr. Winner has inquired about types of air conditioners for the Conditioner Municipal Building and asks he have a little more time in which to make a thorough check before purchasing.

Whooz Store -- Whooz Store has asked permission to extend the present sign, and Mr. Winner believes that their request is still within the ordinance. Before granting the permit, Mr. Winner will want the consent of the Municipal Authority, Owner of the Building.

Avenue Avenue down to Lehigh Avenue.

He requests time to make an investigation of the above request, since the letter was only received today, October 10.

Intersection - Mr. Winner advises that Harry Morrison has offered to deed enough of his land at the corner of Ridgewood and State Alley to provide for the widening of the intersection to provide more room for the school buses.

Mr. Winner advises the work can be done with Borough Labor.

Fall-Out ---- Mr. Winner attended a meeting at the School in RE: Fall-Out Shelters. So far, the shelters shown have not been approved by the Federal Government and recommends that the Borough not do anything about this until we have the information from the Government.

Committee --- FINANCE COMMITTEE - Mr. Duncan, Chairman, says not much to report but would like to call attention that the balance on hand is less than it was this time last year.

PROPERTY & PURCHASE - Mr. Nash, Chairman, wished to bring before Council at this time, the subject of the purchase of a Power Unit for Civil Defense.

He recommends that at the next Council Meeting, Council should advertise for these two Generator Units and we should take care of it in the Budget next year.

Mr. Duncan asked about the unit we now have and Mr. Winner explained about the necessity of a storage tank for gasoline, etc., and would like to give more study to that unit.

Mr. Nash referred to Mr. Winner's report about fall-out shelters, and recalled he recommended an amendment to the building ordinance of zoning ordinance to permit shelters to be built. However, he recommends holding up the ordinance until we get specifications from the Government and not issue any permits until we get the ordinance into effect.

Mr. Nash advises there is a report on the property in which the Borough is interested and he would like to discuss this later in this meeting.

PUBLIC WORKS COMMITTEE - Mr. Freese, Chairman, says Mr. Winner has covered his report quite thoroughly.

POLICE & PUBLIC SAFETY COMMITTEE - Mr. Richey, Chairman, asked about the change in regulations on Chalfonte Avenue, and Chief Clogan advises this is not in effect as yet because we are awaiting the signs.

Under RECREATION, Mr. Richey advised the Recreation Board had a meeting and made plans for a Hallowe'en parade to be held on October 30, and in the event of rain, it will be held November 1. The Board talked of arrangements being made if it rained on October 30, of having the event indoors but there does not seem to be a large enough building to accommodate this many persons. However, the Chairman will contact the School to see if it could be held there if we get caught in the rain.

Mr. Richey advised they will need about a thousand bags, more or less.

Motion by Mr. Nash, seconded by Mr. Duncan, that the money necessary to provide bags and prizes for the parade be authorized. Carried and so ordered.

Mr. Hurley complimented the Recreation Board on the good job they have been doing in putting on these Halloween Celebrations.

Mr. Hurley also called attention to the damage being done at Bronx Avenue Recreation Field. It is suggested that perhaps if a request for the children to abstain from vandalism at the Field wich is provided for their use, through the schools, it may be effective.

FIRE & WATER COMMITTEE - Mr. Jones, Chairman, advises the Members at No. 1 Engine Company request that the building be painted. Mr. Winner has already checked with the Members as to what color they want, and on a day when the weather is too bad to work out of doors, the painting will be done.

Solicitor ---- Carl Brandt, Solicitor, entered the meeting at 8:40 P M.

PUBLIC RELATIONS COMMITTEE - Mr. Powell, Chairman, attended the meeting of the North Boroughs Planning Commission September 28. The City of Pittsburgh has removed the 25 MPH speed limit on the Ohio River Blvd within its boundaries and are permitting a speed limit of 50 MPH. It is recommended by Mr. Toler that the other communities along the Boulevard permit 50 MPH.

A motion was adopted by the Commission that the member communities send a request to the Allegheny County Sanitary Authority to send out a delinquent notice to users of the sewage facilities, in as much as the machines they have could handle these notices with their I. B. M. Machines.

Mr. Powell advises that Members of No. 3 Engine Company will go ahead and have the duct work done and be reimbursed by the Borough out of next year's budget, the estimated cost to be \$300.00. Mr. Nash says if there is any way possible we can secure the money with which to do the work, we should do it this year.

Mr. Duncan says we should not commit anything for next year because we have so much to do for No. 2 Engine Company but should try to do the duct work this year. Motion by Mr. Nash, seconded by Mr. Jones, that the duct work at No. 3 Engine House be done this year. Carried and so ordered.

Mr. Freese asked about the false ceiling Members of No. 3 would like to have but it is agreed the most important item is the heat.

Mr. Powell reports the people who reside in the vicinity of the dead end of Mt. Vernon Avenue appreciate the good work the Borough Manager did, but they would like to have the fence extended all the way around, about 25 feet more. Mr. Winner had intended to do this work.

Mr. Powell has complaints about the speeding on Ridgewood Avenue and addressed his remark to Mayor Gahring.

Audience ---- Mr. Harold Kunze advised Council he was turned down on a permit Harold Kunze to erect four houses, (Row Houses all under one roof) on Oakwood Avenue.

He is advised this type of building does not conform to the Zoning Ordinance and his plans and specifications are not within the regulations of a double duplex.

He is advised to change his plans to conform, after which he will be granted a permit.

Co in RE Crossing At Ashford

They will grant the Borough a permit to cross over the tracks if the Borough will accept the Agreement. Agreement, the Borough is to put in the crossing under their supervision and the Borough to get a permit from the P. U. C. advised Mr. Nagel wanted to start to clean up the lots ready to go ahead when the details have been settled.

Shelters

Fall-Out ---- Mr. Winner advised Richard Smith has some literature from Civil Defense in RE: Fall-Out Shelters and Mr. Winner thinks the Borough should take some action on the question of whether to

permit the installation of shelters.

Mr. Powell advised he attended a C D Meeting in McCandless Township and at the meeting, it was reported quite a few municipalities are digressing from their Building Code to permit the erection of Fall-Out Shelters. Some are being built in cellers and some outside.

Mr. Hurley asked for an opinion from Mr. Brandt, the Solicitor.

Kenney -----Property

Mr. Winner advises he has a request from Anna Kenney to sub-divide Lots Nos. 41 and 42 in the Schwitter Plan, Corner of Highland and Bellevue Avenues, into four parcels of land.

Mr. Brandt advises that under the law, to sub-divide land, you must have an approved plan. Examination of the plan submitted indicates that all four lots will face on a paved street, there are sewers and other utilities. Mr. Brandt says the only question he has is the Manager's opinion about the size of the lots. Mr. Winner advises this is sufficient area. Mr. Brandt advised that if Council is satisfied about the size of the lots, they can approve

Mr. Duncan asked if it is necessary to have the plan approved by the County Planning Board to which Mr. Brandt replied "Yes".

Mr. Richey asked about the effect to the properties in the area.

Mr. Duncan asked if there should be a hearing.

Mr. Brandt advises that some communities will not approve a change of this kind until the Allegheny County Planning Commission approves. If the Kenney Family gets this approval before the next meeting, either the Borough Manager or Borough Secretary can post the

premises advising there will be a hearing prior to the next meeting of Council.

Mr. Nash is of the opinion this is the proper procedure.

Reports

Committee ---- FINANCE COMMITTEE - Chairman, Mr. Duncan, Motion by Mr. Duncan, seconded by Mr. Richey, that \$3,000.00 be paid on the \$15,000.00 note which was borrowed in 1959. This will leave a balance of \$3,000.00.

Motion carried and so ordered, Mr. Nash voting "No" because he objected to borrowing the money and has not advocated any payments for that reason.

Placque Fd Accounts

B I #21 & ---- Mr. Duncan advises there is an amount in Bond Issue Account #21 of \$409.79, and an amount in the Placque fund of \$63.62. these accounts have been inactive for ten years and Motion by Mr. Duncan, seconded by Mr. Richey, that these amounts be transferred to the General Fund. Carried and so ordered.

> PROPERTY & PURCHASE COMMITTEE - Chairman, Mr. Nash, says he has the latest inventory of Borough Equipment. He now wants the Borough Manager to check all of the equipment and any equipment that is not here, as per the inventory Mr. Nash has, he wants an explanation.

That is item No. 1.

Item No. 2 - Mr. Nash would like to see Martsolf and Ridgewood Avenues paved. He says there are five Councilmen who will still be in office and he would like to see consideration given to the committment.

Item No. 3 - Mr. Nash states Council had under consideration approximately 43 A of land for protection of the Borough and thinks that should be given some thought.

These items are his suggestions to this Body:

He would like to see an increase in lighting in the Borough. He would discourage the organization of any parking authority in the Borough.

Also, the floating of any bonds unless by mandate of the people. Mr. Nash says he may have a few more suggestions as the evening goes on and requests leave to present them. He wanted to bring these facts to Council in view of the fact we have some of the new men here and he would like to see these ideas carried out.

PUBLIC WORKS - Mr. Freese, Chairman, reports Mr. Winner has pretty well covered his report.

POLICE & PUBLIC SAFETY COMMITTEE - Mr. Richey, Chairman. He has a request that R. C. Freedman be paid his salary for the third week of his vacation in lieu of the time off.

Motion by Mr. Richey, seconded by Mr. Nash, that R. C. Freedman be permitted to take one week's pay instead of vacation period. Carried and so ordered.

Mr. Richey would like to have an ordinance amending the Traffic Ordinance to permit the use of "Yield Right of Way" signs. Also to provide there shall be no parking on the easterly side of Bronx Avenue for 105 ft. southwardly from the easterly section of Purdue, or Princeton Avenue, on Bronx Avenue.

Mr. Nash asked if anyone has contested this regulation and Mr. Brandt explained the suit pending.

Mr. Richey continued with the following: Park Avenue is a one-way street from Perrysville Avenue to Orlando Avenue. At the present time trucks are using it and he recommends making the street two-way.

Motion by Mr. Powell, seconded by Mr. Jones, that if an ordinance was not passed making this a one-way street, that the signs be taken down and two-way traffic permitted.

Carried and so ordered.

Mr. Richey suggests if there are any repercussions, we will take another look at the situation.

Mr. Richey advises the 1960 Buick Police Car is in very bad condition, and suggests we advertise for a new car, bids to be opened in December and paid for in 1962.

Motion by Mr. Richey, seconded by Mr. Freese, that Council advertise for a new Police Car, bids to be opened at the Regular Meeting on December 12, 1961.

Carried and so ordered.

Recreation --- Mr. Richey reported that everyone seemed pleased with the Hallowe'en Parade. Mr. Shaffer asked about the apples that were left over and some of the Councilmen suggested distributing them when the Surplus Food is distributed. However, Mr. Winner had to make a quick

decision as the apples were not keeping. He took them to the School for the Blind Children in Oakland and Mr. Richey commended Mr. Winner for this action. All Members of Council seemed to agree.

FIRE AND WATER COMMITTEE - Mr. Jones, Chairman. No Report.

PUBLIC RELATIONS COMMITTEE - Mr. Powell, Chairman, thanked the Officials for the floral piece to Mrs. Viehbeck.
Mr. Powell reports there was no meeting of the North Borough Planning Commission last month.

He attended a CD meeting at the McCandless Township Building with Richard Smith, who is CD Director for West View. Mr. Sullivan of the County CD conducted the meeting. He had just returned from a meeting of all districts. The U.S. Government is emphasizing common fall-out shelters and not de-emphasizing family shelters; there will be about sixty thousand pamphlets available but Mr. Sullivan did not have them at the time of the meeting in McCandless Township. Mr. Powell recommends, due to the fact there is only one bid in response to the advertisement for an auxiliary power plant, that the bids be held in abeyance as there will be Federal money available for CD. Mr. Powell also reports the Government has allocated two hundred six million dollars for CD, ninety thousand of which is for surveys, etc., and that schools will get first priority. Boroughs, etc. should go after their Solicitors to secure as much money allocated as possible for fall-out shelters rather than for athletic fields, etc.

Mr. Powell advised there are packs for students, at a cost of \$3.00, enough to last for sixteen days. It is food that will keep you alive and last for five years, and the water will last for twenty five years. The pack for the average family will cost about \$16.00 each.

After the meeting was over, the C D Director of McCandless Township gave the set-up they have in which they can take care of about a thousand people, and this did not cost them any money.

Center & ---- Mr. Powell reports the intersection of Waverly at Center is a bad corner as the visibility for cars coming up Center Avenue or out Avenues of Waverly is poor. He recommends signs "Bad Corner" be erected. This will be done.

Audience ---- Mr. McNelis, 450 Perrysville Avenue, advised Council he would like to display a fall-out shelter. If he can get permission, he would like to display this on Perrysville Avenue in front of his building, for the purpose of educating West View people as to what a fall-out shelter is.

Mr. Brandt advises there is nothing in the Zoning ordinance now to cover fall-out shelters and that he has been directed to draw up an amendment to provide for the erections and it will be ready for the next Regular Meeting of Council and he will recommend this permission be an amendment.

Mr. Brandt asked if Mr. McNelis was thinking of displaying the shelter for commercial purposes. He stated as long as it is on his own property and so long as it is not on the Borough road or prop-

erty or the State Highway, he will have the right to demonstrate. He advised Mr. McNelis to consider if persons were to congregate, if it will cause a traffic tie-up. Also, we have an ordinance providing sidewalk sales are not permitted. Mr. Brandt advised the Borough has a dollar a year lease with West

View Park for their parking lot, and perhaps Mr. McNelis should talk with the Park Company to see if they would permit him to display one of these shelters on their property. You then, meaning Mr. McNelis, would be off of the Highway and not causing any traffic tie-ups.

Mr. Nash

asked if there is to be any legislative matters coming up at this meeting that require a yes or no vote. He would like to leave

The Ordinances providing for taxes under Act 481 are to come up.

Wage Tax ---- Motion by Mr. Duncan, seconded by Mr. Richey, that Ordinance No.
