Mr. Winner would like to have an ordinance prepared to provide for the installation of the sewer in the Alley behind the Greco property, the entire cost to be borne by the property owners abutting the sewer, on a front foot basis rather than assessments by the Board of Viewers.

Mr. Winner reports he has received a letter about alterations to be made on the Municipal Building recommended by the Representative from the State. He calls for a second entrance to and from the Jail Room and we are to submit a sketch of the layout of this building.

Mr. Winner reports the Business Men's Association had a meeting and propose to put flower boxes next to the buildings instead of at the curb as originally intended. If they will take out the proper insurance making the Borough a Co-Insured, it will probably be a nice thing.

They spoke of having a carnival but no plans have been made to date as to when, where, etc. Mr. Winner asked if Council had any objection, if they work up a plan, to giving them a permit for a Carnival.

Mr. Hurley advised he had been approached and that they expect some financial aid from the Borough, which he advised them is prohibited. However, he feels if they propose to have a carnival and it will help their business, he would be the last man to say "No", but we will wait until we get some of the facts.

Minutes of a Special Meeting of The Town Council of the Borough of West View held Tuesday Evening, April 17, 1962, in the Council Chamber. Meeting called to order after a moment of silent prayer, at 7:35 by President of Council, E. M. Hurley.

Roll Call was answered by the following Members of Council: Messrs Cully, Duncan, Freese, Jones, Love and Hurley. Councilman Richey entered the meeting at 8:00 P.M.

Present also were T. E. Benson - Mayor; W. H. Douglas - Controller; A. L. Seethaler - Treasurer; Wade Winner - Manager; and Naomi Guckert-Secretary.

The following is the call letter:

E. M. Hurley, President of Council West View, Pittsburgh 29, Pa. Dear Mr. Hurley:

A special Meeting of the Town Council of the Borough of West View is called for Tuesday Evening, April 17, 1962, at seven thirty o'clock, to be held in the Council Chember at the Municipal Building.

The purpose of the Special Meeting is to discuss and take action on any Borough Business which might come before Council.

President of Council called upon Mr. Freese to advise Council of the inspection of the Borough made by the Public Works Committee together with the Borough Manager. Many of the streets are damaged as a result of the winter weather and should be taken care of immediately to avoid heavier expense later. There is more work than can be handled from the General Fund. Therefore, the Public Works Committee are recommending that Council have a Bond Issue to finance the taking care of all of the streets this year, as well as the Ridgewood Bridge, which is going to cost approximately ten to twelve thousand dollars to repair. The bridge is a Must. In the Bond Issue, it is recommended to include funds for the erection of a fire house for No.2 Company rather than to put a large sum of money into the present building. There is also a slide on the path at Center to Ridgewood Avenue, across from Brightwood, which is going to have to be repaired at a great expense. Another landslide at the Martsolf Avenue Bridge steps that requires immediate attention. Mr. Freese said he was calling these conditions to the attention of the other Members of Council and would like to have an opinion from them. Mr. Winner prepared a list of the projects and distributed a copy to each Official. Mr. Winner added to this list the need for new steps on Ashford Avenue from Westfield to Wentworth and perhaps the closing of the path from Center Avenue to Ridgewood Avenue and installing new steps on the other isde of the Bridge. Mr. Hurley called on each Councilman for an opinion.

Mr. Duncan is not in favor of a Bond Issue and thinks it would have been better to have raised the millage when preparing the Budget.

Mr. Freese advised his Committee has gove over the streets and is of the opinion the work must be done this year to avoid bigger costs later and his Committee is in favor of a Bond Issue in amount of seventy five or eighty thousand dollars since the cost cannot come out of the General Fund. The recommendation is based on the prices quoted in the low bids received for this type of work this year. (Mr. Winner made a compariosn with bids quoted in 1961 and calls attention the prices are lower this year.)

Mr. Love believes we should bear in mind we have some obligations to the people who elected us, they want good streets and other things that make a progressive Borough. He favors a Bond Issue to give the people these things and if you do these things, you have some basis on which to increase the millage if it becomes necessary.

Mr. Cully favors a bond issue to get the work all done, thinking perhaps we have been cutting corners too much during the last six years and now find it necessary to do the work to keep the streets from going to 'pot'.

Mr. Jones said the Committee inspected the streets and they are in worse condition than they have ever been, something should be done. He favors a Bond Issue.

Mr. Richey feels very much along the lines of Mr. Duncan's thinking. Perhaps there is some medium between the five or six thousand dollars set up in Budget and the Bond Issue and so as much as we can this year, and again next year.

Mr. Richey does not favor a Bond Issue.

Motion by Mr. Freese, seconded by Mr. Cully, that Council authorize a Bond Issue in amount of \$80,000.00, the bonds to be retired over a period of fifteen years.

Roll Calla Ayes: Messrs Cully, Duncan, Freese, Jones, Love and Hurley.

Nays: Mr. Richey

Motion by Mr. Love, seconded by Mr. Jones, that the Solicitor be authorized to prepare the necessary ordinance for Bond Issue #24. Motion carried and so ordered.

Planning Mr. James Nudi addressed Council regarding Planning and projects to be spronsored by the Federal Government.

Lee A formal petition, accompanied by a check, is received from Lee Leonard regarding the lots on Perrysville Avenue, adjacent to the Wellington Service Station, to be re-zoned to permit the erection of a funeral parlor.

Bond Issue Mr. Douglas, Controller, suggested the following schedule for the payment of the bonds under the new issue:

The Bonds to be in multiples of\$1,000.00, ten of which are to become due the first year, and five to become due each year thereafter for a period of 1h years.

Motion by Mr. Freese, seconded by Mr. Cully, that the Controller's recommendation be adopted.

To The West View Borough: ATTENTION: Mr. Clogan, Chief of Police.

SUBJECT MATTER: Dirt piles along Center Ave., extending halfway from Perry Highway to Bellevue Ave.
Dear Sir:

We understand that the ground upon which this dirt is casually piled, is privately owned. However, we feel that the Borough of West View can and should exert both moral and, if necessary, legal pressure to have the owner of said property either remove, level off, or otherwise dispose of these dirt piles, in a satisfactory manner. Here are some pressing reasons for our objections:

l. It is an ugly eyesore to the entire community. Motorists who wish to turn into this street are often discouraged, thinking that some construction is going on.

2. It is a definite hazard to both motorists and pedestrians. When it rains, mud rolls and streaks along the street, causing cars to slide, and persons to slip and fall, not to mention the mud and dirt which they pick up and redistribute into the various establishments which they may frequent.

3. Most important of all it is a DANGEROUS NUISANCE which attracts

small children.

As any parent knows, children love to play in dirt; infinitely more so if such dirt and perhaps pieces of glass or sharp stones are "ATTRACTIVELY" piled into pyramids for them.

Such children playing may fall or slide off and land either into the path of some motorist, or over the hillside. Not to mention the scratches, cuts and bruises that these children will incur while playing on these mounds of dirt.

In conclusion, we the undersigned strongly urge and hope that this matter can be satisfactorily resolved.

It was explained by Mr. Hurley that the street program will amount to more than \$65,000 and that does not provide for everything that has to be done. This does not include the cost of the repairs to the Ridgewood Bridge, which are absolutely necessary, some steps that must be replaced, etc.

It is suggested that Council try to carry out a previous agreement to put aside some money each year until such time as we can build a new engine house for No.2 Company. Meantime, it will be repaired.

# HEARING - Lee Leonard Property Wellington Heights June 12, 1962. 7:30 P M

A petition has been presented to Council requesting that the zoning on Lots 3, 4 and 5 in the Wellington Heights Land Company Plan be changed from Residential "A" Use to a Commercial Use District, to permit the erection of a Funeral Home by Devlin Funeral Home.

The place, date and time of hearing was set by Council to be held in the Council Chamber at 7:30, the evening of June 12, 1962. Proper notices were posted and advertised in the Legal Paper of the Borough, the Allegheny Journal.

President of Council, E. M. Hurley, opened the hearing and read the petition as presented, after which persons attending the meeting were called to present their opinions.

Mr. Vitunac, 214 Highland Avenue, Wellington Heights, Secretary of the Wellington Heights Association, reported to Council that at a Meeting of the Association, the change in zoning was opposed 100%, the feeling being if the property is permitted to go Commercial, it is a dis-service to the people who have invested money in their homes as it will lessen the value of the property and the people affected will demand a reduction in taxes.

Mr. Arthur Collins, a Member of the Association, attended the meeting of the Association and it was the consensus of opinion. Also, many of the residents were polled and no one is in favor of the change. He said they may not object to a building similar to the other properties above these lots but they do not want a funeral parlor.

Mr. Hurley reminded Mr. Collins that one of the Members of the Association has already condemned an apartment, to which Mr. Collins replied it was because of the type of the building, but if it were to be something nice, they would not object.

Mr. Hurley said the Borough would like to see a building erected from the standpoint of revenue.

Mr. Hough, 9 South Fork Drive, voiced his objections.

Mrs. Vitunic voiced her objections.

Mr. Adrian Supple, Wellington Drive, said the People of Wellington Heights are here to protest the change in zoning.

Mr. Wissner, 200 Montclair Avenue, says he is deeply interested in this problem as he has ninety feet back of the lots in question and when he bought it, fifteen years ago, he was told this was a residential area and to rezone these lots and permit a commercial enterprise, it is not going to help his property and asks if the Borough wants to favor a non-resident by doing this.

Page #2 - Lee Leonard Lots 3, 4 and 5 Wellington Heights Plan June 12, 1962.

Mr. Mulhizer, 198 Highland Avenue, opposes the change - does not think a change should be made to favor one pièce of property; what should be done is what is best for all.

Mr. Sheehan, 223 Montclair Avenue, purchased his home and moved into the Heights in December. Many people advised him against buying because there are ao many restrictions but he believes this is for the benefit of the people and he is opposed to any change.

Dr. Miller, 547 Perrysville Avenue, asked the Solicitor if in order to make the change there are a certain number of objections required.

Mr. Brandt replied that if a majority of the abutting property owners object, it requires three fourth vote of Council to amend the ordinance in order to make it commercial.

Mr. McKinley, Marquette Road, says he has been a resident of West View for seven years and in front of Council about thirty times and it is almost always the same thing. He says the people of Wellington Heights are here tonight to ask that Council protect their rights. These people from outside buy these lots and want to tuen them over for a quick profit. He says he bought, like others, with the idea it is a Residential "A" Zone.

Mrs. Lee Leonard, Butler County, Owner of the property, says they bought this property ten years ago with the intention of building. However, with four children, they do not think it suitable. They did not buy it for a 'quick' profit and that since these people all feel the way they do, "Believe Me, I am with you." However, what do you do with an eyesore - do you want an apartment; why not a funeral home to beautify it.

Mr. Devlin asked of Mr. Brandt how many houses would be permitted to be built on these properties, to which Mr. Brandt replied, one on each lot or three houses. Mr. Devlin then asked if the houses could be rented to whoever they wanted to rent, to which the reply from Mr. Hurley was "That is your perogative."

Mr. Frank Donaghue thinks perhaps they should show by hands who is opposing and who is in favor. The hands indicated all opposing and none in favor.

This hearing was adjourned at 8:05 P M.

Mayor Benson recommends we advertise by the first of October and if agreeable to Council, would like this to be done.

Mr. Brandt advertise for a particular manufacturer's product unless there are certain patents.

Mr. Hurley requested the Police & Public Safety Committee, Mayor Benson and Borough Manager to draw up specifications and submit them to Council at the next meeting, October 9th.

FIRE & WATER COMMITTEE - Mr. Jones, Chairman, No report.

PUBLIC RELATIONS COMMITTEE - Mr. Richey, Chairman, referrs to the Borough Manager's Report on a Guard Rail to be installed and asks if this could be misconstrued to being done for certain properties. Mr. Winner says it is for the benefit of many people. Mr. Richey says there was never a 12 foot drop at this particular property and there is a question of whether we are spending money for a hazard that was never there before. (This is in reference to intersection of Frankfort and Richland Avenues.)

Mr. Brandt, in RE: this matter, advised we have a duty to protect the people and also, we cannot prevent a man from excavating his own ground for improvement.

Mr. Duncan asked if we are sure the excavation is not on Borough property.

Mr. Winner advised the street was on private property and it is only proposed to put the guard rail at the intersection of Richland and Frankfort Avenues around the corner.

Mr. Winner suggested to the owner that he dedicate that portion to the Borough of West View, the same as the sewer on Magnolia Avenue.

RECREATION COMMITTEE - Mr. Freese, Mr. Cully and Mr. Winner met with five of the Ross Township Commissioners and Members of the School Board. There was some talk of swimming pool, etc. Under this program, for every dollar the Borough and Township would spend, the State would pay 42¢ if we had a qualified director. There is to be another meeting in October, the third Monday, and each month thereafter, to discuss whether we will join Ross Township and the School Board.

Audience

Mr. Horace G. Archer, Stanford Avenue, opposed the amending of the Zoning Ordinance to rule out multiple dwellings in Residential areas. Mr. Weston, Wunderly-Weston Agency, also voiced his protest. Mr. Kissner, Oakwood Avenue, favors the amendment. Mr. Ganz, Hempstead Avenue, who has a problem with parking his car off-street, feels he and Mr. Winner can come to some agreement as we where to locate the parking area on Mr. Ganz' property.

Solicitor - Mr. Brandt, spoke as a citizen of the Borough rather than Solicitor, and called attention to the necessity of controlling these mutiple dwellings from the viewpoint of both the parking problems, healthy, etc. and to prevent West View from becoming a "Congested" Area.

Unfinished Business

Mr. Brandt recommends to Council that a special committee be appointed to go over the Zoning Ordinance in its entirety, study it with the idea of coming up with a comprehensive plan. The Ordinance and all of its amendments should be studied.

He suggests that what must be done is to so restrict our land to keep out the speculators who have no interest in the Borough to maintain its integrity, but looking forward only to the income that might be realized.

Mr. Hurley thought Mr. Brandt's remarks very good and suggests that each Member of Council study the ordinance and appointed a Committee Mr. Richey, Mr. Cully, Mr. Duncan and Mr. Freese, to make a special study of the matter.

Mr. Brandt suggests a public announcement of this through the local papers, and that there may be people in the Borough who would be willing to give of their time and suggestions in the matter.

Mr. Hurley said the Committee is appointed and the mathod they feel best and that if they feel that hearings are necessary, that is up to them. He suggests possibly a meeting of this Committee could be held within the next week or so, and the Committee come up with suggestions at the next meeting of Council.

Motion by Mr. Cully, seconded by Mr. Richey, that Ordinance #1058 be tabled until the report of the Committee is received. Carried and so ordered.

Reports of the Mayor, Treasurer, Controller - no report, Chief of Police, Fire Chief, Borough Electrician, Secretary and Manager. The Manager added to his report verbally the following: Wunderly-Weston will dedicate a portion of five lots at Frankfort and Richland Avenues for street purposes and the sewer to the Borough so that we will have authority to get into the sewer to make repairs if necessary. Agreements are to be prepared. The Kurtz, Clairmont Avenue, has agreed to all of the conditions imposed upon him if he opens Sciota Alley, and the Solicitor is requested to prepare the agreement. The alley is not to become a portion of the Borough's Highway System. Mr. Kurtz proposes to open the alley for a distance of 155 feet.

There was some damage done to the Ridgewood Bridge, but it was very minor and we have settled with the Insurance Company for \$24.00. It will require a small amount of material and about four hours labor to correct the damage.

We have also settled for damages in amount of \$150.00 caused by a car running into a pole.

We have a petition signed by nine people on Center Avenue and Mt. Vernon not to plow snow on sidewalks, but some places where cars are parked and we cannot get in, we will do the best we can.

One complaint received about the Christmas Lights at Center and Cornell Avenues because we did not put lights in front of Frank's Market. We will keep this in mind next year.

We have an inquiry about a permit to build a ranch type house on the Kenny lot, facing Bellevue Avenue.

Mr. Brandt advised Miss Kenny, who was in the audience, that before a house can be built facing on Bellevue Avenue, it will be necessary for her to submit the plan of the proposed division of the lot to the Planning Board for approval, advising the Borough when she has done this. It is necessary because the Borough Ordinance provides

that a house must be erected facing the street on which the lot faces in this instance, the lot faces Highland Avenue.

The Solicitor deferrs his report until later in this meeting.

Committee Reports FINANCE COMMITTEE - Mr. Duncan, Chairman, advises there is interest due on Bond Issue #24, January 1st.

Motion by Mr. Duncan, seconded by Mr. Jones, that \$1500 be transferred bo the Sinking Fund for payment of interest on B.I. #24. Carried and so ordered.

Also Mr. Duncan recommends the payment of the balance of \$3,000.00 on the \$15,000 note be paid in this year's business.

This was agreeable to the other Members of Council.

PROPERTY AND PURCHASE COMMITTEE - Mr. Cully, Chairman, reports the two new Police Cars have been ordered at a total cost of \$1,560.00 to be delivered during this month.

PUBLIC WORKS COMMITTEE - Mr. Freese, Chairman, says Mr. Winner and the Public Works Men are to be complimented on the snow and ice control.

POLICE AND PUBLIC SAFETY COMMITTEE - Mr. Love, Chairman, read a letter from Chief Clogan asking that parking be prohibited on the one side of Homekort Avenue, and that the Pittsburgh National Bank be requested to remove the posts which are protecting the standard of the Night Depository.

Mr. Love also read the following letter:

Dear Sir:

Rising costs, coupled with the desire to maintain a dignified standard of living, prompt us to request the following: a \$300.00 per year increase in pay for each member of the Police Force.

Also, we ask consideration of:

- a. police officers' hospitalization paid in full by the Borough of West View.
- b. accumulation of sick leave to continue beyond the 5 year period of 12 days per year
- c. 3 weeks vacation after 5 years of service
- d. extra paid holidays: Easter Sunday and Veterans Day
- e. \$25.00 additional uniform allowance
