Motion by Mr. Duncan, seconded by Mr. Cully that the action in renewing the policy with H. W. Schmitt for coverage of the contents in the municipal building and the payment of the premium in amount of \$286.00 be approved.

Mr. Duncan called attention to the 1963 Budget to be prepared, and a meeting is to be held Tuesday, January 15, 1963, to discuss the 1963 Budget.

PROPERTY & PURCHASE COMMITTEE - Mr. Cully, Chairman, asked about the delivery of the new Police Cars. Mr. Winner advised they are to be in on Thursday of the present week. No other report.

PUBLIC WORKS COMMITTEE - Mr. Freese, Chairman, read a letter received from the Employees of the Public Works Department who asked that if raises and benefits were granted to other Departments, would consideration be given to them. Mr. Freese complimented them on this letter citing the fact it did not contain any "demands", just"consideration." The letter will receive consideration at the Budget Meeting. Mr. Freese requested authorization for a new Jeep Pick-up in as much as the 1957 Jeep is in bad condition and expensive to maintain. Motion by Mr. Freese, seconded by Mr. Duncan, that Council advertise for bids for a 4-Wheel Pickup truck, specifications to be prepared by the Borough Manager, bids to be opened at the meeting on February 12, 1963.

FIRE & WATER COMMITTEE - Mr. Jones Chairman, advises the Firemen would like to meet with Council.

The meeting is to be held at 7:00 o'clock, January 15, just prior to the Budget Meeting.

PUBLIC RELATIONS COMMITTEE - Mr. Richey, Chairman, nothing to report. In RE: Recreation, Mr. Richey suggests the Recreation Board recognize the cooperation of some of the young people of the Borough for their interest in protecting the Recreation Field Ice Skating area. This cooperation surely helps.

The news reporter in the audience was asked to recognize this in his paper - the News  $R_ecord$ .

Mr. Pedone asked about the Kenny Property sub-division and the following letter was dictated by Carl Brandt; "The Allegheny County Planning Commission, Pittsburgh 19, Pennsylvania.

Gentlemen:

The Town Council of The Borough of West View has received the proposed plan of the sub-division of the Kenny property at the corner of Highland and Bellevue Avenues, dividing lots Nos. 41 and 42 in the Fridolin Schwitter Plan of West View into two lots, one 72:15 feet facing on the westerly line of Bellevue Avenue, and the other having a frontage of 140 feet facing on the northerly side of Highland Avenue. The changes recommended by the Planning Commission are acceptable to the Borough and it will approve the sub-division with the recommended changes.

However, the Borough would recommend to the Planning Commission that it consider the sub-division of the frontage of 140 feet, having a residence thereon known as #146 Highland Avenue, into two lots, on having a frontage of 85 feet, being the lot upon which a residence is erected, and the other a frontage of 55 feet and a depth of 111 feet, so that the owner could ultimately sell two lots and cause residences to be erected on each of the two lots and still maintain a side line set-back of five feet next to the westerly wall of her residence. The third lot in this sub-division gives a lot area equal to or larger than the average size in the Borough of West View.

The Committee, with Mr. Hurley, rode around in the first car delivered during a heavy rain and the windshield wiper did not work, but it was repaired immediately. The cars are now in good shape.

PUBLIC WORKS COMMITTEE - Mr. Freese, Chairman, wanted to report that the Public Works men and Mr. Winner got out today about 4:30 to 5:00 A M and the streets were in fine shape. Mr. Hurley commented on the fine, quick job done by the Public Works and said that seems to be generally the case, they are doing a fine job.

POLICE & PUBLIC SAFETY COMMITTEE - Mr. Love, Chairman, unavoidably absent. Mr. Richey, a Member of the Committee, reported the Committee, along with other Councilmen, attended the F. O. P. Meeting and met some of the Officers. He talked with some of our Police and they were asking questions about the Pension Fund. Several are not familiar with the plan. Mr. Mockenhaupt's report is due February 15 and we will

meet with the Police about the Plan.

Mr. Hurley advised he had heard from a young man in the Borough, who has used a "Gyro Skid Bar", which is supposed to be of advantage to a light car to prevent skidding.

This Bar will be investigated to see the merit of installing on the Police Cars.

FIRE & WATER COMMITTEE - Mr. Jones, Chairman, reports the Fire & Water Committee met with the Firemen about a new fire truck. The truck will cost \$25,000. Mr. Jones has the specifications and pictures of the truck. A Committee of Firemen went to Ohio to look the trucks over. Officers' Reports Motion by Mr. Freese, seconded by Mr. Love, that the reports of the following officers be received and filed: Mayor Benson, Treasurer, Chief of Police, Chief of Fire, Secretary, and Manager. Mr.Kane deferrs Solicitor's report until later in the meeting. Motion carried and so ordered.

Mr. Winner added to his report the following:

John Dreves, 81 Brightwood Avenue, requests that he be permitted to erect a garage on a lot and it will necessitate extending the alley down to the lot for a distance of approximately 60 feet. Mr. Winner would, like to have the Members of the Public Works Committee inspect this project, along with some of the other streets which will require attention this year, to determine what amount of work is to be done.

He also requests the Committee to look at Seventh Alley where there is a drainage problem which can be corrected by grading about a foot off of the hump in the center of the road and this would not disturb either side of the alley.

On March 2, there was an accident at North Park and Perrysville Ave. and they broke a sign. We have settled the claim with the insurance company for a new sign, and they have paid, so that matter is settled. Mr.Winner advises he contacted Mrs.Zinkel, Corner Wellington Drive and Highland Avenue, about grading the terrace in front of her home to permit better visibility for motorists coming from Wellington Drive. She claims the trouble is not at that point but rather it is caused by cars coming over the brow of the hill of Highland Avenue. However, she will get a contractor to look at the property and will call Mr. Winner to determine what can be done to correct the problem.

J. R. Love, Chairman Police & Public Safety, West View, Pennsylvania

Dear Mr.Love:

Under the emergency powers of the Mayor, parking of automobiles on the westerly side of Lakewood Avenue from Chalfonte Avenue to Waverly Avenue, was prohibited from January 1, to March 1, 1963. This regulation has proven to be successful.

Therefore, I would like to recommend that the regulation become a permanent ruling and that the Traffic Ordinance be amended accordingly. This will be particularly helpful during the summer season at West View Park.

During the trial period, only one complaint was registered.

Mr. Love presented the following letter to Council: "February 28, 1963. The Mayor and Police & Public Safety Committee, Borough of West View, West View, Pittsburgh 29, Pa. Gentlemen:

During the heavy snows of February, we found a large number of automobiles parked on both sides of North Park Road which made it difficult for our snow plows to clean the street. In several locations, machines were parked opposite each other on both sides of the street, thus reducing the travelled cartway and making it doubtful if a fire truck could get through in case of emergencies.

I would recommend that consideration be given to permit parking on one side of the street only throughout the entire length of North Park Road.

The request to limit parking to one side of Lakewood Avenue from Chalfonte Avenue to Waverly will be referred to the Solicitor to prepare the proper ordinance.

The matter of limiting parking to one side of North Park Road is to be held in abeyance until a study is made to determine which side of the street is to be affected, by the Mayor, Mr. Richey, the Manager and Chief Clogan.

The following letter is read to Council by Mr. Love: "March 12, 1963.

As you requested, I made a survey of the Officers of the Police Department, to determine if they wanted to change from "Black Leather Jackets" to the "Blue Nylon Jackets" the results were as follows:

Mr. Love explained that Council was under the impression the Police wanted to make a change in uniform jackets and that is why it was brought before Council, and a motion adopted to authorize the change. After discussion, Mr. Richey withdraws his motion to authorize the change and Mr. Duncan withdraws his second to the motion.

Posts at PNB Mr. Winner will call the Pittsburgh National Bank again regarding the moving of the Posts and Depository in front of the bank.

FIRE AND WATER COMMITTEE - Mr. Jones, Chairman, attended the last Department Meeting and advised that Chief Farley said the Fire Department had received more from this Council than any Council for the last five years.

PUBLIC RELATIONS COMMITTEE - Mr. Richey, Chairman, attended a program at the West View Methodist Church that was especially for the Youth. This program was put on by the West View Volunteer Fire Department and was really worth seeing. It showed pictures of various schools and one in particular, where there was a fire, showed the use of a Canvas Chute to help get the children out of the building. Mr. Richey recommends that Council should purchase such a chute to have in case it would be needed, but hopes it never will be used. Mr. Winner is to investigate the above, as to where they may be purchased, etc.

Mr. Richey called attention to items that were printed in newspapers having circulation in the Borough incorrectly. One was the report that the including of Park Police in the Pension Fund is being considered and the other that the Borough is considering a swimming pool. These items were not mentioned at a Council Meeting, and Mr. Hurley suggests the reporters, before printing items they are not sure of, contact the various Councilmen and get the correct information.

Mr. Love reports he contacted three school buslines who operate in

the Borough and that two of them do not have FUC franchise to go to North Park. The third busline, operated by Sanford Transportation Company can go to North Park and have made an offer of \$25.00 per day. (This is the busline that serves the Catholic School.) Mr. Love advised them there may be days when they would have to make two trips, but they advised that would be included in the \$25.00 Mr.Love advises that now, if Council so desires, we can start working out the mechanics of the program. He suggests that one of the School Guards be employed as a chaperon on the bus to supervise the trip. Also, the Secretary is to inquire of the Insurance Carrier about coverage. NOTE (Upon inquiry, I am advised by Mr. Wunderly that the General Liability Policy will cover the above project at no additional cost.)

Audience -

Mr. Frank Fehl, 258 Park Avenue, thanked the Police for their help recently when there was an emergency in his family. (The child was taken to the hospital by the Police). Mr Fehl said this help may have saved the life of his child. He also thanks Council and the Police for correcting the traffic problem at Park and Center Avenues and Park and Perrysville Aves.

A few months ago, Herbert L. Costolo came into our office to pay his 1962 School and Boro taxes. He claimed he never received a statement. In checking over the records, it was discovered that D. N. Murrell had paid all the taxes for the properties located at Columbia Avenue. This was due to the fact that D. N. Murrell had purchased a lot from Mr. Costolo, and should have paid only the taxes on the lot. Instead, he paid taxes on both the lot that he purchased and on Mr. Costolo's property. The taxes were never itemized to this effect. This has not been done and all payments have been received from Mr. Costolo.

Mr. President & Members of West View Council, Gentlemen:

As having been your Health Officer for the past 36 years, starting April 27th, 1927, the sorrow day our Police Chief W. A. Quigley met his death on a Motor Cycle, when I took over the Health position. I have every year been certified by the State Health Department making a report to the State & County Health Dept. every 7 days of each week. Also have taken care of all Health matters such as Communicable Diseases, Quarantines, Sewer & Septic tanks, Store inspections, Beer Parlors, Pharmacy's & Stores selling Ice Cream by the cone or plate.

Complaints from citizens pertaining to Health matters, Rats, Garbage & Dog excretion calls, etc. All were taken care of without prosecution. Stores such as listed above were all inspected & a license issued for a fee of \$1.00 which I turned over to the borough every year. Never had an epidemic of any kind in the borough during the past 36 yrs. I have rendered honest & faithful service to the borough.

As of April 1st, 1963, I tender my resignation to the Borough Council. Copy of this letter will be turned over to the Board of Health at the next meeting, March 26th, 1963.

It had been understood that we have some proof that the organizations using the Field are carrying insurance on their teams, especially if they are coming from outside the Borough. Mr. Richey does not think the taxpayers of West View should pick up the tab for incidents unless it be proven that such incidents were caused by negligence on the part of the Borough. None of these accidents have been a result of that condition. Mayor Benson advised that the Y. M. C. A. sponsors the Monday evening games and will give the Borough a Certificate of Insurance. Mr. Freese advises the Little League Players are covered and Mr. Winner thinks the St. Athanasius Team will cooperate in this matter.

After discussion, Mr. Richey suggests Council go along this year rather than to discourage the use of the Field.

# THE BOROUGH OF WEST VIEW Zoning Hearing Obermeier Property Perry Highway

Notes taken at hearing in RE: application from Mrs. Eleanor Obermeier, to re-zone her property located at 5340 Perrysville Avenue from Residential "B" to "Commercial C".

Mr. Winner read the notice of this Hearing which was given to the Public by posting the property and advertising in the Official Paper of the Borough, The Allegheny Journal. This notice contained the time and place for the hearing.

Mrs. Obermeier advised Council she would like to sell the property and if it were to be zoned commercial, she could receive a better price.

She was asked what type of enterprise would be erected on the site if the property were to be sold and she did not know.

Mr. Richey, her Real Estate Representative, said it would be a very good location for a gasoline service station.

Mr. Tarolli, a resident in the Plan adjacent to this site, advised Council that when he purchased his home, it was for the peace and quietness of a residential district (this is in Ross Township), but he objects to certain types of businesses being located in the vicinity.

Mr. Cully said that due to the closeness of the property to Ross Township, how they would feel about a commercial enterprise in that section.

Mr. Richey (Real Estate Representative) said Ross Township has permitted the building of the Metropolitan Insurance Company on Perry Highway at Winter Avenue.

Mr. Tarolli or Council would not object to rezoning for a building of that type or for a building to house Doctors' Offices. However, a service station would be considered objectionable.

Mr. Love expressed sympathy for Mrs. Obermeier but asked if it would be proper to postpone a decision on the question of rezoning and if the owner gets an offer and it is the kind of business we would want in that location, Council will probably agree to rezone it to commercial, rather than to kill the decision at this time.

Mr. Richey (Real Estate Representative) said it would be easier to get a buyer if it were zomer "Commercial". He advised there are a number of Gasoline Companies awaiting the decision of Council.

Mrs. Obermeier called to Council's attention she spent Fifty Dollars to have this matter brought before Council thinking she would get a favorable decision. Mr.Duncan explained this fifty dollars was not a profit to the Borough but was to cover costs of advertising, etc. After discussion, Mr. Brandt advised that perhaps what Council ought to do, in view of the fact that Mrs. Obermeier nor Mr. Richey have not specified a particular use for the property excepting as a possible gas station, etc., is to refer this matter back to the Borough Manager to get in touch with the Manager of Ross Township to determine if they can come up with a plan, taking into consideration all of the uses to which this property could be used. It should also be taken into consideration the fact that Mr. Tarolla is objecting to certain types of business.

Mr. Duncan would like Mrs. Obermeier to leave this meeting tonight feeling that if can come up with a buyer who proposes a business enterprise that would be attractive, this Council will go along with it but will oppose it being sold for a gasoline station.

Mr. Cully asked if it is fair to the neighboring township that we rezone the property without giving them a chance to say something about it.

Motion by Mr. Freese, seconded by Mr. Love, that the recommendation of Mr. Brandt be accepted and also that Mr. Tarolli and Mrs. Obermeier be consulted in the matter. Carried and so ordered.

THE PITTSBURGHALLEGHENY COUNTY CHAPTER, AMERICAN RED CROSS. Recognizing the fine cooperation which has existed between the officials of The Borough of West View and those of the American Red Cross, and the need for preparedness to meet any major disaster emergency, it is believed that an agreement between the borough and the Red Cross will clarify the responsibility of each and is a method effecting the best possible coordination in the event of a major natural disaster. It is understood that the Borough of West View, through its various departments, will direct all efforts to the protection of life, property, and public health, the maintenance of law and order, and, to the extent of equipment available, to the clearance of debris, and the repair of streets and public buildings. When necessary, borough officials will issue warnings, and designate hazard zones. Officials of the borough will also be responsible for organizing and coordinating rescue activities and enforce evacuation from threatened areas. Officers' Reports Motion by Mr.Jones, seconded by Mr. Duncan, that the reports of the Mayor, Treasurer, Controller (no report), Chief of Police, Fire Chief, Secretary and Manager be received and filed.

Carried and so ordered.

Mr. Winner, Borough Manager, added the following to his report verbally: There is a drainage problem at Yale and Kenyon Avenues. In an effort to correct the condition, Mr. Winner proposes to put in some fill where the puddle is located, and then install another pipe as the one there now is filled. There are two ordinances on the grade of Brightwood Avenue, one dated September 3, 1908, showing a proposed grade of 11.6 from Linden to Fenton Avenues. One is dated October, 1928, but shows only the grade as far as Linden Avenue, so that the grade of 11.6 will remain. The Engineer has pointed out that to bring the grade down to 11.6 in front of the Cipka house it would mean a cut of  $21\frac{1}{2}$  feet, some places 18 ft., and this is not practical. Mr. Winner recommends the grade remain as it is now for the present.

Mr. Tresky wants to install a sidewalk and we can show him where to install it and keep it to the present grade of the street.

Committee Reports FINANCE COMMITTEE - Mr. Duncan, Chairman, reports that in comparing the finances this year with the same period last year, we are short about six thousand dollars, but this may be only temporary. Wage Tax collections have been exceedingly light which usually is in the ninth months. We are looking forward to bigger collections in October. Mr. Duncan recommends tightening up on spending and if we do so, by the end of the year, the balance should be about the same as last year.

PROPERTY & PURCHASE COMMITTEE - Mr. Cully, Chairman, called attention that the Municipal Building has been painted and everyone agrees it is a nice job. The lower part is more colorful than before while the top is not quite so bright, but if lighter, it would fade.

PUBLIC WORKS COMMITTEE - Mr. Freese, Chairman, reports that Ronald George, an employe of the Public Works, has resigned but Mr. Winner has an applicant in mind for the job.

POLICE & PUBLIC SAFETY COMMITTEE - Mr. Love, Chairman, read a letter from the Chief of Police calling attention to the deplorable condition of the Building at the Bronx Avenue Recreation Field, caused by vandalism, and that the Borough has been put to great expense trying to keep it in repair. Mr. Clogan recommends the building be razed. Mr.Love and Mr. Hurley agree, but Mr. Duncan and Mr. Richey favor retaining it.
