FIRST: That E.M.Hurley, President and Fern Herchenroether, Secretary of the Town Council of the Borough of WestView, be and they are hereby authorized and empowered to borrow from time to time, as needed, from the Pittsburgh National Bank, West View Branch, sum or sums of money not exceeding in the aggregate One Hundred Thousand (\$100,000.00) Dollars, for the purpose of meeting ordinary and/or current running expenses of the Borough for the year 1967, such loan or loans to bear interest at the rate of three and one-quarter (3-1/4%) percent.

SECOND: That the President and Secretary of the Town Council of the Borough of West View be and they are hereby authorized and empowered to execute such notes, certificates of indebtedness or other obligations under the seal of West View Borough to evidence the said loan or loans, and to certify to Pittsburgh National Bank such information relating to the indebtedness of the Borough, as may be requested.

RESOLUTION NO. 848

WHEREAS, the Pennsylvania Borough Code provides inter alia:

The council of the borough shall have power:

(1) "To create, by motion, ordinance or resolution, and appoint a treasurer, a secretary, a solicitor, an engineer, a street commissioner and such other officers as it deems necessary. The treasurer and the secretary shall not be members of council. A bank or bank and trust company may be appointed as treasurer. All officers and employes appointed by the council, with the exception of those who under the provisions of this, or any other act are under civil service or have a definite term of office, shall serve for an indefinite term at the pleasure of the council."

AND WHEREAS, the Town Council has been unable to secure for a period of two years the services of a Borough Manager possessing the required qualifications at a salary that the Borough can afford to pay;

AND WHEREAS, the elected members of the Town Council are either self-employed or employed by others so that the majority of their working time is devoted to their several vocations;

AND WHEREAS, the elected members of the Town Council are either self-employed or employed by others so that the majority of their working time is devoted to their several vocations;

AND WHEREAS, the Borough is in need of the services of a person who is mentally and physically capable of supervising, maintaining, and repairing its streets, alleys, playgrounds and other public works on a full-time basis to assure the residents of the Borough;

AND WHEREAS, the Borough desires to create the office of "Street commissioner" in accordance with the Pennsylvania Borough Code of 1966 and to define the duties and responsibilities thereof.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE BOROUGH OF WEST VIEW, IN REGULAR SESSION ASSEMBLED, AND IT IS HEREBY RESOLVED BY AND WITH THE AUTHORITY OF THE SAME:

FIRST: That effective as of the date of the adoption of this resolution the Town Council does hereby ordain and establish the office of "street commissioner".

SECOND: That the duties of the "street commissioner" shall be to supervise, maintain and repair all of its streets, alleys, playgrounds, sewers, municipal buildings and other public works.

- B. To prepare, maintain and keep a chronological record of all complaints and requests for municipal services.
- C. To prepare and submit to representatives of council monthly a report of such communications and the disposition with respect as to such request and/or complaints.
- D. To prepare each six months, i.e. on or before February 1 and August 1, a written report of the proper improvements contemplated to be made during such period.
- E. To supervise, control, manage, direct, employ and dismiss all of the public works employes of the Borough with the approval of council.

THIRD: The monthly compensation to the Street Commissioner shall be fixed by the then councilmen from time to time. The term of the employment of a street commissioner shall be at the pleasure of the members of the Town Council.

FOURTH: That all resolutions or parts of resolutions inconsistent with the terms hereof, be and the same are hereby repealed, insofar as the same affect this resolution.

Committee Reports FINANCE COMMITTEE - Mr.Duncan, Chairman. Insurance on the fire equipment is due to be renewed. Motion by Mr.Powell, seconded by Mr.Freese that we insure this equipment with Mr.Robert Derr for a total amount of \$91,500.00 at a premium of \$1,11.75. The Borough will advertise for bids on the insurance for the buildings and equipment, as well as liability insurance, with bids to be opened at the March 14,1967 meeting.

> PROPERTY & PURCHASE COMMITTEE - Mr. Drummond, Chairman - gave a detailed report of complaints and matters which he has handled. The plastic rink liner didn't work - not practical anywhere. With regard to the dumping on North Park Rd., Mr. Drummond feels we need a good sound reason to stop him. All Mr. Drummond can do now is reason with him, until an Ordinance can be passed.

Old Fire Engine

Mr. Brandt believes we can scrap the old fire engine. Will give Mr. Drummond a definite answer after he has checked.

Cross-overs With regard to cross-overs at Columbia and Harvard Aves.,Mrs.Brandt Columbia and feels we can safely remove the tracks and take care of the street Harvard He suggests we take a picture of each spot before the tracks are removed.

Car-wash It was suggested that we have Atlantic Service Station take Police care of the washing of the police cars at a cost of \$104.00 for a year's service. An agreement will be arranged.

Field House Bronx Field It was suggested we remove the Field House at Bronx Field. This will be referred to the Recreation Committee to bring up at the next meeting of Council.

PUBLIC WORKS COMMITTEE - Mr.Freese, Chairman - complimented Mr. Drummond on the work he is doing. Mr.Freese will go over the streets and alleys for work to be done and present them to Council.

POLICE & PUBLIC SAFETY COMMITTEE - Mr. Richey, Chairman - no report.

FIRE & WATER COMMITTEE - Mr.Powell, Chairman. Fire Dept. has received three air masks and the 500' of hose which they need will be ordered later. Mr.Powell inquired about the emergency power plant and was informed that it is okay and ready to use. It is turned over at least once a week by a Borough public works employee.

Mr. Hauck of Ashford Ave. asked Mr. Powell about the wall he wants built. This will be taken care of when the men have the time.

PUBLIC RELATIONS COMMITTEE - Mr.Setler, Chairman inquired about West View's decision with regard to the Library. The Council feels their sentiments are for it, but financially we cannot make any committments. We are just not able to handle it.

RECREATION COMMITTEE - Mr.Richey, Chairman - No report.

Mr.Grafton Duvall of Ashford Ave. representing the American Legion extended an invitation to Council to attend a dinner at the Wexford Post American Legion Home on April 1st. Anyone interested contact Mr.Duvall. Chief Clogan and his wife will be their guests.

Gerber, Cappy Mrs.Florence Gerber, 600 Perry Hwy. was present to complain about the vandalism to her property at Princeton and Center Avenues. She wants protection. Mayor Love informed Mrs. Cappy that arrangements will be made to try to clean out the corner.





Mr.Wunderly stated that the property immediately following the last house in West View Borough now belongs to Frank Heintz, and he feels quite certain that Mr. Heintz will eventually make this commercial.

Request has been granted for a Public Hearing to be held Tuesday evening, November 12,1967 at 7:30 P.M. This will be advertised and posted.

Mr.Wunderly thanked the gentlemen of Council for coming out and listening to Mr. Kennedy and himself.

Mr. Setler - Same sentiments - in favor of rezoning.


Mr. Powell - Yes
