Minutes of Special Meeting, Dec. 19, 1969. Motion by Mr. Derda, seconded by Mr. Drummond that the minutes of a Special Meeting of December 19, 1969 be approved. Carried and so ordered.

Bills & Payroll

Motion by Mr. Drummond, seconded by Mr. Derda, that the bills in amount \$9746.53 and payroll in amount \$17,082.27 be approved. Carried and so ordered.

Officers Reports

Mayor Powell read a letter from the resident at 106 Amherst Ave. (Ross Twp.) complimenting the Borough for the manner in which streets are cleared of snow.

Book Mobile Service

Mayor has been in contact with the commissioners, relative to securing a Book Mobile for West View. As of now, there is not one available for West View, but they will continue their efforts in attempting to secure one for the Borough.

Expense of repair of High Lift,

Mr. Daugherty questioned the expense of repairing the Hi-Lift. Mr. Drummond informed him that this was absolutely necessary, as this is an important piece of our equipment. However, it is an old Hi-Dift and Council will keep it in mind for next year's budget.

Solicitor defers.

Motion by Mr. Orleman, seconded by Mr. Gruener, that the reports of the following officers be received and filed: Mayor, Treasurer, Secretary, Chief of Police and Street Commissioner. Carried and so ordered.

Committee Reports

FINANCE - Mr.Orleman, Chairman - Motion by Mr.Orleman, seconded by Mr.Gmiter, that the insurance premium on the four fire trucks be paid in amount \$367.83 for a three year period.

PROPERTY & PURCHASE - Mr. Drummond, Chairman - Nothing to report, other than we are purchasing a lot of salt.

PUBLIC WORKS - Mr. Daugherty, Chairman - No report

Advertise for Police Car

POLICE & PUBIC SAFETY - Mr.Derda, Chairman - Police have requested that we advertise for a new police car.

Mr. Daugherty brought up the question of purchasing a Station Wagon to be used as an ambulance.

This was turned over to the Police & Public Safety Committee to confer with the Police and the Mayor, and to come up with a recommendation on what type of police car they would like to have.

PUBLIC RELATIONS - Mr. Gmiter, Chairman - No report, but would appreciate help from the former Committee Chairman as to what his duties are, as to attending meetings, etc.

Skating-Bronx Field

Mr. Drummond received a petition from a group of youngsters to flood Bronx Field for ice skating. Mr. Drummond explained to Council what this involves, and all realized what an impractical idea it is.

It was suggested that the matter be brought to the attention of the combined Ross-West View Recreation Committee at their next meeting.

The combined Recreation Committee was discussed at length, with the final solution that West View Councit sit back and wait tuntil we see how this develops. Do not pursue it, other than to attend meetings and listen.

Remarks from audience Frank Calore - Barber Mr. Calore (Franks Barber Shop), Mr. Perugini(Patty Ann Dress Shop) and Mr. Kasunic (Meat Market) were in the audience to complain about the parking situation.

The Police Department will be instructed to enforce the two-hour parking limit, and Council will get in

touch with the Municipal Authority about their plans relative to providing parking where the old Gasoline Station now stands on Perry Highway.

Council will most certainly do what they can to help.

Tony Ruffalo 228 Cornell Ave. Mr. Ruffalo inquired once more about progress on the Cornell Ave. bridge. Mr. Drummond answered his questions as best he eould.

Mr. Ruffalo also inquired about rubbish collection. Would like to know what the rubbish coilector considers to be building material, and what isn't. He was instructed to contact Mr.Drummond when he has a question, and in the meantime Council will endeavor to find out from Mr. McKee what his reasoning is on this.

Section 1. That a tax be and the same is hereby levied on all property within the said Borough subject to taxation for Borough purposes for the fiscal year of 1970, as follows:

TAX RATE FOR BOROUGH PURPOSES - 16 mills on each dollar of assessed valuation.

AN ORDINANCE PROVIDING FOR THE PAYMENT OF SALARIESOF THE VARIOUS OFFICERS AND EMPLOYEES OF THE BOROUGH OF WEST VIEW; FIXING THE AMOUNTS OF SAID SALARIES AND WAGES; FIXING the HOURS OF WORK OF THE OFFICERS AND "EMPLOYEES; AND MAKING ALL SALARIES, AND WAGES RETROACTIVE TO JANUARY J. 1970, AND REPEALING INCONSISTENT ORDINANCES."

WEST VIEW, IN REGULAR SESSION ASSEMBLED, AND THE STREET ORDAINED AND THE BOROUGH OF AND WITH THE AUTHORITY OF THE SAME:

SECTION 1, That from and after January 1, 1970, the annual salaries and wages and the monthly working hours of the following officers and employees appointed either by the Town Council or employed by the Street Commissioner or the Borough Secretary, shall be as follows:

Public Works Department and Administration Department receive the following paid Holidays: New Years Day, May 30th, July 4th, Labor Day, Veterans Day, Thanksgiving Day and Christmas Day.

School Guards shall be entitled to five (5) days sick leave per year.

Employees in the Public Works and Administration Departments shall be entitled to twelve (12) days sick leave per year with the right to accumulate a maximum of ninety (90) days of such sick leave.

Vacations: One year of continuous employment - two (2) weeks.

Ten years of continuous employment - three (3) weeks.

Twenty years of continuous employment - four (4) weeks.

SECTION 2. All Borough Employees shall be paid semi-conthly.

SECTION 3. That the schedule of working hours and the place and time during which work is to be performed by all full-time salaried employees, excepting Church and School Guards, shall be determined by the Street Commission—er. All full-time salaried employees of the Borough shall serve not less than forty(40) hours for each seven day work week.

SECTION 4. The Solicitor shall attend all meetings, regular and special, give legal opinions, either oral or written, prepare resolutions, ordinances, agreements and contracts; and all other work shall be considered special service for which he shall receive extra compensation.

SECTION 5. The salaries of the Borough Street Commissioner, Secretary, Bookkeeper, Treasurer, Controller and Solicitor shall be provided for and pald from the Administration Appropriation.

The salaries of the Foreman, wages of Equipment Operators and Laborers shall be provided for and paid from the Streets and Bridges Appropriations.

The salaries of the Custodians shall be provided for and paid from the Administration Appropriation.

The salaries of the Church and School Guards shall be provided for and paid from the Protection Appropriation.

The salary of the Borough Electrician shall be provided for and paid from the Protection Appropriation.

The salary of the Secretary of the Board of Health and the Health Officer shall be provided for and paid from the Board of Health Appropriation.

The salary of the Recreation Director shall be provided for and paid from the Recreation Appropriation.

In addition hereto, the Borough shall pay the premium on the Municipal Employers Insurance Trust, which includes Blue Cross, and Blue Shield benefits, Weekly Disability Income and Occidental Life Insurance premiums for all

full-time employees of the Borough.

SECTION 6. The salaries and wages provided for herunder shall be retroactive to January 1, 1970, and be effective as of that date.

SECTION 7. That all ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

In the event the Lessee fails to commence construction of the said apartment building on or before July 1, 1970, in accordance with the terms of this Lease, the earnest money shall be forfeited to the Lessor as liquidated damages and this lease shall become null and void and of no legal effect, and shall constitute a mutual release of the parties hereto, for damages of any nature, kind or character whatsoever arising out of this Lease, including all agreements, oral and written, heretofore entered into between the parties."

Roll Call was answered by the following Members of Council: Messrs. Daugherty, Derda, Drummond, Gmiter, Gruener, Orleman, and Richey. Also present were Mayor R.E.Powell; Solicitor, H.Carl Brandt; Treasurer, A.L.Seethaler and Secretary, Fern Herchenroether. Controller, R.J.Scherer was not present, due to other committments.

Bills

Motion by Mr. Daugherty, seconded by Mr. Gmiter that the bills in amount \$10,107.78 be approved. Carried and so ordered.

Mr. Daugherty questioned the bill on the Hi-Lift. He also inquired as to whether we could purchase a Hi-Lift on a rent-al-purchase deal. This will be looked into.

Officers Reports

Mayor Powell met with the police and they request two walkie talkies as soon as possible. They would also like to drop out of the City Radio ban and go along with Ross Twp.frequency.

Walkle talkies

After a discussion on the price of walkie talkies, this was referred to the Police & Public Safety Committee to check on prices, etc., and report back to Council. There is an amount of \$750.00 in the budget for minor equipment.

Transfer to Ross frequency.

Police & Public Safety Committee are requested to come up with a recommendation on transferring over to Ross frequency.

Police Red Cross Course Motion by Mr. Gmiter, seconded by Mr. Gruener that Chief Farley enroll all police officers in the Red Cross Course to be given at West View Jr. High School. The officers are to be reimbursed at their hourly rate. Carried and so ordered.

Letter was read from National Multiple Sclerosis Society re-

garding their TAG day. Council will be happy to have them conduct their campaign in West View.

#100.00 to Sinking Fund

Motion by Mr. Orieman, seconded by Mr. Daugherty that \$100.00 be transferred to the Sinking Fund to cover March interest on bonds.

Dances - Danceland

Chief Farley was questioned about whether or not we have problems at Danceland every week. Chief answered that approximately 1000 young people attend these dances weekly and we average two or three incidents a week. He was told by the Manager of the Park, that if and when things get out of hand, Chief has permission to demand that the dances be discontinued.

Sait expense

Street Commissioner, Mr. Drummond informed Council that the Borough has spent \$8,000.00 for the purchase of salt up to this time. He also remaked that it is most important and necessary that the fire horn on the old Borough Building be moved as soon as possible before it is destroyed by vandals.


