Minutes of the regular meeting of The Town Council of The Borough of West View held Tuesday evening, January 12, 1971 in The Board Room of The Municipal Authoraty. Meeting called to order after a moment of \$1 ient Prayer and Piedge of Allegiance to the flag at 8:00 P.M. by President of Council, Loyd L. Richey.

Roll Call was answered by the following Members of Council: Messrs. Daugherty, Derda, Drummond, Gruener, Orleman, Gmiter and Richey. Also present were Mayor R.E. Powell; Controller, R.J.Scherer; Treasurer, A.L.Seethaler; and Secretary, Fern Herchenroether. Mr.Leonard Kane sat in for H.Carl Brandt, Solicitor.

Motion by Mr. Derda, seconded by Mr. Gmiter that the minutes of the regular meeting of December 8, 1970 be approved. Carried and so ordered.

Motion by Mr. Daugherty, seconded by Mr. Gmiter that the minutes of the Special Meeting of December 22, 1970 be approved. Mayor Powell's name was omitted from these minutes as having attended the meeting. It will be inserted. Carried and so ordered.

Motion by Mr.Orleman, seconded by Mr. Drummond, that the payroll in amount \$16,636.99 and bills in amount \$10,444.17 be approved for payment. Carried and so ordered.

Mayor reports that the Police Chief has asked for permission to send an officer to the North Park Police Academy for a 14 week course.

Motion by Mr. Gmiter, seconded by Mr.Daugherty, that Officer John Muschick attended the Police Academy in North Park for a period of 14 weeks. Carried and so ordered.

Mr.Thomas J.Foerster, County Commissioner, was introduced at this time. Mr. Foerster attended Council Meeting to present the check to the Borough in amount \$7,583.00 from AIM for street improvement.

Mayor announced that the County Health Dept. will have their Chest X-Ray equipment on the VFW Parking Lot on February 19th from 12:00 noon until 8:00 P.M. for chest x-rays and also anyone willing to donate blood (18 yrs. through 65 yrs.) may do so between the hours of 6:00 PM and 10:00 PM.

Motion by Mr. Derda, seconded by Mr. Orieman that the reports of the following officers be received and filed: Mayor, Treasurer, Secretary, Chief of Police, Fire Chief and Street Commissioner. Carried and so ordered.

Committee Reports - FINANCE - Mr.Orieman - Motion by Mr.Orieman, seconded by Mr.Gmiter, that \$700.00 be transferred from the General Fund to the Sinking Fund for interest on bonds for January. Carried and so ordered.

PROPERTY & PURCHASE - Mr.Drummond - No major purchases other than \$1300.00 for

Mr. Drummond would like Council to advertise for a new roof on #3 Fire Hall. Fire and Water Committee will go over this with the Fire Department members.

PUBLIC WORKS - Mr. Daugherty - thanks the Public Works employees for their work in keeping the streets in good condition over the holidays.

Mr.Daugherty mentioned the empty house on Glenmore Ave. which is in bad shape. This is being looked into by Mr. Drummond.

Since we have had no complaints on the Oakwood Ave. steps being closed, it is safe to assume they can be demolished.

When the weather is permissible, the hump of Glenmore Ave. and Rochester Rd. will be leveled off.

FIRE & WATER - Mr. Gruener - Fire department has received the hose they requested.

Mr.Gruener spoke on the rumor that the Fire Dept. had purchased the Wright building. This was discussed at length and Mr.Gruener will bring back more to Count cil.

PUBLIC RELATIONS - Mr. Gmiter met with the Chamber of Commerce about additional parking. Some of the requests suggested by them were discussed and they will meet again prior to next Council meeting to Iron out some of the problems.

Steve Affolder requests permission to attend the next Planning Commission meet-ing.

Motion by Mr. Derda, seconded by Mr. Drummond that the Committee Reports be approved. Carried and so ordered.

Audience Dorothy Veinegar 206 Carlisle Mr. Richey read the signed petition from residents who live around 204 Carlisle Ave. relative to Tri Rivers Ambulance Service.

Their complaints were that the two ambulances cause a parking problem and that the tower interferes with their television.

They feel that this is a business being operated in a residential area.

Mr.Ittel, attorney for Mr.Richard Dickson spoke for him.

Mr.William Lewis
1112 Success St.

Father-in law of Mr.Dickson spoke in his behalf. He feels it is nothing but a spite thing.

Mr.Ittel doesnot necessarily adopt all of the remarks made by Mr.Lewis. He feels it is strictly a legal decision.

Mr.George Birx 131 Princeton Ave.

Feels the ambulances block the street, and could be parked elsewhere.

Mrs.George Birx

Does not like the effect the sight of the ambulance has

on her elderly mother in law.

Norman Veinegar 206 Carlisle Does not want a second ambulance parked there.

John Koerts 133 Princeton Asked if there isn't a zoning ordinance in the Borough prohibiting the operating of a business in a residentic; area. Also if there is a zoning ordinance referring to towers.

This petition was turned over to our legal Counsel to get together with Mr.Dickson's legal Counsel, and we will have an answer by next Council meeting.

The Borough is going to have to spend some money on this.

Letter was read from Mr.R.J.Krepp, Pres. of West View-Ross Athletic Assoc. requesting permission to use Bronx Field for the 1971 baseball season, everyday except Wednesday. Permission granted.

We had a request for the use of Bronx Field this coming summer from David Jones for Wednesday evenings. Mr. Richey will check to see if this is the YMCA league or another one.

Letter of resignation from Mr.Edward A. VanVlack from the Planning Commission was read.

Letter of resignation from Mr. Edward E. Kennedy from the Planning Commission was read.

Motion by Mr. Drummond, seconded by Mr. Daugherty that these resignations be accepted and letters of thanks expressing the Council's appreciation for their services be sent to Mr. VanVieck and to Mr. Kennedy. Carried and so ordered.

Motion by Mr. Drummond, seconded by Mr. Orleman, that Dr. Robert Love be appointed to the Board of Health for a five year term. Carried and so ordered.

Mr.Gmiter requested that in the future, the Board of Health and the Planning Commission present monthly reports to Council.

Motion by Mr. Daugherty, seconded by Mr. Derda, that Mr.Gary Robinson be paid \$1,000.00 for hauling excess garbage out of the Borough. This will be paid upon presentation of an itemized bill. Carried and so ordered.

Mayor Powell has had word that County Assessors will be in the borough the we of February 1st through 5th to hear appeals from West View residents on their assessments. (this was later changed to Feb. 15th through Feb. 19th). It has been suggested that they use #3 Fire Hall since parking would be more convenient.

When the date has definitely been verified, Chief Farley will have #3 Parking Lot blocked off.

Motion by Mr. Daugherty, seconded by Mr. Gruener that Council re-advertise the Borough property with the wording or general description as suggested by Mr. Fred Turner of Kendree & Shepherd, and approved by our Solicitor.

Carried and so ordered.

Meeting called to order after a moment of Silent Prayer and Pledge of Allegiance to the flag at 8:00 P.M. by President of Council, Loyd L. Richey.

Roll Call was answered by the following Members of Council: Messrs. Daugherty, Derda, Drummond, Gruener, Orleman, Gmiter and Richey. Also present were Mayor R.E. Powell; Treasurer, A.L. Seethaler; and Secretary, Fern Herchenroether. Mr. Scherer, Controller, was not present. Mr. Leonard Kane sat in for H. Carl Brandt, Solicitor.

> Motion by Mr. Derda, seconded by Mr. Daugherty that the minutes of the regular meeting of January 12, 1971 be approved. Carried and so ordered.

Motion by Mr. Drummond, seconded by Mr. Orleman, that the payroll in amount \$18,581.52 and bills in amount \$7.044.12 be approved. Carried and so ordered.

> Mayor Powell remarked that the police would like Council to advertise for a new police car.

Cars are still being driven up over the curb into the shopping center. Mr. Drummond will pursue this further. He will contact the Water Authority about sharing the cost, and also will determine the most feasible method for this curbing.

Treasurer requests \$500.00 be transferred to the Sinking Fund for March interest. Motion by Mr.Orleman, seconded by Mr. Derda that this transfer be made. Carried and so ordered.

Mayor brought up the question of the low band being requested from Ross Township. Mr.Derda answered that he had word that our request had been granted at the Ross Township Commissioners Meeting on Monday evening. He would have a letter from Mr.Miles Caughey verifying this.

Mr.Richey complimented the Public Works Department on the good job they did during the recent snow.

Motion by Mr. Derda, seconded by Mr. Gmiter that the reports of the following officers be received and filed: Mayor, Treasurer, Secretary, Chief of Police, Fire Chief and Street Commissioner. Carried and so ordered.

Committee Reports - FINANCE - Mr.Orleman - Motion by Mr.Orleman, seconded by Mr. Derda, that Council authorize the proper officials to borrow \$40,000,000 from Pittsburgh National Bank to meet expenses. Carried and so ordered.

Mr.Orleman remarked about the funds received from Centre Video in amount \$487,25.

Also suggested that perhaps we should have an Ordinance requiring owners to furnish names to the Borough of their tenants for wage tax purposes.

Mr.Orleman met with a representative Of pennsylvania Municipal Services regarding delinquent sewage. He will come up with some figures before a decision is made on this.

Mr.Drummond reported here that Centre Video will have their local offices in the Versace Building at 96 Rochester Rd.

PROPERTY & PURCHASE - Mr. Drummond - salt - that's all.

PUBLIC WORKS - Mr. Daugherty - Permission is granted by Council to go ahead with the demolition of the Ridgewood Ave. steps. - Public Works men to do the work.

Mr.Daugherty explained the program of the Ecology Club of the North Hills High School whereby they will go door to door informing the residents to take their glass, tin cans and paper to a pick-up point on certain Saturdays. MissBartek who represented the club had asked for the use of Borough trucks and drivers for this purpose. Her request was granted.

POLICE & PUBLIC SAFETY - Mr. Derda - Motion by Mr. Derda, seconded by Mr.Drummond that Council advertise for bids on a four door sedan or a station wagon to be used for police work. Bids to be opened at the next regular Council meeting on March 9th. Carried and so ordered.

FIRE & WATER - Mr. Gruener - Motion by Mr. Gruener, seconded by Mr. Gmiter that Council advertise for bids for a new roof on #3 Fire Hall. Bids to be opened at the next regular meeting of Council on March 9,1971. Carried and so ordere

PUBLIC RELATIONS - Mr.Gmiter - Mr.Affolder, Mr.Foster and Mr.Gmiter met with the Water Authority. Parking has been alleviated somewhat. With regard to the old gas station owned by the Water Authority, they have two trucks parked in the old building. They will have to find a place for them. If and when they do, they will start demolition of the building.

Chamber of Commerce recommends that in the future, if public hearings are to be held, they should be held away from the business section and especially not on a Saturday morning. The business men objected to the public hearing held on January 23rd because of the parking problem.

RECREATION - Mr. Derda - Mr. Derda met with Ross Recreation Committee and told them West View is not financially able to cooperate, but would permit them to use Bronx Field and the Tennis Courts again this year. In turn, Ross will continue to bus West View children to North Pack Pool.

Mr.Richey made several remarks about spending. The Borough will be spending more in February than they take in. There are some things we should keep in mind, and should try within reason, to save any money whatsoever. We should stay away from all new expenditures and should try to hold off on spending of money which we have budgeted, until the end of the year. He asked that all Councilmen keep in mind that whatever it is we are spending, try to keep it do

Audience- Mr.George Birx - 131 Princeton Ave. - asked what has been done about the operating of the ambulance service at 204 Carlisle Ave.

After a discussion back and forth between the interested residents present, Council, and Mr. Kane, Solicitor, it was decided that Mr. Kane will determine whether or not this is a commercial business and will return his decision at next Council meeting.

George Weig! - Carlisle Ave. - just wanted to remark, that because of their decent recreational facilities, Avalon and Bellevue have higher millage than West View.

Motion by Mr. Gmiter, seconded by Mr. Daugherty, that the Solicitor be authorized to contact the former garbage contractor and inform him that he did not complete his contract. Carried and so ordered.

Motion by Mr. Daugherty, seconded by Mr. Gmiter, that the Solicitor be directed to draw up an Ordinance setting up a pension for Mr. Conrad Kratz, retroactive to February 1, 1971. Carried and so ordered.

Letter was read by Mr. Richey from Fred Turner with suggestions for the ad for the Borough property. These changes will be made and the property will be readvertised.

Motion by Mr. Gmiter, seconded by Mr. Gruener that the Solicitor be directed to draw up an Ordinance increasing the West View Park operating license from \$1500.00 to \$2500.00. Carried and so ordered.

Motion by Mr. Gmiter, seconded by Mr. Daugherty that the Solicitor be directed to amend our parking ordinance to increase parking tag fines to \$5.00. Carried and so ordered.

Motion by Mr. Derda, seconded by Mr.Orleman that the bill from Kendree & Shepherd be paid, in amount \$1,050.00, as funds are available. Carried and so ordered.

Motion by Mr. Derda, seconded by Mr. Gruener, that the minutes of the regular meeting of February 9, 1971 be approved. Carried and so ordered.

Motion by Mr.Orleman, seconded by Mr. Drummond, that bills in amount \$9,192.51 and payroll in amount \$18,991.64 be approved. Carried and so ordered.

Mayor Powell reported on a planned Easter Sunrise Service at 6:30 A.M. There was a request to use Bronx Field for this purpose, but there is a possibility this location will be changed.

Mayor Powell read a letter from Al.Lindow, 242 Jamaica Ave. thanking the Police Dept. for their prompt and efficient service when his wife had a heart attack.

Motion by Mr. Drummond, seconded by Mr. Gmiter that the reports of the following officers be received and filed: Mayor, Treasurer, Secretary, Chief of Police, Fire Chief and Street Commissioner. Carried and so ordered.

Committee Reports - FINANCE - Mr.Orleman - Motion by Mr.Orleman, seconded by Mr. Daugherty, that the insurance premium of \$34.00 be paid for the garage and contents on Schwitter Ave. Carried and so ordered.

With regard to the collection of delinquent sewage by Pennsylvania Municipal Service Co., Council has decided to hold off on this until it becomes too much of a problem to collect.

PUBLIC WORKS - Mr. Daugherty - Mr. Mascari has been in touch with Mr.Daugherty regarding Parker Alley. Perhaps Public Works can take care of this short alley. Mr.Daugherty requested that Mr.Drummond get in touch with Mr.Weaver of Russell Industries regarding Township Rd.

POLICE & PUBLIC SAFETY - Mr.Derda - Since last meeting, Mr.Derda has received the letter from Mr.Miles Caughey of Ross Twp. verifying the permission of Ross to use their police radio frequency.

Mr.Orleman brought up the fact that there are gangs of teenagers roaming the Borough and he was informed that we do have a Loitering Ordinance in the Borough and that it can be enforced.

FIRE & WATER COMMITTEE - Mr.Gruener - Presented the Council with a list of equiment needed by the Fire Department in the coming year. Mr.Gruener will get pries on what is required and present the list at next Council meeting.

Motion by Mr. Gruener, seconded by Mr.Gmiter that a bill from Seagrave for repairs to #2 Pumper be approved in amount \$121.70. Carried and so ordered.

Topic of generators was discussed. Mr.Gruener and Fire Chief George will look into the possibility of purchasing a smaller generator to be placed at #1 Fire Hall.

Fire Chief George remarked that the Base Station at #I Fire Hall should be moved to the second floor. Police Chief Farley stated that this has already been reported to Motorola for necessary moving of the piece of equipment.

Specifications will be drawn up and advertised for a new roof on #3 Fire Hall.

PUBLIC RELATIONS - Mr. Gmiter - Made a few remarks about the "Get Together" the Chamber of Commerce sponsored for the business people of the Borough. He felt it was a success and the Chamber of Commerce should be so informed. He will write a letter, commending them.

RECREATION - Mr. Derda - attended a joint recreation meeting and had a copy of the Recreation Agreement. It will be filed in the Borough Office.

Motion by Mr. Derda, seconded by Mr. Daugherty, that reports of the committees be approved. Carried and so ordered.

Audience - John Koerts, 133 Princeton Ave. inquired about progress with Tri Rivers.

Mr.Kane, Solicitor gave the opinion that Tri Rivers Ambulance Service is an enterprise conducting business in his home, thereby violating the Zoning Ordinance, and written notice should be given to him to dispense immediately. (This letter will come from Solicitor Brandt's office) with copy to Mr.Ittel, Attorney for Mr.Dickson.

Tony Ruffalo - 225 Cornell Ave. - feels that if you are going to do this to one guy you should do it to all. Not being fair to the little man.







Mr. Richey at this point also expressed this thanks to Chief Farley and Officer Obermeier, and feels the Police Dept. should be proud of the fact that they were a part of helping to save the life of the child taken to Children's Hospital.

Treasurer A.L. Seethaler reported that all bonds for this year are paid and our bonded indebtedness is now \$84,000.00.

Since the Borough is no longer permitted to use the wiring for christmas lighting as it now is, Council agreed to dispense with the lighting as used in the past. Mr. Hoellerman will check on what can be done. Perhaps several trees in different districts, as suggested by Mr. Gmiter, or pole decorations as suggested by Mr. Daugherty.

At this point Mr.Gmiter inquired about Cable TV and why it hasnot been completed in the Borough. Mr.Richey has been attempting to get in touch with Centre Video with not much success, but after reading the contract, it appears that they have

until May of 1972 to complete their cable in the Borough.

PROPERTY & PURCHASE - Mr. Drummond - Arrangements will be made with Whooz Market to buy ready packed bags of candy for the Hallowe'en Parade. The date for the parade has been set as October 28, 1971 (Thursday) with the rain date November 1, 1971 (Monday).

PUBLIC WORKS - Mr. Daugherty - Still working with the Borough Employees on their 1972 contract.

Mr.Daugherty mentioned that the Borough has received a grant of \$4,000.00 from AIM for repaving of Center Ave.

Mr. Daugherty was a little unhappy with the item in the Allegheny Journal and stated that he had been receiving quite a few calls on it. This is with regard to the condemnation of Center Ave. The item in the Journal stated that Center Ave. would be a four lane highway, whereas all Council has in mind is a two lane highway.

Mr. Nudi, publisher of the Journal, was in the audience and explained that the information came from the County Commissioners that this would be a four lane highway sometime in the future.

Mr. Gmiter had a few words to say about the News Record write up on the two elder ly citizens of the Borough who Mr. Early and Council were trying to help. He for that this was a case of very bad judgment on the part of the News Record and he is violently opposed to this type of reporting, especially since Council asked that this not be published.

Mr.Gmiter will write a letter to the Editor of the News Record and all members of Council will sign it, expressing their disapproval of the item.

RECREATION - Mr. Derda - Discussed the North Hills recreational program and stated that he would get in touch with the proper persons to be judges in the Hallowe'en Parade.

Audience - Mr. George Heil - spoke for the Chamber of Commerce. They would like to voice their protest against changing the Zoning Ordinance in making Center Ave. residential and not commercial as it has been. Mr. Gmiter explained that Council has sat through meetings over the last 15 months and that they have not approved or sanctioned all that has been presented to them. There will be many more sessions before this Master Plan is finalized.

Mr.Richey suggested that perhaps Mr.Heil would like to put his views in the form of a letter and address it to the Planning Commission.

Mr.Scholze - Quaill Fire Co. - Ross Twp.- The firemen have been cleaning up Keny Ave. (an un-opened street) and would like to asphalt it to make more parking space

for them. Mr. Eardley of Highland Ave. voiced his disapproval of this in a letter addressed to Mr. Richey. The Public Works Committee and Mr. Hoellerman will look into this situation and report back to Council. Mr. Hoellerman will also keep in touch with Mr. Scholze and report what progress is made.

Frank Fehl - 258 Park Ave. - Complained about the owner of an apartment building on Orlando Ave. who works for B&J Construction and is bringing back refuse from his remodeling jobs and dumping it on his lot. Neighbors were in the audience expressing their disapproval of same. Mr.Fehl requests that perhaps the police could contact the man and inform him as to what he can do - No more dumping.

He has tried to get his landlord to repair the place and he gets nowhere, so he is moving out. However, he feels that something should still be done about the house. Mr.Richey explained that if the house is in such bad condition, Council can ask our Solicitor to direct a letter to the owner asking him to either repair it, or it will be condemned. It will be checked.

Tony Ruffalo - 228 Cornell Ave. - Asked about the poles on Center Ave. Mr.Hoeller-man answered that the drawings have been received and okay'd - now we wait for Duquesne Light. Mr. Ruffalo commended Council for their proposed action with the News Record.

Jim Nudi - Speaking for himself and all members of the Chamber of Commerce, he appreciates the remarks made by Mr. Gmiter that Council is not going to rush into the zoning change. The Chamber of Commerce will cooperate 100% and anytime a hearing time is scheduled, the people will be informed.

Alfred Graziani - 219 Highland Ave. - Asked what had been done about his sewer problem. He was informed that a test had been run on the main sewer and that all sewers have been cleaned and there is no stoppage in any of them.
