Minutes of the Regular meeting of The Town Council of The Borough of West View held Wednesday evening, January 3, 1973 in the Board Room of the ^Municipal Authority. ^Meeting called to order after a moment of Silent ^Prayer and ^Pledge of Allegiance to the flag at 8:00 ^P.M. by ^President of Council, Harry ^H. Gruener.

Roll Call was answered by the following Members of Council[‡] Messrs. Keller, Daugherty, Gmiter, Witherel, Rinchiuso and Gruener. Mr. Roberts was not presentill. Also present were Mayor R. E. Powell; Solicitor, Fred E. Baxter, Jr.; Controller, Frank Heagy; Engineer, Vincent Mannella and Secretary, Fern Herchenroether.

Motion by Mr. Witherel, seconded by ^Mr. Keller that the minutes of the Regular Meeting of December 6, 1972 be approved. Carried and so ordered.

Motion by Mr. Keller, seconded by Mr. Gmiter that the minutes of the Special Meeting of December 27, 1972 be approved. Carried and so ordered.

Motion by Mr. Keller, seconded by Mr. Gmiter that accounts payable in amount \$39,083.33 and including payroll in amount \$20,119.05 be approved. Carried and so ordered.

Reports - Mayor - Recommends that Charles Holtgraver, Jr. be enrolled at the Allegheny County Police Academy.

Motion by Mr. Gmiter, seconded by Mr. Witherel, that Charles Holtgraver, Jr. be enrolled for 14 weeks at the Allegheny County Police Academy beginning February 26, 1973. Carried and so ordered.

Mayor had a statement from ^Northway Car Wash for washing of the police cars for the year 1973. \$200.00 for each car - no Saturdays or Sundays. This was tabled until the Chief of ^Police has an opportunity to check other sources.

Mayor Powell recommends that since Car #2 - Pontiac- has 50,000 miles on it, It would be advisable to consider advertising for another police car at this time. The Police and Public Safety Committee will meet and discuss this, then a decision will be made by February meeting.

Mayor extended an invitation to Council Members to attend several installation services of Fire Companies.

Mr. ^Keller inquired about the rain coats which were to be bought for the ^Special Police. All they need do is report to the Borough Office and see the ^Police Chief.

Mayor Powell suggested that the School Guards be given red lights to be used especially on dark mornings.

Mr. Gmiter inquired as to the possibility of parking cars on the Water Authority property beside Arrow Cleaners on Friday evenings, when it is not used by the Authority. ^Chief will inquire as to this possibility.

Mr.^Keller complained about parking on sidewalk between Norwich & Hawthorne Ave. on Center. ^Chief will instruct the police officers on this. Fire Chief George - Applied for burning permit from the County to burn Christmas trees on January 12th, 19th and 26th, on Bronx Field.

The engine is in the Aerial truck and should be back in service in about a week or two.

<u>Mr. Mannella - Engineer</u> reported he had sent letters to Duquesne Light Co. concerning the poles on Center Ave. He received an answer and he will send plans in duplicate to them immediately.

He also sent a letter to Mr. ^Heisley regarding the changing over of lights. Answer also received on this, stating that as soon as the necessary engineering is completed, the Construction Department will be contacted to schedule installation as soon as possible.

Mr. Mannella also addressed a letter to State ^Highways regarding Highland Ave. Never taken care of satisfactorily. ¹he pot holes were filled, but it didn't hold.

Mr. Keller inquired about the water which runs across the highway from John Downs property. He was told this comes from springs and there is really nothing the Borough can do about it. This happens in quite a few spots in the Borough.

COMMITTEE REPORTS - Finance - Mr. Rinchiuso - Motion by Mr. Rinchiuso, seconded by Mr. Witherel that 9906.77 be transferred from the General Fund to the Sinking Fund. Carried and so ordered.

Fire & Water - Mr. Keller - recommends that a fire plug be installed in Ross Township property between Perry Highway and Bellevue Ave. on Schwitter. Council members suggested that Mr.Keller get in touch with Ross Twp.Commissioners and their Fire Chief and discuss this matter with them. The cost of installing a plug is \$750.00 and the rental is about \$35.00 per year. Mr. Keller feels this plug is necessary to cover the new apartment building in Schwitter Ave.

Public Relations - Mr. Witherel reported on the Home Rule Commission. They organized and their officers are: Chairman, Mr. Witherel, Vice Chairman, Mr. Edward Kennedy and ^Secretary-Treasurer, Mr. P. Gmiter. Their meeting date is the 4th Wednesday of each month.

Recreation - Mr. Daugherty announced that a card party will be held at VFW on January 17th for Senior Citizens. Mary Kay Bernhard of the Committee will have charge of this affair.

Collection of garbage from the new apartment building on Schwitter Ave. was discussed. Mr.Hoellerman will find out the details and report back at next Council meeting.

Unfinished Business- Public Works Committee has been negotiating and a contract should be signed within the next week.

Mr. Gmiter suggested that it might be a good idea to let **čitizens** of the Borough know what is going on. It was suggested that items of interest be inserted in the envelope along with the quarterly wage tax statements. ^Council members will be informed in time to do this.

Motion by Mr. Rinchiuso, seconded by Mr. Witherel, that Resolution #924 be taken up at this time. Carried and so ordered.

Minutes of the Regular meeting of The Town Council of The Borough of West View held Wednesday evening, February 7, 1973 in the Board Room of the Municipal Authority. Meeting called to order after a moment of Silent Prayer and Pledge of Allegiance to the flag at 8:00 P.M. by President of Council, Harry H.Gruener.

Roll Call was answered by the following Members of Council: Messrs. Daugherty, Keller, Gmiter, Roberts, Rinchiuso and Gruener. Mr. Witherel was in Harrisburg attending a Local Government convention. Also present were Mayor R.E.Powell; Solicitor, Fred E. Baxter, Jr.; Controller, Frank Heagy and Secretary, Fern Herchenroether. Mr. Mannella, Engineer - ill - not present.

Motion by Mr. Gmiter, seconded by Mr. Roberts that the minutes of the Regular Meeting of January 3, 1973 be approved. Carried and so ordered.

Motion by Mr. Daugherty, seconded by Mr. Gmiter that accounts payable in amount \$61,254.73 and including payroll in amount \$21,282.80 be approved. Carried and so ordered.

<u>REPORTS</u> - Mayor- Read a letter from Mrs. Grace Hurley thanking Officer Kircher and Officer Holtgraver for their quick and efficient service with the ambulance after she became ill in January.

Read a letter from the North Hills Buccaneers thanking Council for permitting them to use the rear room in the Borough Hall last September to practice.

Mayor Powell reported that Mr. Powell of the Water Authority has granted permission for use of the empty parking spaces beside their building on Friday evenings.

Read a letter from West Penn Motor Club about pot holes. Mr.Hoellerman feels Public Works are doing the best they can with pot holes.

Motion by Mr. Daugherty, seconded by Mr. Gmiter that Council take a full page ad in the VFW 40th Anniversary Book. Carried and so ordered.

Mayor announced that the Police have specific instructions that they are not to leave the Borough unless requested by Ross. If disobeyed, disciplinary action will be taken.

Chief Farley requests that the antennae for the police radios be moved from the Borough Building to #1 Fire Mall.

COMMITTEE REPORTS - Finance - Mr. Rinchiuso announced that all forms have been finalized to borrow \$135,000.00 from Pittsburgh National Bank. \$60,000.00 has been deposited in the General Fund and \$75,000.00 in Certificates of Deposit at 5% interest.

Motion by Mr. Rinchiuso, seconded by Mr.Keller that \$227.50 be transferred to the Sinking Fund for March requirements. Carried and so ordered.

Mr. Rinchiuso asked that the people in West View make sure to write in "West View" on their Federal Income Tax forms. On the short form it is lines 26 and 27, and on the long form it is lines 31 and 34.

Mr. Rinchiuso also asked for permission to make copies of forms free of charge for Senior Citizens for tax rebates. Permission granted. Mr. Rinchiuso will attend a meeting on Revenue Sharing and will report any kind of recommendation for Council to consider. He feels part should go for Senior Citizens.

It has been suggested that perhaps a bus could leave West View for the Shopping Center several times a month, for Senior Citizens.

PROPERTY & PURCHASE - Mr. Roberts - reported that the maintenance work has been completed at #1 and #3 Fire Houses.

Two pieces of office equipment were sold the past year. Also a salt spreader was sold. Not too much salt has been purchased so far this year.

A calculator is needed in the Bookkeeping Dept. Several have been placed in the office on a trial basis. No choice has been made yet.

<u>PUBLIC WORKS</u> - Mr. Daugherty - Motion by Mr. Daugherty, seconded by Mr. Gmiter that Council advertise for one 2^{1} ton 4 wheel drive dump truck and a Street Sweeper. Bids to be opened at the next regular Council meeting on March 7,1973. Specifications may be picked up at the Borough Office. Carried and so ordered.

The advertisement will be for either a diesel engine or a gasoline engine on the Sweeper.

Motion by Mr. Daugherty, seconded by Mr. Roberts, that Council advertise for hot mix. Carried and so ordered.

Mr. Daugherty asked permission to send for an application from AIM to repair Center Ave. Permission is granted and Mr. Mannella will handle.

The street signs are still being made. Districts 3, 4 and 5 are completed. All should be completed by March 15th.

Mr. Heisley of Duquesne Light has been out to the Borough and informed Mr.Hoellerman that the preparation work is being done on up-dating our lighting system.

POLICE & PUBLIC SAFETY - Mr. Gmiter thanks the Chief for taking care of all of the requests from last month.

Motion by Mr. Gmiter, seconded by Mr. Rinchiuso that the antennae for the police radios be installed at #1 Fire House. Carried and so ordered.

Motion by Mr. Gmiter, seconded by Mr. Daugherty, that Council advertise for a Station Wagon for police work. Bids to be opened at the next Council meeting March 7,1973. Specifications to be available at the Borough Office. Carried and so ordered.

The Police Committee will meet in the near future to discuss changing the color of the police cars.

FIRE & WATER COMMITTEE - Mr.Keller - Motion by Mr.Keller, seconded by Mr.Rinchiuso that Council purchase two 12 Volt batteries at \$70.00 each for the aerial ladder truck. Carried and so ordered. The truck should be back in service by the end of the week.

Mr.Keller talked to the Fire Chief of Ross about a hydrant at Schwitter Ave. Ross will handle this.

PUBLIC RELATIONS - Mr. Witherel (Mr. Gmiter reporting) Home Rule Committee met. Recommendations will be made soon and will be reported to Council. RECREATION - Mr. Daugherty reported that the Senior Citizens card and bingo party held in January was a big success. He thanked the Committee and VFW for their help and cooperation.

Mr. Daugherty reported on the progress of aid for Bronx Field. The applications are being reviewed and it will probably be another 60 to 90 days for a final answer. He feels there should be no problems. However, if the application is held up that long, Little League and others may not be able to use the field this summer.

Letters are being sent to parents of children who are interested in Recreation for a meeting to be held at #3 Fire Hall on Saturday, February 17th.

Dr. Torrenson called Mayor Powell and asked that he convey to Council that all of the School facilities will be available to West View children for recreation. Mr.Daugherty will meet with the Recreation Board of Ross to get some details straightened out.

Permits have been granted to use the gym floors at West View Jr. High School, Highland and Perrysville Schools.

Audience - Mrs. Haney asked about forms for West View Senior Citizens for tax rebate. These forms are not yet available.

William L. Wunderly stated that his office would have these forms when they are available and his office will be available for assistance.

Unfinished Business - Motion by Mr. Daugherty, seconded by Mr. Roberts that Resolution No.923 be removed from the table. Carried and so ordered. (rodent control)

Mr. Daugherty reported on rodent control on information received from 15 other communities, and how they handle it. From this survey, he feels that we should continue our contract with Commonwealth Exterminators.

Motion by Mr. Daugherty, seconded by Mr. Gmiter that Resolution/shall not be adopted. Carried and so ordered.

Motion by Mr. Gmiter, seconded by Mr. Daugherty that Council renew the contract with Commonwealth Rodent Control for another year. Carried and so ordered.

Motion by Mr. Rinchiuso, seconded by Mr. Roberts that council engage the services of Dan-Dee Car Wash, Inc. for washing of two police cars (unlimited) for \$140.00 per year per car for a total of \$280.00 (one year). Carried and so ordered.

Mr. Gruener read a card of thanks from the Norris family for remembering them on their recent bereavement.

The matter of garbage and rubbish collection from the apartment on Schwitter Ave. was discussed. This will have to be settled between Mr.McKee and the owner of the property.

Mayor Powell requests that Mr.Hoellerman inform the contractor who is building the two houses on Ashford Ave. that he clean the street periodically.

The Mayor has also had numerous calls about parking. He says there is no way we can stop people from parking in front of anyone's house, as long as they have a good license plate and a good sticker.

<u>New Business</u> - Motion by Mr. Gmiter, seconded by Mr. Daugherty that \$1,000.00 be allocated to the Home Rule Commission. Carried and so ordered.

Motion by Mr. Daugherty, seconded by Mr.Keller that Ordinance No. 1152 be taken up at this time. Carried and so ordered.

CHIEF OF POLICE - John Farley announced that the police are taking a refresher course in First Aid. Officer Holtgraver is attending the Police Academy. Officer Obermeierwill be back on duty tonight after his recent operation.

FIRE CHIEF GEORGE - Aerial Truck #3 is back in service. Quite satisfactory. Firemen are also attending the First Aid classes.

Mr.Keller has discussed with the Manager of Ross Township, Mr. Williams, the subject of the fire hydrant at Gerber Terrace and Schwitter Ave.

Motion by Mr.Keller, seconded by Mr. Roberts that West View Borough share with Ross Township the expense of installing and the monthly rental of the hydrant. Carried and so ordered. Secretary to write a letter to the Public Safety Committee of Ross Township, stating Council's decision.

Motorola license and bill discussed. Solicitor Baxter will see what he can do in endeavoring to receive the l@cense. Council will hold off on the bill until the Solicitor has an opportunity to examine.

PUBLIC RELATIONS - Mr. Witherel- reported on his attending a conference in Philadelphia. He has tapes on the meetings for Council to study.

RECREATION - Mr. Daugherty. Another Semior Citizens Card Party and Bingo on April 4th at the VETS hall. Parents and adults have met in order to form a Parents Recreation Association. We should hear from this group shortly.

Council dispenses with regular order of business to open bids on Sweeper.

Mr. Dom Mamone spoke for the Chamber of Commerce relative to Mr. Rinchiuso's idea for a restarea on Center Ave. Chamber of Commerce feels it is a good idea and Mr.Mamone had several other ideas. They will cooperate to the fullest.

Jim Nudi also spoke. He feels the merchants would all be in favor of this. Secretary is to write PAT about replacing the old shelter at West View Park with a new one.

Mr. Witherel as Public Relations Chairman will work with Chamber of Commerce and look into these plans.

Mr.Nudi asked that Mr. Rinchiuso also be on the committee. Approved.

Mr.Roberts made a motion that an Ordinance be drawn up for the Borough of West View to join the Northland Library.

Mr. Daugherty will meet with Mr. Slanina and Mr. Lowandowski of the State Dept. of Highways to go over Center Ave. with the thought that perhaps the State will be able to help with this project.

Mr. Daugherty reported that the paving job should be completed within the next few weeks.

Audience - Mr. Sagnimeni - 30 Glenmore Ave. - remarked that he cannot possibly clean up all the debris in the creek, on his property, as suggested by Mr. Baxter. Solicitor ^Baxter feels that this is not the problem of the Borough. After discussion, it was agreed that Mr.Mannella, Engineer will be asked to take a look at this situation and try to come up with a solution.

Mrs. Taylor - <u>324</u> Cornell Ave. spoke for a group of mothers who are interested in a sports program at Highland School. Mr. Daugherty explained to them that the Recreation Board will try to set up a program at the Highland School for Thursday evenings and Saturday mornings.

<u>Mrs. Fucci</u> - <u>228 Magnolia Ave.</u> - presented a petition to Council relative to the terrible condition of the Magnolia steps, as well as the large drainage hole (unoovered) between 228 and 220 Magnolia Ave.

The Borough will make an effort to cover the opening on Magnolia Ave. and Mr.Hoellerman was asked to get an estimate on steps for next year's budget.

Mr. Kostelnik - 229 Magnolia Ave. - requested that a "No Outlet" sign be posted at the top of the hill at Magnolia. This will be done.
