Question -- Robert Eardley said he lived at the corner of Highland and Ann Arbor. First of all, I have no objections. It is a good idea. Just thought that since there had been no changes over there in 30 years why, all of a sudden, this come up. What is the motive?

Mr. Daugherty said that about a year ago, someone had requested a Stop Sign for traffic coming off Union Avenue. The State Department of Transportation came out and did a Survey. They decided the YIELD Sign there was enough. However, at that time, they did suggest that the Borough might consider making Ann Arbor Avenue One Way going in off of Highland Avenue.

Mr. Eardley further said, as they are passing this Ordinance, you might want to consider better maintenance of 11th Alley which runs between Lehigh and Ann Arbor behind Highland Avenue. The weather hasn't been too bad this year, but last year it seemed that this alley was ice-covered all Winter. Mr. Kovac advised this Alley is up on the Board for Salting and plowing as soon as possible after each snowfall.

Mayor Powell said that Highland Avenue and Ann Arbor is amost a completely blind corner and the One Way into Ann Arbor would eliminate an unsafe condition at that particular corner. Motion carried, and so ordered.

Our Liquid Fule CD in the amount of \$81,840.44 matured today earning Interest of \$460.35. Of the \$82,300,79 we will use \$9,582.47 to pay for recent Salt Purchases and the Balance of \$72,718.32 was Reinvested for 30 Days to earn Interest.

The first quarterly payment for Entitlement Period 17 - Revenue Sharing - was received by the Bank and immediately invested in a CD in the amount of \$16,931.00 -- for 90 Days -- to earn interest at 7%.

Real Estate Tax Collection Deposits for the Month of January totaled \$2,051.28 - all being used to defer our January Expenditures.

Wage Tax Collection Deposits for the Month of January totaled \$37,601.54 - the Borough's Net Proceeds were \$18,800.77. These Funds are being deposited into the General Fund Checking Account to help offset Borough Expenditures in February.

Public Works - William H. Cummings

The Borough Workers are very, very busy with salting of streets and trying to keep up with filling in Potholes. they are getting them as fast as they can but will, now, have to wait until we get a break in the weather.

Have talked with Bill Wunderly regarding the Redevelopment Authority and asked them to stay together. He advised they would be happy to. They have a Meeting coming up and will discuss and let us know. We now have access to the back Parking Lot between the Affolder and West View Savings Buildings. We started a Driveway Project further up the Highway which we feel will clear some of the trafic in the Area of West View Savings and Driveway to Borough Building. They will be using the new area as an EXIT ONLY on to the Highway. We hope to complete this Project when there is a break in the weather.

Police and Public Safety - Joseph J. Szalinski No report.

# Fire and Water - Bernard J. Smith

I announced at the last meeting there was going to be a Basketball between our Fire Companies and WEEP. They killed us. However, we did raise \$410.00 which was given to the West Penn Burn Unit.

At this time, would like to make a Motion to Close Out the #2 Fire Company Fund and put it in the General Fund. Motion seconded by William Cummings. Mr. Smith said this was the money for their New Building. Motion carried, and so ordered.

The second one was on Glenmore Avenue and I was at the corner of Ashford and Glenmore with traffic. Was not aware there had been a fatality. It was probably about 4:30 A.M. when everything was finally clenaed up from both fires.

I received and I feel I should get my money back for the time I lost.

Chief Kircher said Mr. Urban was not found not guilty -- it was due to a technicality when the citation was written up in the wrong section of the Motor Vehicle Code.

Mr. Urban asked if Lipp Avenue was in West View as he could not locate on his copy of the Voter's List. Mr. Daugherty indicated one half was in West View and half in Ross Township. Mr. Urban said that he was asking because one Saturday he was over there and saw a Police Officer in Uniform shoveling Snow. As a Taxpayer, I want to know if he is injured himself, would the Borough pay Workmen's Compensation on him? One of the reasons you gave for raising Millage was the higher rates on Liability. Secondly, he was on his owntime and we cannot tell anyone what to do during their lunch break. Sometimes they do not get full time for a break — they are always on Portable and available for emergency calls.

Mr. Urban asked if Mr. Daugherty knew a Mr. Dannemueller who works for the West View Water Authority. Mr. Daugherty said that 's my Son-in-Law. Mr. Urban said he saw him parked in front of 26 Lakewood Avenuethe other night for two hours. Mr. Daugherty said this is not Borough business but he would like to inform that Mr. Dannemueller is a Foreman and available 24 hours a day. He uses car to go back and forth to work. Mr. Urban asked if he is charged if he uses it for personal business and Mr. Daugherty said yes.

However, it was reinvested for \$68,884.25 - this was a result of a \$100 Credit issued by Morton Salt. This CD will mature on Monday, April 14, 1986. Upon maturity, the face amount, along with the interest earned, will be reinvested for another 30 Days to earn interest. We also received our 1986 Liquid Fuel Tax Check Allocation on Wednesday, April 2, 1986 in the amount of \$69,054.41. This money was invested in another CD on April 3, 1986 for 32 days to earn Interest.

Real Estate Tax Collection Deposits for the month of March totaled \$2,457.32 - all being used to defer our March Expenditures.

The Second Quarterly Payment for entitlement Period 17 of the Revenue Sharing was received by the Bank and immediately invested in a CD in the amount of \$16,931.00 for 62 days to earn Interest. Also, the CD we purchased with the First Quarterly Payment of \$16,931.00 will mature on Friday, April 11, 1986 and will have earned interest of \$302.88. The Doors need straightened and it needs some paint. We were unable to do this due to the Weather and my Husband has been off work for 5 years due to a broken back. For the last five years, we haven't been able to do much.

We have had Bob Hatfield on the front porch telling me to do something — or else: Allegheny County Health Department was out and we were given a clean bill of health by them on May 17, 1984.

We were brought before Mark Devlin and he said he was going to push the Garage over and then condemn the house -- we should get out of the Borough.

Have been harassed by the Neighbors. Bob Aguglia has stood in the yard and yell at me and it is their Child that is always teasing the Dogs. We have been getting obscene calls and my childre have been harassed.

This is the worst place I have ever lived in -- have been here for 15 years and people have even accused us of having a Dead Horse out at the side of our house.

We have been constantly harassed for the last five years and have to do everything ourselves. The neighbors don't care and no one has offered to help us.

rar. Daugherty said the Borough has had numerous complaints and nothing seems to be done. I know the former Borough Manager contacted you and nothing has ever been accomplished. As far as Allegheny County, we have never received a Report from them.

Question -- Controller Frank Heagy wanted to specify that the Funding Source would be Liquid Fuel. Motion carried, and so ordered.

Public Works - William H. Cummings

Mr. Kovac and I have been surveying the Streets and, so far, have found three really bad streets. Will not give out Names but we are going out once more and will do as many as we can, depending on the Bid Results.

We are doing Potholes as usual and painting Curbs and Crosswalks as a safety measure.

Police and Public Safety - Joseph J. Szalinski Nothing to report at this time.

Fire and Water - Bernard J. Smith

At previous meetings we reported that the #3 Fire Hall Restrooms had been remodled. They did a really nice job and on Election Day, the Ladies will be surprised.

Have been having trouble with the Current Fire Horn system up at 31 Fire Hall on Ridgewood Avenue. Fire chief Assisi contacted Pittsburgh Communications regarding Repairs to the Base Station up ther and they quoted a Price of about \$233.22 this time. Feel that, eventually, we will have to do something with the entire System — I have never seen such an Old System.

Public Relations and Recreation - Mary Kay Bernhard

Have some bad news — we have been attempting to hold on to the Ridgewood School Building. At this point in time, the members of our Community are not making use of it and we cannot meet the Utility Bills. We are going to turn the Building back to the North Hills School District — this is a ver hard thing to do. Jay Nowark and I are on the Building Committee and it is hard to realize that we can't make a go of it. It is just not being used by the Community. We woule like to request that Town Council handle a Gas Bill in the amount of \$1,770.31. We will be notifying the School District and sending notices to the people that are using the Building that the facilities are no longer available after June 30th.

All of the people worked so hard to get the building cleaned up. They scrubbed walls and floors and set up a Library. They did a really wonderful job. Only three families made use of the Library. We have Two Rooms full of Books. Mr. Nowark has made arrangements to have them shipped out of the Country to Foreign Land Schools. Again, it is a hard decision but we have no other choice but to return it to the School District.

.r. Nowark said he did not want to repeat but we really did try to save this Building for a West View Community Center and just did not get Community support. People involved gave of their time and effort 100%. We do not want to come to Council for help but simply cannot make the payment of \$1700 for the Gas Bill.

In the beginning, we came to Council and told you what we wanted and everyone supported us. As Mary Kay said, it is very hard to lose it after all that was done.

Mr. Daugherty thanked Mary Kay Bernhard and Joseph Nowark for all of their efforts. It is hard to find volunteer help in order to keep the Building up. Once again, would like to thank you for your help and please pass our thanks along to the Members of the Building Committee who worked so hard on behalf of Council.

John Gorman Made the Motion to pay the Gas Bill for \$1,770.31 for the West View Community Center. Motion seconded by William Cummings. Motion carried.

#### Audience

Jim Farenhold, 19 Richland Avenue — Here tonight due to a problem we are having on Richland Avenue. People are using Richland Avenue as a shortcut from Route 19 over to Center Avenue. There are two Stop Signs but they don't even slow down. Most of them don't live on the street and there are a lot of children. Maybe you could put a Stop Sign at Frankfort and Msgnolia. Also, why can't the Police give out Tickets. Chief Kircher said the Police always respond to Complaints.

One of our neighbors suggested having Police come down in the busy time — around 5 PM — it is really busy, then. They don't even slow down. They go right through the Stop Signs. There are no Sidewalks. I have been there for 7 years and am wondering why no one has been killed by now. In the Winter, there is a Spring down there and it ices up but Men always come down as soon as they can. Mr. Farenhold gave the Petition to Mr. Daugherty.

Mr. Daugherty aksed the Mayor and Chief Kircher to check the area and maybe we could put an Officer down there for a couple days at 5 P.M. Mayor Powell asked if the Residents would consider having it a One Way Street. Mr. Farenhold thought they might put in a Speed Bump and Mayor Powell said this is illegal. If they decided on a One-Way Street, we could do it ona 30-Day Trial basis.

Bill Gatto - Magnolia Avenue -- Signs at Magnolia would probably not help. There are still cars coming up Frankfort to get to Ridgewood and the Highway. They don't even slow down before going up the hill.

Falso, there are two cars parked right on the corner. I think they belong to the Shamrock Roofing. If you decided on One-Way, it should be from Oakwood over to

Edward Kennedy, 220 Ridgewood Avenue -- Wanted to make suggestion that they put a 3-Way Stop at Bellevue and Cetner Avenues. A lot of people come off Glenmore and speed down Bellevue Avenue. Also you might consider No Parking on the Left Hand Side in front of the Dairy Store.

We received a letter from Lou Washowich, Mayor of McKeesport requesting our support for the establish a Greyhound Racing Track. They included a Sample Resolution for our consideration. All Members of council received copy of letter and Resolution. The matter was tabled until the next Council Meeting in June.

Mr. Cummings reported that the new Hi-Lift has been delivered and we will be training more than one person to run it in case someone is off due to vacation or sick time.

Police and Public Safety - Joseph J. Szalinski

Want to say we have one of the best emergency systems around. I happened to be in the Police Station the night of the severe storms. Really have to compliment the Police, Borough Manager and Borough Workers, Fire Department and Police Desk Personnel. Dom Lopez happened to be on Desk and was really running back and forth between Fire Alarm and Phones.

One thing I would like to mention. I didn't believe number of calls coming in regarding Lights being out. These people should have called Duquesne Light. Is there some way we can educate Residents to please not call in a situation such as this? We have no way of knowing what Duquesne Light is doing during emergencies.

Fire and Water - Bernard J. Smith

We are going to get new Tires on the Pumper at #2 - this will cost approximately \$1030.00 and is taken care of by Borough.

Up at #1 Fire Hall (the original Borough Building) had to replace Small Door - this was done at Firemen's Expense.

Joe Assisi discussed the Aerial -- it was purchased in 1960. The Law states that after 30 Years it must be totally Tested and Re-Certified. This costs about \$600. Our Thirty Years will be in in 1990 and maybe it would be wise for us not to wait that long.

Chief advised that we had couple of places flooded during that bad storm, but we had nothing nearly as bad as Shaler and Etna. Our people did an outstanding job and, in the past few weeks, some of our Men volunteered to go into Shaler and Etna and help with the clean-up. Some of the other communities have set up locations for donations for food, clothes, etc.

Public Relations and Recreation - Mary Kay Bernhard

Summer Recreation Program will run June 30th through August 24th. We will only have
one Playground this year -- West View Elementary School. Playground Program is from
9 AM to 12 Noon and 1 PM to 3 P.M. - Monday, Wednesday and Friday. We will be taking
Children to North Park for Swimming on Tuesdays and Thursdays. It will be a one-time

payment of \$1.00 at Signup. Signup will be Tuesday June 24th from 6:30 P.M. to 8:30 P.M. at the Borough Hall. We will issue Badges for Swimming at that time.

We are still looking for one more Employee for the Summer Program - they must be a College Student. If you know of anyone interested in working the Program, contact Audrey or me for an Application.

With the Ridgewood Building closing, we are going slow and don't know how the Program will be received this year. Have to wait and see how many children will be coming over from the Ridgewood Avenue area.

We are working on the Senior Citizens Trip-- have nothing definite, yet.

Mr. Smith asked if he could say one more thing. Chief Assisi mentioned something about the current Fire Horn up at #1 - They have been having trouble with Base Station up there. Pittsburgh Communications recently did some repairs and total bill was over \$2,000. It is now back in service. System is really old.

The U. S. Supreme Court recently ruled the automatic Budget Cutback provisions of the Gramm-Rudman Law and unconstitutional. Congress must take formal action to impose the 4.3% cutback (or more--or less). Everything depends on action taken by the time of the Adjournment of the 99th Congress.

Audience

Howard Teets - PSSA (Pa. Seniors Softball Association) - I am here tonight to give Members of Council a Packet and to see if anyone has questions.

Mr. Daugherty and Mayor Powell said they had some questions but for Mr. Teets to go ahead with his presentation. Mr. Teets handed out the Information Packet. He said the Organization had had 6 Years of Experience and asked if anyone had seen the writeup in yesterday's News-Record. They are also having Announcements on WJAS and WSHH Radio.

We are a Non-Profit Organization and these Leagues have been successful all over the Country - amost every State. In the package is a letter of Commendation from the Department of Aging -- most of the information is publicity in Newspapers.

Mrs. Bernhard asked if he was connected with Sharpsburg. Mr. Teets said they are in the League.

How many Teams are there? There are 7 Teams existing, now.

Understand you are calling people -- are you asking Seniors to participate? Also, you are asking for \$10 Donation. Mr. Teets said they don't single out just Seniors-asking everyone for Donation.

Mr. Daugherty asked if they work through the AARPs. No.

Mr. Teets said they have approximately 300 persons in the Eastern League - they are from Monroeville, Penn Hills, McKeesport, Wilmerding, Turtle Creek, Wilkins Township and Plum Borough.

Rules for Senior Softball are different and modified. There are 25 Players on a Team due to having a hard time getting substitute players. Monroeville has two Teams and there are 5 Teams in McKeesport. Four Teams are for 50 Years and Older and 1 Team is for those 55 Years and Older. One of our Liquid Fuel CD's for \$21,680.98 matured on December 5th and earned Interest of \$93.05. Face Value and Interest (\$21,774.03) was Reinvested for 30 Days to Earn Interest.

A second Liquid Fuel CD will mature on Monday, December 15th. Face Value and Interest in the amount of \$311 will Total \$68,248.72. This Total will also be Reinvested for 30 Days to earn Interest.

Real Estate Tax Collection Deposits for the Month of November totaled \$16,538.45. This amount will be used to defer our Expenditures for the balance of the year-1986.

Wage Tax Collection Deposits for the Month of November totaled \$57,470.89 less \$63.90 (1 Returned NSF Check). Borough Workers are very busy keeping up with the Leaves. The Sweeper has been broken down for 3 to 4 weeks. It is repaired and they will be back out picking up leaves. Potholes are a continuing problem and they are keeping up with these.

The Community Redevelopment Committee has agreed to pay for the Christmas Tree down at Center Avenue and Perry Highway. Our Men have put it up and it really looks nice for Christmas time.

#### Audience

Mrs. Theresa Gruener, 15 Ann Arbor Avenue -- Am here this evening with regard to the Blasting on I-279 over on Courtney Mill Road.

Starting in July, they have been blasting about 3 times a Day - 5 Days a Week. Seemed they have been doing more blasting. One day in October there was a terrible jolt. We have been keeping track and have contacted Cameron Construction Co. - Tom Wilson. He, in turn, said we would be contacted by Liberty Mutual and a Construction Engineer. I know some of neighbors are concerned.

I started keeping a Log. One crack in the foundation near the base has moved all the way up. They said it might be the Humidity Factor so I started a Log on this, too. They also mentioned Settlement of House. The house is over 50 years old and we are now starting to notice cracks in the plaster.

Mr. Kovac, at the Borough Office, encouraged me to take pictures of the foundation. One picture taken on 10/30 shows a 6" Crack in the foundation going upward. Now, it is coming back down. The inside window sill is cracked and we are getting dampness after heavy rain on the interior wall.

I contacted Mr. Kovac again on December 9th and he advised me, once again, to make up a Daily Log. He will meet with me tomorrow afternoon. He advised he will be stopping by to investigate any other claims. Something has to be done as we are being affected by this blasting.

Mr. Daugherty said that we will try to contact Representative Mayernik and our new State Senator to see if they can apply some pressure. He asked Mrs. Gruener to come into the Office tomorrow and we will make copies of her records for filing in the Borough Office. Mr. Kovac will call to make arrangements to meet with you as soon as possible.

Linda McLallen, 343 Cornell Avenue -- Came this evening to see if Council could help. Said she had already been in contact with David Mayernik's Office, PennDOT, Cameron Construction, Engineers, Berger & Associates and went as far as having Sizemograph Testing done. Have split in floor between Dining Room and Kitchen and floor boards completely separated. Have contacted several of these people more than once and one of the Secretaries was very rude to me indicating that I was a "Liar". One of the Men went so far as to say if he pursued this matter, he would be ineligible for future employment due to Politics. Another man said these problems were not due to blasting - they appeared to be previous conditions. Miss McLallen also started a Log of all that had happened and Mr. Daugherty asked her to bring them to the Borough Office so we could make copies.

Miss McLallen felt there was definite need for someone to apply Political Pressure. Said she would appreciate any help Council could give her.

Mr. Daugherty asked Mr. Witherel what we could do and he said as was mentioned earlier, all the necessary Permits have been filed between Ross Township and Penn DOT and the Construction Company.

Only possibility is maybe contacting PennDOT. Mr. Daugherty asked Mr. Witherel to check with Mr. Baxter to see if there is anything we can do to be of help.

Mr. Daugherty thanked Mrs. Gruener and Miss McLallen for attending tonight's meeting
