Minutes of the Regular Meeting of Town Council on Wednesday, January 12, 2011, held in Council Chambers at 441 Perry Highway, Pittsburgh, PA 15229. The Meeting was called to order at 7:00 p.m. by President Bernhard, followed by a moment of silent prayer and the pledge of allegiance to the Flag.

Mr. Wolf conducted Roll Call. Members of Town Council present were: President Mary C. Bernhard, Vice President Barry G. Schell, Member William F. Aguglia, Member John W. Koerts, Member Donald E. Mikec, and Member Ralph R. Burchell. Also attending were: J. R. Henry, Mayor, Secretary/Manager Kenneth J. Wolf, Assistant Secretary Patricia A. Rapp, Police Chief Charles M. Holtgraver, and Solicitor Fred Baxter. Council Member M. Kimberly Steele and Robert Zischkau from Glenn Engineering were absent.

Motion to approve the Minutes of the Regular Meeting of Town Council on December 8, 2010 was made by Mr. Schell and was seconded by Mr. Aguglia. Motion was approved and ordered.

Motion to approve the payment of general fund expenditures for net pay and payroll withholding in the amount of \$129,977.38 and payments to vendors in the amount of \$559,992.30 was made by Mr. Aguglia and was seconded by Mr. Koerts. Motion was approved and ordered.

Motion to approve the payment of building fund expenditures in the amount of \$28,236.74 was made by Mr. Koerts and was seconded by Mr. Aguglia. Motion was approved and ordered.

REPORTS FROM THE OFFICERS.

Report from the Mayor - J. R. Henry, Mayor

The Mayor said a copy of his December Report was furnished to Council in their packets and gave the Mayor's Report for the Year 2010 as follows:

Mayor Henry said the Association of Mayors of the Borough of Pennsylvania honored the late Richard Powell with recognition at their annual conference and sent 33223 out a memorial resolution for his service to West View, with a copy being forwarded onto his wife, Helen.

Mayor Henry updated Council on the progress of the Civil Service testing for the Police Officer list for the Borough. The Borough should have a list of eligible Police Officers every two years and the Borough is currently updating this list. The physical test was completed on January 11th and the Civil Service written test will be given on January 19th. Upon completion of testing, the Civil Service Commission will conduct interviews in order to compile a current list.

Mayor thanked both the Commission Members and the Borough Secretary for their assistance with the testing.

Report from the Secretary/Manager - Kenneth J. Wolf

Mr. Wolf said the Borough Auditors were in for one day and will be returning to conduct the 2010 Audit.

Report from the Chief of Police - Charles M. Holtgraver

Chief Holtgraver had no report for Council.

Report from the Solicitor - Fred E. Baxter

Mr. Baxter had no report for Council.

Report from Glenn Engineering - Robert E. Zischkau (Absent - Written report on file)

At this time, President Bernhard introduced George Hollenberger, who was in the Audience, as the new Fire Chief of the West View Volunteer Fire Department.

Chief Hollenberger thanked Council for their welcome. Chief Hollenberger said he resides on Clairmont Avenue in West View and had been Joe Assisi's Assistant Chief in the past. Chief Hollenberger has served with the Fire Department for 30 years.

REPORTS FROM THE COMMITTEES

Finance Report - Ralph R. Burchell

Mr. Burchell said the Wage Tax collection deposits for the month of December totaled \$24,098.89. The Borough's net proceeds were \$11,520.04.

The Capital Reserve - UDAG CD in the amount of \$28,500.00 matured on December 4th, after earning interest in the amount of \$2.34. A new CD was purchased on that

0.0.0.0.2 same day in the amount of \$28,500.00.

The Liquid Fuel CD in the amount of \$65,500.00 matured on December 4th, after earning interest in the amount of \$5.38. A new CD was purchased on that same day for \$10,000.00.

Mr. Burchell said the Building Fund Money Market Account had a balance of \$197,729.15 as of December 31st. That Money Market Account earned interest of \$33.58.

The General Fund Money Market Account had a balance of \$862,247.57 as of December 9th. That account had earned interest in the amount of \$148.90.

Real Estate Tax collections for the month of December totaled \$20,654.54. These Funds were deposited into the General Fund Checking Account to help offset Borough expenditures in December.

Property and Purchasing Report - John W. Koerts

Mr. Koerts had no report for Council.

Public Works Report - Barry G. Schell

Mr. Schell reported that the Public Works Department has been getting ready to take down the Christmas decorations in the Borough and has ordered 1,300 tons of salt for the 2010-2011 season. The Crew is patching potholes, doing street and traffic maintenance throughout the Borough, and is doing an excellent job with snow and ice removal.

President Bernhard said the Crew is doing an excellent job on the Borough streets and was out there now clearing the streets.

Police and Public Safety Report - William F. Aguglia

Mr. Aguglia reported the Police had 261 complaints for the month, inclusive of three drug arrests, 16 thefts, 10 accidents, five assaults and one weapon complaint.

Mr. Aguglia said the Police handled five arrests for public intoxication and three burglaries. Mr. Aguglia requested Council retire for an Executive Session at the end of the Meeting to discuss contract negotiations.

Administrative / Budget Report - Ralph R. Burchell

Mr. Burchell had no report for Council.

Mr. Mikec gave the Fire Report for the year 2010, with the Department answering 281 calls for the year, averaging 23.5 calls per month. There were 11 Department Drills using 787 man hours and 1,764 man hours were used during the 37 Company Drills.

Public Relations and Recreation Report - M. Kimberly Steele (Absent)

In Ms. Steele's absence, Mrs. Bernhard said the Senior Citizen Spring Fling will be held on Friday, April 29, 2011 at the West View Banquet Hall. Tickets are on sale now for \$10.00 per person at the Borough Office from 8:00 a.m. until 4:00 p.m. The cost of \$10.00 includes a luncheon, entertainment and door prizes and Mrs. Bernhard requested Seniors purchase their tickets as soon as possible so they would know how many meals to order.

Mrs. Bernhard asked Mr. Mikec to report on the Crime Watch Meeting that took place on Monday, January 10th, since she had not attended.

Mr. Mikec attended the Meeting and said the Program that Game Warden and Biologist Ryan Miller from the Pennsylvania Game Commission was very informative. Mr. Miller addressed many of the wildlife problems in the suburbs and Mr. Mikec enjoyed the Program, which he said was terrific. Mr. Mikec said Magistrate Richard Opiela will present the February 7th Program.

AUDIENCE

President Bernhard welcomed everyone to the Meeting on the behalf of Town Council. Mrs. Bernhard said that Council welcomes comments from any Borough Resident who would like to do so. All that we ask is that when addressing Council, you follow these procedures:

Each Individual will give their name and address. Each Individual will be limited to a maximum time period for questions and answers of five minutes and will be notified when there is one minute remaining.

If the Individual has not used their allotted five minutes, the Individual will be permitted to finish their five minutes, only after all Individuals wishing to address Council are heard.

Mrs. Bernhard said that in no event will Public comments extend beyond thirty minutes unless Council is of the opinion that those wishing to address Council cannot be heard. In this event, Council will extend the thirty minute time periods, if necessary. This extension will not allow Individuals that have already used their five minutes to further their time to address Council. If your comments require an answer, Council will try to provide an answer at this firme. If Council cannot provide an answer, they will give the Individual the proper directions to help get the information they seek.

Mrs. Bernhard said she would like to advise that Council is here to listen to comments and help when it is possible but Council is not here to debate opinions. Mrs. Bernhard welcomed Residents to step forward, giving their name and address.

Jim Barr from 200 Frankfort Avenue addressed Council to question Mr. Mikec on the Crime Watch Program, specifically if Mr. Miller had reported on Coyote sightings in West View. Mr. Mikec said every County has coyote sightings and knew of a recent Bear sighting off of Camp Horne Road and in West View's Hidden Valley area.

Mr. Barr wanted to know if there was an update on the Public Works or Police Contract and Mrs. Bernhard answered no.

Mr. Barr questioned if Budget Line Item 403.120 in the amount of \$59,075.00 for Tax Collector / Clerk was for more that one person, with Mr. Wolf stating it is for one Full Time and one Part Time Employee.

Mr. Barr questioned Fire Chief Hollenberger if he had any policy changes. Mr. Hollenberger said no. Mr. Barr had no further questions and was seated after addressing Council for two minutes and fifty-six seconds.

The Meeting was Called to Order at 7:00 p.m. by Mrs. Bernhard, followed by a Moment of Silent Prayer and the Pledge of Allegiance to the Flag.

Mr. Wolf conducted Roll Call. Members of Town Council present were: President Mary C. Bernhard, Vice President Barry G. Schell, Member William F. Aguglia, Member John W. Koerts, Member Donald E. Mikec, Member Ralph R. Burchell and Member M. Kimberly Steele. Also, attending were: J. R. Henry, Mayor, Secretary/Manager Kenneth J. Wolf, Assistant Secretary Patricia A. Rapp, Acting Police Chief Bruce A. Fromlak, Solicitor Fred E. Baxter and Robert E. Zischkau from Glenn Engineering.

Motion to approve the Minutes of the Regular Meeting of Town Council on January 12, 2011 was made by Mr. Aguglia and was seconded by Mr. Schell. Motion was approved and ordered.

Motion to approve the payment of General Fund expenditures for net pay and payroll withholding in the amount of \$135,455.73 and payments to vendors in the amount of \$86,906.60 was made by Mr. Aguglia and was seconded by Mr. Schell. Motion was approved and ordered.

Motion to approve the payment of the 2007 Project Fund - Sewer in the amount of \$150,916.88 was made by Mr. Koerts and was seconded by Mr. Mikec. Motion was approved and ordered.

Motion to approve the payment of the Building Fund expenditures in the amount of \$11,641.90 was made by Mr. Mikec and was seconded by Mr. Aguglia. Motion was approved and ordered.

Motion to approve the payment of Liquid Fuel expenditures in the amount of \$24,085.11 was made by Mr. Aguglia and was seconded by Mr. Koerts. Motion was approved and ordered.

REPORTS FROM THE OFFICERS

Report from the Mayor - J. R. Henry, Mayor

Mayor Henry said his Report had been contained within Council packets and the total receipts for January 2011 was \$2,166.81. The Mayor read a letter he received from Police

Chief Charles M. Holtgraver, who had written that after 40 years of service, his last working day was January 28, 2011 and, after taking five weeks of vacation and five personal days, he would formally retire on March 12, 2011. The Chief thanked Council and expressed his gratitude in working at a job he loved for 40 years. The Mayor said he was sad to see Charlie go but was glad to see he is looking forward to a long and healthy retirement and the Mayor wishes him well. *Motion from Mr. Schell was seconded by Mr. Aguglia to accept Chief Holtgraver's resignation/retirement letter, with regret. Motion was approved and ordered.*

The Mayor said that it was his privilege and honor to recommend Officer Bruce A. Fromlak as the Acting Police Chief. Bruce had been serving as Acting Police Chief since January 29th, as permitted by Borough Code. The Mayor would like to formalize this appointment with a Motion from Council and then he would like to officially swear him in.

The Mayor said Bruce had been serving the Borough since 1985 and he is a very effective and dedicated Officer for the past 26 years.

Motion to appoint Bruce A. Fromlak as Acting Chief of Police was made by Mr. Schell and seconded by Mr. Aguglia. Motion was approved and ordered by Council.

The Mayor swore in Bruce A. Fromlak as Acting Chief of Police at the Podium and Chief Fromlak was applauded by all. Mrs. Bernhard thanked Chief Fromlak on Council's behalf and Chief Fromlak said that he was honored and humbled to receive this appointment and looks forward to working with everyone on Council and within the Borough.

The Mayor said that he would like to recommend to Council to set Chief Fromlak's rate of pay for Acting Chief of Police at \$2.00 more per hour than the Lieutenant's salary. *Motion to approve the Mayor's salary recommendation was made by Mr. Schell and was seconded by Mr. Aguglia. Motion was approved and ordered.*

Report from the Secretary/Manager - Kenneth J. Wolf

Mr. Wolf said the Auditors are still working on the Borough's 2010 Audit.

Report from the Acting Police Chief - Bruce A. Fromlak

Chief Fromlak announced he had received information today that the Borough will receive Grant proceeds in the amount of \$9,990.00 that was previously applied for through the Pennsylvania Commission of Crime and Delinquency. This Grant was used in the purchase of a speed trailer. The trailer would be placed within the Community and is radar operated. This is not for speed enforcement, but for public education, posting the speed limit and the actual speed of the motorist. The system includes a data recorder which will produce time and day traffic speed monitoring reports.

Mrs. Bernhard questioned if this was a movable object and Chief Fromlak said yes and

added that the purchase of a digital camera system for the next new Police Cruiser is included in the Grant money.

Report from the Solicitor - Fred E. Baxter

Mr. Baxter had no report for Council.

Report from Glenn Engineering - Robert E. Zischkau

Mr. Zischkau reported that the North Hills Council of Governments has issued a notice to proceed to the contractor for the demolition of 226 - 226 ½ Martsolf Avenue, which may be scheduled to begin as early as next week. Due to the nature of the demolition, with the close proximity of the building next door, Mr. Zischkau plans to have a project representative on sight to make sure there are no problems with the adjoining property.

Mrs. Bernhard said she was glad to hear this report.

REPORTS FROM THE COMMITTEES

Finance Report - Ralph R. Burchell

Mr. Burchell said the Wage Tax collection deposits for the month of January totaled \$111,066.56. The Borough's net proceeds were \$54,880.33.

The Capital Reserve - UDAG CD in the amount of \$28,500.00 matured on January 3rd after earning interest in the amount of \$2.34. A new CD was purchased on that same day in the amount of \$28,500.00.

Mr. Burchell said the Liquid Fuel CD in the amount of \$10,000.00 matured on January 3rd after earning interest of \$0.92. A new CD purchased on that same day in the amount of \$10,000.00.

The Building Fund Money Market Account had a balance of \$197,762.74 as of January 31st. That account had earned interest of \$33.59.

The General Fund Money Market Account had a balance of \$277,360.01 as of January 11th. That account had earned interest of \$112.44.

Mr. Burchell said we did receive our 2011 Tax Anticipation Loan. That Loan was in the amount of \$500,000.00.

Real Estate Tax collections for the month of January totaled \$8,328.86. These Funds were deposited into the General Fund Checking Account to offset Borough expenditures.

Mr. Koerts had no report for Council.

Public Works Report - Barry G. Schell

Mr. Schell said the Borough Workers are still taking down the Christmas decorations and we have ordered 2,350 Tons of road salt to date. They are patching potholes in the Borough as they are found and are taking care of street and traffic sign maintenance, as well as removing snow and ice.

Mr. Schell said he had good news, being a settlement has been reached with the union for a contract and it will be decided under this evening's Agenda. The contract will run from October 1, 2010 through December 31, 2013, with wage raises of 2 ½%, 2 ½% and 3% per year. The employees will be contributing to their health insurance, as they will be using UPMC HSA \$1250 and will contribute through a 4% payroll deduction with a ceiling of \$65.00 per month in the second year and contributing 5% with a ceiling of \$75.00 per month for the third year.

Police and Public Safety Report - William F. Aguglia

Mr. Aguglia would like Council to consider approving the Police contract, which is in tonight's Agenda. The contract is a three-year contract from January 1, 2011 through December 31, 2013, with 2.5%, 3% and 3% yearly wage increases. The Police would also change their health insurance to UPMC HSA and would contribute 5% in the second and third year, with a \$75.00 per month cap. Mr. Aguglia feels that the Attorney Vickie Beatty and the Committee Members have come up with a viable contract.

Administrative / Budget Report - Ralph R. Burchell

Mr. Burchell had no report for Council.

Fire and Water Report - Donald E. Mikec

Mr. Mikec read a letter dated December 22, 2010 from Joseph Assisi, who had been the Fire Chief for West View Volunteer Fire Department for 25 years. Mr. Assisi thanked Council for all of their help over the years while he served the Community as Fire Chief. Mr. Mikec extended his thanks to Joe for his years of service and then welcomed George Hollenberger as the new Fire Chief, as of January, 2011.

Mr. Mikec said the West View Volunteer Fire Department responded to 18 Calls for the month of January 2011.

Mrs. Bernhard extended her thanks to Joe Assisi and said she would like to send a letter to Joe to thank him for his years of service.

Public Relations and Recreation Report - M. Kimberly Steele

Ms. Steele said the Senior Citizen Spring Luncheon will take place on April 29th at the West View Banquet Hall. Seniors will have lunch and entertainment at a cost of \$10.00 per Senior. The next Crime Watch Meeting will be held on Monday, March 14, 2011 at 7:00 p.m. in the West View Banquet Hall and Members of the West View Volunteer Fire Department and Ross/West View Emergency Medical Services Authority will be attending to present the Program.

Ms. Steele said the West View Chamber of Commerce has some events scheduled, such as a trunk sale on May 1st, a Community Day for Saturday, June 11, 2011 and the Farmer's Market is scheduled to begin on May 3, 2011. More information will be given when it is received from the Chamber.

Mrs. Bernhard added that she had attended Monday's Crime Watch Meeting where Magistrate Opiela had a good program. The Magistrate advised the Community to keep an eye on property maintenance issues and to report them before they get out of hand.

Roll Call was taken by Mr. Wolf. Members of Town Council present were: President Mary C. Bernhard, Vice President Barry G. Schell, Member William F. Aguglia, Member John W. Koerts, Member Donald E. Mikec, Member Ralph R. Burchell and Member M. Kimberly Steele. Also attending were: Secretary/Manager Kenneth J. Wolf, Assistant Secretary Patricia A. Rapp, Acting Chief of Police Bruce A. Fromlak, Solicitor Fred E. Baxter and Robert E. Zischkau from Glenn Engineering. Mayor J. R. Henry was absent.

Motion to approve the Minutes of the Regular Meeting of Town Council on February 9, 2011 was made by Mr. Schell and was seconded by Mr. Koerts. Motion was approved and ordered.

Motion to approve the payment of general fund expenditures for net pay and payroll withholding in the amount of \$133,914.70 and payments to vendors in the amount of \$161,284.37 was made by Mr. Burchell and was seconded by Mr. Aguglia. Motion was approved and ordered.

Motion to approve the payment of building fund expenditures in the amount of \$958.03 was made by Mr. Schell and was seconded by Mr. Koerts. Motion was approved and ordered.

Motion to approve the payment of liquid fuel fund expenditures in the amount of \$36,665.25 was made by Mr. Schell and was seconded by Mr. Aguglia. Motion was approved and ordered.

Report from the Mayor - J. R. Henry, Mayor (Absent)

In the Mayor's absence, Mrs. Bernhard read the Mayor's report for the month of February 2011 as follows:

Report from the Secretary/Manager - Kenneth J. Wolf

Mr. Wolf discussed Agenda Item #1, which is the Insurance Proposal for General Liability from MRM Property & Liability Trust through the HDH Group, Inc. totaling \$77,616.00. Mr. Wolf said this Proposal includes property/commercial liability, automobiles, public officials, employment practices, police professional, as well as a blanket replacement value, with a limit of \$790,000.00 for traffic signal controls coverage. Mr. Wolf said last year's cost was \$76,642.00 without the signal coverage and Mr. Wolf recommends Council consider approving this Proposal.

Report from the Acting Chief of Police, Bruce A. Fromlak

Chief Fromlak said he has gotten together with the Foreman of the Road Crew, Mr. Assisi, and they plan to tour the Borough in order to evaluate street signs. The Chief has plans for the removal of outdated, redundant signage, replacing damaged signs or adding new signs where necessary.

Report from the Solicitor - Fred E. Baxter

Mr. Baxter said Council will consider Agenda Item #6, which is an Agreement between John P. Florio of 45 Vassar Avenue and the Borough of West View. Solicitor Baxter said the Borough was involved in a law suit a few years ago. Mr. Florio was getting insufficient flow in his sewer system at this property and it was due to the old design of the sewer system. Solicitor Baxter said this is a health violation that the Borough would be responsible.

The Solicitor and Mr. Zischkau came up with the solution to install a grinder pump, reversing the pressure and stopping the sewage backup. The Agreement would install the pump, with part of the cost being paid for by the Borough's Insurance Company.

The Agreement has been recommended by the Borough Solicitor as an acceptable Agreement for both the Property Owner and for the Borough of West View for a sewer backup problem at this address.

Report from Glenn Engineering - Robert E. Zischkau

Mr. Zischkau reported on the demolition of the property at 226 - 226 ½ Martsolf Avenue. Mr. Zischkau said the Contractor must do site grading, remove the gas pipe to terminate the service, and needs to cleanup the site. Mr. Zischkau was pleased that there was no damage sustained to the abutting property. Mr. Zischkau said he had met with Mr. Schell and the Contractor to test the generator installed at the Borough Building. The test was successful, everything was operable and the generator worked as planned.

REPORTS FROM THE COMMITTEES

Finance Report - Ralph R. Burchell

Mr. Burchell said the Wage Tax collection deposits for February totaled \$145,202.23. The Borough's net proceeds were \$70,301.05.

Mr. Burchell said the Capital Reserve UDAG CD in the amount of \$28,500.00 matured on February 2nd, after earning interest in the amount of \$2.34. A new CD was purchased on that same day in the amount of \$28,500.00.

Our Liquid Fuel CD in the amount of \$10,000.00 matured on February 2^{nd} , after earning interest in the amount of \$0.82. A new CD was purchased on that same day in the amount of \$10,000.00.

The Building Fund Money Market Account earned interest of \$30.34. That account had a balance of \$197,793.08 and that was as of February 28th.

The General Fund Money Market Account earned interest of \$111.91. That account had a balance of \$707,471.92 and that was as of February 9th.

Property and Purchasing Report - John W. Koerts

Mr. Koerts had no report for Council.

Public Works Report - Barry G. Schell

Mr. Schell said the Road Crew has taken down the Borough's Christmas decorations. The Borough has ordered 2,550 tons of road salt for the 2010 - 2011 winter season and they are fixing potholes and street signs. Mr. Schell said the Road Crew did an outstanding job with snow removal and Mr. Schell said the Borough was clean and other Municipalities were not.

Mr. Schell said, on March 26th, we will have a yard waste pickup throughout the Borough. Mr. Mikec said he has received numerous compliments from Residents of West View, commending the job the Road Crew did this winter in keeping the roads clear. Mr. Mikec said he would like to commend them himself.

President Bernhard said the Crew has done a wonderful job. Mrs. Bernhard had many people stop her to tell her they know that once they get to West View, they can get home, which is good to hear, and she commends the Road Crew for their good work.

Police and Public Safety Report - William F. Aguglia

Mr. Aguglia reported that, under the Agenda, Council will consider hiring a Full-Time Officer from the Eligibility List supplied by the Civil Service Commission. Civil Service completed the testing and supplied Council with the top three Candidates.

Mr. Aguglia recommends the consideration of Officer Gary Pavlecic as Full-Time Police Officer. Mr. Aguglia recommended Council consider appointing Officer Bruce Fromlak as Chief of Police, effective Saturday, March 12, 2011. Mr. Aguglia said the appointment of Gary Pavlecic to Full-Time would be effective Saturday, March 19, 2011.

Administrative/Budget Report - Ralph R. Burchell

Mr. Burchell said he had no report for Council at this time.

Fire and Water Report - Donald E. Mikec

Mr. Mikec said the West View Volunteer Fire Department responded to 19 calls during the month of February. Mr. Mikec said he had read the resignation letter from Joseph Assisi at the last month meeting but neglected to welcome the new Fire Chief George Hollenberger, effective January 1, 2011.

Public Relations and Recreation Report - M. Kimberly Steele

Ms. Steele said the next meeting of Crime Watch is going to be held Monday, March 14, 2011 and Members from the West View Volunteer Fire Department and Ross/West View EMSA will be presenting the Program.

Ms. Steele said the Committee is accepting applications for the use of Bronx Field and the Senior Citizen Party is scheduled for April 29th. The Recreation Committee has met and they are planning the Recreation Program and the Summer Safety Bike Rodeo Project. Ms. Steele will pass on more information and more details as they become available.

AUDIENCE

President Bernhard welcomed everyone to the Meeting on the behalf of Town Council. Mrs. Bernhard said that Council welcomes comments from any Borough Resident who would like to do so. All that we ask is that when addressing Council, you follow these procedures:

Each Individual will give their name and address. Each Individual will be limited to a maximum time period for questions and answers of five minutes and will be notified when there is one minute remaining.

If the Individual has not used their allotted five minutes, the Individual will be permitted to finish their five minutes, only after all Individuals wishing to address Council are heard.

Mrs. Bernhard said that in no event will Public comments extend beyond thirty minutes unless Council is of the opinion that those wishing to address Council cannot be heard. In this event, Council will extend the thirty minute time periods, if necessary. This extension will not allow Individuals that have already used their five minutes to further their time to address Council.

Mrs. Bernhard said, if your comments require an answer, Council will try to provide an answer at this time. If Council cannot provide an answer, they will give the Individual the proper directions to help get the information they seek.

Mrs. Bernhard said she would like to advise that Council is here to listen to comments and help when it is possible but Council is not here to debate opinions. Mrs. Bernhard welcomed Residents to step forward, giving their name and address.

Dave Urban of 60 Lakewood Avenue said he does not feel the need to send Borough Workers praise from Council, as he feels they are well compensated to do their job.

Mr. Urban complained of getting asphalt chips on his new car and said the way the Road Crew does their asphalt is not the way to do it. He wants them to put a sign out when they are patching so he could go the other way. He said he told Ken Wolf this all before and he wants them to use a vibrating machine to tamp it instead of backing a truck over the asphalt. Mr. Urban said using the truck is stupid and wastes gas.

Mr. Urban questioned the Borough Solicitor on how much money the Agreement with 45 Vassar was going to cost the Borough, as he never mentioned a dollar figure, and questioned Council why the Borough needs another Full-Time Officer since it costs more. Mr. Urban questioned Council on how they decided to go about making Bruce Fromlak the Chief of Police.

Solicitor Baxter said, to have a Contractor install a grinder pump, would cost \$19,000.00. The Solicitor said this would be a one-time payment and Borough's Insurance Carrier will pay \$5,000.00 and the rest of the money will come from the Borough's sewer rental money from West View Water Authority.

Mr. Wolf said the Road Crew shovels patch in the pothole and then runs a truck or the highlift over the patch. Mrs. Bernhard asked Mr. Wolf to have the Crew tamp it down better and maybe use a sign the next time.

Mr. Aguglia said he heads the Police and Public Safety Committee and said the Committee considered Officer Fromlak's qualifications, being an Officer for years, being in the Military and being in Iraq, his leadership ability, and Mr. Aguglia said it was

decided he was a person that could lead the Borough. Mr. Urban asked if other Officers were considered since Officer Fromlak was gone 90% of the time and he was not here patrolling.

Mr. Aguglia said he is here to make these decisions and they felt Officer Fromlak is the best decision to lead the Borough. Mr. Aguglia said Officer Pavlecic's been a Part-Time Officer for three years and passed all of the qualifications. Mr. Urban questioned how many Officers live in the Borough and was informed by Officer Fromlak that two Full-Time out of ten Full-Time live in the Borough.

Mr. Urban was in front of Council for five minutes.

Jim Barr from 200 Frankfort Avenue questioned Council on how many Members are on the Public Safety nominating Committee. Mrs. Bernhard said three Members are on the Public Safety Committee and explained the Police Candidate testing procedure to Mr. Barr.

Mr. Barr questioned if the Committee meetings are public and he questioned Sunshine Law compliance when he was told they are not public and need not be advertised.

Mr. Barr said he tried to get a copy of the Public Works Labor Contract and could not and wanted to know the status of the Contract. Mrs. Bernhard said Council has signed the Contract and now the Union has the Contract to review and sign. It will be returned to the Borough. Mr. Barr questioned if they were working without a Contract and Mr. Baxter explained the changes in the language and said the Crew is working under the new Contract, as it had been agreed upon with no problem.

Mr. Baxter said there is no problem with either Contract and expected its return to the Borough within a reasonable time.

Mr. Barr was in front of Council for five minutes.

Dave Urban from 60 Lakewood Avenue questioned Council on how many Full-Time Officers we have and how many Part-Time.

Chief Fromlak said the Borough has 10 Full-Time Officers.

Mr. Urban questioned how many Officers live in the Borough. Chief Fromlak said both himself and Detective Towne live in West View and 8 Officers live outside of West View. Mr. Urban questioned how many Part-Time Officers we have. Chief Fromlak said one and he lives outside of the Borough.

Mr. Urban questioned how many Borough Workers we have and do they all live in the Borough. Mrs. Bernhard said we have 7 and they all live in West View and we only use Part-Time Workers in the Summer.

Mr. Urban questioned a Motion from February's Minutes. He said he had questioned Mr. Wolf about the Motion to give the 4 Full-Time Employees a 2 ½% increase in their salary. Mr. Urban believed they already received 2% and the 2 ½% increase would equal 4 ½%. Both Mrs. Bernhard and Mr. Burchell explained the raises and the budget process and said the Employees were increased ½% to equal a total of 2 ½%, which coincides with the Union Members raise.

Mayor Henry added the Union Contracts were not settled and the Budget was passed with Council's best projection. The Mayor said that due to the State Law, the Borough is required to have a Budget passed by December 31st.

Mr. Urban asked if the Union Contracts are now available to the Public for copies and Mrs. Bernhard said yes, they are available.

Mr. Urban was in front of Council for 5 minutes.

Jim Barr from 200 Frankfort Avenue questioned Council regarding the Bids for work on the Building and asked when the Bids were requested. Mr. Wolf said there was no Bid advertisement, as the Bids were below \$4,000.00.

FINANCE REPORT - Ralph R. Burchell

Mr. Burchell said last month he had reported an incorrect amount for the Borough's share of the wage tax collection. The correct amount was \$38,704.90 for March and Mr. Burchell wanted this put on record. Mr. Burchell said the April collections were \$338,970.17. The Borough's net proceeds were \$165,230.07. These funds were deposited into the General Fund Checking account.

The Capital Reserve – UDAG CD in the amount of \$28,500.00 matured on April 3rd after earning interest of \$2.34. A new CD was purchased on that same day for \$28,500.00.

The Liquid Fuel CD in the amount of 10,000.00 matured on April 3^{rd} . That earned interest of less than one dollar, 0.82. A new CD was purchased on April 3^{rd} in the amount of 10,000.00. We did receive our 2011 Liquid Fuel proceeds, that amount was 133,220.52.

Mr. Burchell said the Building Fund Money Market Account had a balance of \$197,858.12 as of April 29th. That account had earned interest of \$31.44.

The General Fund Money Market Account had a balance of \$291,639.51 as of April 11th. That fund had earned interest of \$72.37. These proceeds were left in the Borough's Money Market. Account, as it was paying a little higher interest.

PROPERTY AND PURCHASING REPORT - John W. Koerts

Mr. Koerts addressed Item #2 on the Agenda. Mr. Koerts proposed Council table the quotation/proposal until next month to further investigate the costs.

PUBLIC WORKS REPORT - Barry G. Schell

Mr. Schell reported the Public Works Crew has been cutting grass, fixing playgrounds and working on Bronx field. The Crew has been doing the electrical work on the decorative lights up and down the Highway.

They are patching potholes throughout the Borough and are taking care of traffic signs and street signs. When checking with the telephone company, this would enable them to place long distance calls and bill them to your phone number.

Ms. Steele said the Crime Watch meetings have concluded until September, but they should have a list of upcoming Programs to announce prior to September.

Ms. Steele said the West View Summer Safety Program will be held on Saturday, June 4th from Noon until 3:00 p.m. at the #3 Fire Company at 471 Perry Highway. The Program is sponsored by the West View Volunteer Fire Department, the West View Police Department, VFW Post #2754, the VFW Women's Auxiliary, State Representative Adam Ravenstahl, West View Recreation Committee and West View Crime Watch. This is a free event with fingerprinting, bike inspections, safety topics, games and refreshments.

The Summer Recreation Program will take place at West View Elementary, Monday through Friday, from 9:00 a.m. until 3:00 p.m., beginning on June 27th through August 5, 2011. This Program is free to all West View Children grades one through six.

AUDIENCE

President Bernhard welcomed everyone to the Meeting on the behalf of Town Council. Mrs. Bernhard said that Council welcomes comments from any Borough Resident who would like to do so. All that we ask is that when addressing Council, you follow these procedures:

Mr. Burchell said the Building Fund Money Market Account had a balance of \$197,892.81 as of May 31st. That account had earned interest in the amount of \$34.69 for the month.

The General Fund Money Market Account had a balance of \$316,679.83 as of May 10th. That account had earned \$40.32 of interest.

PROPERTY AND PURCHASING REPORT - John W. Koerts

Mr. Koerts referred to Agenda Item #2, which are the quotations for the rehabilitation to the curb and concrete barrier. Mr. Koerts wants Council to consider having this work done in house, probably at a lesser cost.

Mr. Koerts requested Council consider tabling Item #4, which is the Holly Ridge Web design to update the Borough's website. Mr. Koerts wants Council to consider the cost before deciding.

Mr. Koerts requested Council authorize Barry Schell to look into bids for the purchase of a new five-ton truck, complete with plow and spreader for the Public Works Department.

PUBLIC WORKS REPORT - Barry G. Schell

Mr. Schell said the Public Works Department has been busy cutting grass, fixing playgrounds and doing maintenance on Bronx Field. They have done electrical work on our decorative lights and have fixed 95% of them. They have been patching potholes, taking care of street lights and traffic signs. Mr. Schell said the Men are doing a fine job.

POLICE AND PUBLIC SAFETY REPORT - William F. Aguglia

Mr. Aguglia reported the Borough's K-9 was used to apprehend a male who ran from Officers during a traffic stop. The male ran because he had an active PFA and was in the vehicle with the person he was not to have contact with.

Mr. Aguglia said a female was arrested for DUI and possession of marijuana after Officers initiated a traffic stop and the female was found to be impaired and she was charged. Mr. Aguglia said a female was arrested in the Magistrate's office after it was found that she had brought drugs into the office. The woman was found guilty after charges were filed through the Magistrate.

Mr. Aguglia said a male was arrested in the Plaza after he was found to be carrying crack cocaine and heroin, along with pills that he did not have a prescription for. Mr. Aguglia said a

juvenile female is going to be charged with terroristic threats after it was determined that she 0.933 had been sending threatening text messages to a classmate.

Mr. Aguglia passed on information regarding driving in the rain. Mr. Aguglia read an article that said it has been proven to wear sunglasses while driving in the heavy rain and the sunglasses help the driver to see better, especially through spray and splashes from other vehicles.

ADMINISTRATIVE / BUDGET REPORT - Ralph R. Burchell

Mr. Burchell requested an Executive Session to discuss a personnel matter and requested it be at the end of the meeting. President Bernhard said the session will be held at the end of the meeting.

FIRE AND WATER REPORT - Donald E. Mikec

Mr. Mikec reported the West View Volunteer Fire Department responded to 28 calls during the month of May 2011 and Members attended FF1 classes several times during May.

PUBLIC RELATIONS AND RECREATION REPORT - M. Kimberly Steele

Ms. Steele thanked everyone for participating in the Summer Safety Program that was held last Saturday. Ms. Steele thanked the Chief, Barb O'Lare and Matt Holland for putting the event together and thanked Rich Rapp from the West View Volunteer Fire Department. Ms. Steele also thanked Ross/West View EMSA, the West View Crime Watch, West View Recreation, the West View Post #2754 VFW and VFW Auxiliary and all of the local merchants donating food and door prizes.

Ms. Steele extended her thanks to State Representative Adam Ravenstahl for doing a special mailing to Borough Residents to alert them about the Summer Safety Project/Rodeo.

Ms. Steele is still taking applications for the summer recreation program, which starts Monday, June 27th.

AUDIENCE

President Bernhard welcomed everyone to the Meeting on the behalf of Town Council. Mrs. Bernhard said that Council welcomes comments from any Borough Resident who would like to do so. All that we ask is that when addressing Council, you follow these procedures:

Paul Pokorny from 50 Tomoka Avenue presented Council with aerial photos of some properties. Mr. Pokorny addressed Lot 217 C 45, extending up to 217 C 47 and 217 C 40 up to 217 C 45. Mr. Pokorny acquired 2 of these lots recently and questioned if the Borough had planned to develop on these 10 lots. Mr. Pokorny questioned Palatka Alley and Marco Alley access to the 10 lots and questioned if the Borough may be interested in developing the lots for extra revenue for the Borough.

The Mayor asked if Mr. Pokorny had discussed this matter with Mr. Wolf, to which Mr. Pokorny said no, saying he was unsure on what steps to take. Mr. Pokorny would like to have houses built on the vacant lots.

Solicitor Baxter said that normally Municipalities are not in the business for developing lots but felt the Borough would be more than willing to cooperate with any individual or developer to open roadways to access a development. The Solicitor said the Borough normally does not expend money to put in the roadway or do the development, as the Borough is not permitted to do so in accordance with the law.

Mayor Henry suggested Mr. Pokorny talk to the Borough Manager to find out all of the steps he would need to take to develop this property, as he feels this is the best place for Mr. Pokorny to start.

Mr. Pokorny was in front of Council for five minutes.

Dave Urban from 60 Lakewood Avenue questioned Council if the Special Meeting on May 26th had been published and what was the meeting about. Mrs. Bernhard said it was advertised in the paper and it was an executive meeting and not an open forum. The meeting was to discuss personnel matters and was advertised. Mr. Urban said he did not see it in the Post Gazette.

Mr. Urban questioned how many summer help was the Borough hiring. Mr. Wolf said one will be working right now and he is returning from last year, Bobby Serpa. Mr. Urban questioned if

more would be hired and Mr. Wolf said right now, we have hired one. Mr. Schell said two other applications are out but have not been returned and Mr. Schell would check into the applications once received, possibly put them on and ratify it in July, but right now, Mr. Schell could do nothing.

Mr. Barr questioned if there were three gentlemen from the Freedman family that served the Borough. The Mayor and the Chief explained that Ralph, Randy's Father, served as an Officer, along with Ron, Randy's brother, all for West View and their Sister was an Officer in Florida and their Brother, Ralph was Ross Township's Chief.

Mr. Barr questioned when holding a special meeting was discussed. Mrs. Bernhard said they decided to hold a special meeting during the executive session at the May meeting. The meeting was called to order at 7:00 p.m. by President Bernhard, followed by a moment of silent prayer and the pledge of allegiance to the flag.

Mr. Wolf conducted Roll Call.

Members of Town Council present were: President Mary C. Bernhard, Vice President Barry G. Schell, John W. Koerts, Donald E. Mikec, Ralph R. Burchell and M. Kimberly Steele. Also attending were: J. R. Henry, Mayor, Kenneth J. Wolf, Secretary/Manager, Fred E. Baxter, Solicitor, Robert E. Zischkau from Glenn Engineering, Police Chief Bruce A. Fromlak and Assistant Secretary Patricia A. Rapp. Council Member William F. Aguglia and Fire Chief George Hollenberger were absent.

Motion to approve the Minutes of the Regular Meeting of Town Council on June 8, 2011 was made by Mr. Schell and was seconded by Mr. Koerts. Motion was approved and ordered.

Motion to approve the payment of general fund expenditures for net pay and payroll withholding in the amount of \$126,665.56 and payments to vendors in the amount of \$180,181.31 was made by Mr. Burchell and was seconded by Mr. Mikec. Motion was approved and ordered.

Motion to approve the payment of building fund expenditures in the amount of \$6,122.95 was made by Mr. Schell and was seconded by Mr. Koerts. Motion was approved and ordered.

Motion to approve the payment of liquid fuel fund expenditures in the amount of \$5,198.46 was made by Mr. Mikec and was seconded by Mr. Schell. Motion was approved and ordered.

REPORTS FROM THE OFFICERS

Report from the Mayor - J. R. Henry, Mayor

The Mayor said his report for June 2011 was within Council packets and the total receipts were \$4,264.76. The Mayor advised residents to move their vehicles on street sweeping days to avoid being ticketed and said 63 tickets were issued in June, with 205 year-to-date.

The Mayor read the public notice for the stop sign that has been temporarily placed on Highland at Bellevue. The Ordinance will be legally advertised for Council to consider accepting the placement of the stop sign at the August meeting.

Mayor Henry introduced Katherine Risko, the Associate Director from CONNECT and welcomed her to the podium.

Ms. Risko addressed Council and said CONNECT is the congress of neighboring communities center for metropolitan studies and was formed to provide various community services for the municipalities surrounding the City of Pittsburgh. The Chief will be setting up the details to issue the new vests to our Officers.

Finance Report – Ralph R. Burchell

Mr. Burchell said wage tax deposits for the month of June totaled \$26,566.45. The Borough's net proceeds were \$13,153.19.

The Capital Reserve - UDAG CD in the amount of \$28,500.00 matured on June 2nd after earning interest of \$2.34. A new CD was purchased on that same day in the amount of \$28,500.00.

The Liquid Fuel CD in the amount of \$10,000.00 matured on June 2nd after earning interest of \$0.82. We purchased a new CD on that same day the amount of \$143,000.00.

Our capital reserve-UDAG checking account had a balance of \$ 28,948.24 as of October 31ST. Our liquid fuel checking account had a balance of \$ 143,414.09 as of October 31st.

Mr. Aguglia reported that our building fund money market account had a balance of \$ 198,028.39 as of October 31st, after earning interest in the amount of \$ 16.82. Our general fund money market account had a balance of \$ 766,880.93 as of October 31st, after earning interest in the amount of \$ 45.77. Mr. Aguglia reported that the real estate tax collection for the month of October totaled \$ 36,493.68.

Property and Purchasing Report – John W. Koerts

Mr. Koerts reported that the windows upstairs in the borough building are the original windows and they need replaced. OFFICIAL BOROUGH OF WEST VIEW SPECIAL BUDGET WORKSHOP MINUTES NOVEMBER 15, 2011

Minutes of the Special Budget Workshop Meeting, held Tuesday, November 15, 2011 in Council Chambers at 441 Perry Highway, Pittsburgh, PA 15229. The Meeting was called to order at 5:30 p.m. by Mrs. Bernhard, followed by a moment of silent prayer and the pledge of allegiance to the flag.

Mrs. Bernhard read the special meeting notice advertised on November 12, 2011.

Roll call was taken by Chief of Police Bruce A. Fromlak/Manager at 5:35 p.m. President Mary C. Bernhard, Vice President Barry G. Schell, Member William F. Aguglia, Member John W. Koerts, Member Donald E. Mikec, Member Ralph R. Burchell and Member M. Kimberly Steele were present. J. R. Henry, Mayor was absent.

Chief Fromlak said the proposed 2012 Budget expectation is tax neutral but we will still be able to maintain all services without a tax increase in 2012.

Chief Fromlak reported on the Police capital, being maintained at \$45,000.00 since 2009. The Chief anticipates the purchase of an all-wheel drive or SUV type vehicle for the Police Department and said we were able to purchase a \$70,000.00 Truck for the Public Works Department in 2011 and any anticipated purchases in 2012 should not exceed \$12,000.00.

Chief Fromlak was happy to report the paving program has been completed and \$257,470.00 has again been budgeted for paving in 2012. Uniformed Employees will receive a 3% increase in wages in 2012 and Non-Uniformed Employees will receive a 2.5% increase in wages, both as per contract. The Borough's tax anticipation loan for 2012 should range between \$450,000.00 and \$500,000.00 and the Chief will receive quotes this coming Thursday. The Borough received a slight windfall from the Pension State aid, receiving \$8,000.00 above our projection for 2011.

The Chief addressed 2012's budget, revenues for real property taxes \$1,757,700.00, local tax enabling act \$725,100.00, penalty and interest on delinquent taxes \$22,100.00, business license and permits \$133,000.00, non-business license and permits \$7,000.00, fines \$60,600.00, earnings from investments \$1,000.00, federal grants \$74,700.00, State shared revenue \$103,000.00, local capital (sales tax from Act 77) \$150,000.00, payment in lieu of taxes \$3,500.00, charges for services \$17,500.00, special Police services \$71,000.00, highway and streets \$46,000.00, sanitation \$300.00, miscellaneous revenue \$2,500.00, bringing the total general fund revenues for 2012 at \$3,175,000.00.

Member Burchell addressed Act 32, regarding the unknown impact of the pending collection of our local income taxes. The timing of the receipt of the Borough's payments in 2012 will depend on how well the new collection system is conducted, but the Borough will closely monitor the 2012 collections.

Chief Fromlak said the 2012 proposed Budget for general fund revenues and expenditures is \$3,175,000.00, building fund is \$111,000.00, liquid fuel fund is \$128,900.00, proprietary fund is \$875,080.00, 2007 project account (sewer) is \$466,835.00, with the total 2012 revenues and expenditures being \$4,756,815.00, which is a 1.6% decrease over the 2011 budget, which is an anticipated savings projected for 2012.

President Bernhard requested that Chief Fromlak read the general fund expenditure items. Chief Fromlak said the projected general fund expenditures for 2012 for the legislative body is \$32,100.00, executive is \$34,100.00, financial administration is \$18,000.00, tax collection is \$120,400.00, law is \$19,200.00, clerk/secretary is \$51,800.00, engineer is \$21,200.00, police is \$1,071,000.00, fire is \$95,600.00, ambulance and rescue is \$12,100.00, protective inspection is \$4,000.00, planning and zoning is \$3,800.00, health is \$11,500.00, highway general services is \$225,350.00, cleaning of streets and gutters is \$35,800.00, snow and ice removal is \$110,700.00, traffic signals and street signs is \$22,000.00, street lighting is\$4,200.00, sidewalks and crosswalks is \$17,000.00, storm sewers and drains is \$34,500.00, repair of tools and machinery is \$16,600.00, repairs to highways and bridges is \$126,600.00, construction and rebuilding is \$257,500.00, parks is \$13,700.00, civil and military celebrations is \$9,100.00, senior citizen centers is \$18,650.00, the debt principal that was

paid off this year is zero, with the debt interest being \$10,000.00, retirement and pension contribution is \$137,800.00, insurance is \$214,900.00, employee benefits is \$425,800.00 and refunds of prior year revenues is zero, with a total 2012 expenditures being projected at \$3,175,000.00.

Member Burchell said the Borough's allocation for funding for ambulance and rescue is \$12,100.00 for 2012, as is all member municipalities and their projected funding requirement seems to have leveled off, with no anticipated increases being projected. Mr. Burchell requested a proposal from the independent auditor, Don Reddinger, and Mr. Burchell believes it will be a two-year proposal. Mr. Burchell said all employees cooperated in the past to help lower the high health care costs, changing to a different program in 2011, resulting in a lower health care expense cost. The current plan expires May 1, 2012 and the Borough will be aggressively pursuing new programs for employees. The employees are now contributing to the health insurance costs and have been instrumental in instituting a change over the old plan.

Member Mikec questioned the expense for the bookkeeper position and Mr. Burchell explained Council is still considering this matter for the future and will keep reviewing how the current operations are going.

Chief Fromlak read the building fund revenues for earnings from investments is \$300.00, rents of buildings is \$108,000.00, interfund operating transfers being zero, expenditures for law is zero, engineer is \$2,000.00, buildings and plant is \$101,000.00, zero for debt interest and general liability insurance is \$8,000.00, bringing the total 2012 building fund revenues and expenditures to \$111,000.00. The liquid fuel state shared revenue is \$128,900.00 and \$63,000.00 for highway maintenance for snow and ice supplies is a budgeted expense, along with \$65,900.00 for street lighting costs, bringing the total revenue and expenditures for 2012 for the liquid fuel fund to \$128,900.00. Capital Reserve UDAG fund revenues and expenditures are both zero and the proprietary fund (Alcosan) revenues and expenditures are both \$466,835.00 and this encompasses the general obligation serial bond for 2012.

Mr. Mikec questioned a typo on item 341 on the building fund revenue interest and Chief Fromlak said this error would be addressed. Mr. Burchell questioned the leasing under the building fund. Chief Fromlak said all facilities are currently being rented by the Borough and he is negotiating with the County regarding the Magistrate's current month-to-month lease. PNC has another year on their lease, Schorr's Bakery has two years, the smoke shop has two years with a third year option remaining and Dollar General has three years remaining and has expressed an interest to pursue a longer term lease (seven to ten years) with the Borough through the Chief.

The Chief addressed past liquid fuel allotments and expects a decrease for 2012 from the State for our road salt allotment. Mr. Burchell said a line item was added in the past to help budget for the deficiency in income received from the State for road salt reimbursement. The Chief said the Borough is locked into a \$63.00 per ton for salt for 2012.

Mr. Koerts had requested a different breakdown of the budget than had been presented to Council in the past and Mr. Koerts felt the Chief did a really good job of presenting this budget and extended his thanks. Mr. Mikec agreed and the Chief said he is only as good as the staff around him and that Patty Rapp had put the 2012 budget together. Mr. Burchell said the best news is that the Borough has a tax neutral budget for 2012.
