## **REGULAR MEETING – JANUARY 8, 2015**

Minutes of the regular meeting of the Town Council of the Borough of West View held Thursday, January 8, 2015 in Council Chambers at 441 Perry Highway, Pgh., PA 15229. President Schell called the meeting to order at 7:00 p.m., followed by a moment of silent prayer and the pledge of allegiance to the flag. Chief Fromlak conducted roll call. Members of Town Council attending: President Barry G. Schell, Vice President William F. Aguglia, Members Donald E. Mikec, M. Kimberly Steele, Bryan S. Kircher and Robert D. Schellhaas. Member Eugene Borio was absent. Also in attendance were: J. R. Henry, Mayor, Chief of Police Bruce A. Fromlak, Secretary/Manager, Asst. Sec. Patricia Rapp, Solicitor Michael J. Witherel, Robert E. Zischkau from Glenn Engineering and Fire Chief Mark Scheller. Junior Council Members Austin Babjak and Madison Hintemeyer were absent. Motion to approve the minutes of the regular meeting of Town Council on December 11, 2014 made by Mr. Aguglia was seconded by Ms. Steele. Motion approved and ordered.

Motion to approve payment for general fund for net pay and payroll withholding for \$156,922.90 made by Mr. Mikec was seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments to vendors for \$74,507.48 made by Ms. Steele was seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments for liquid fuel fund expenditures for \$4,680.43 made by Mr. Aguglia was seconded by Mr. Mikec. Motion approved and ordered. Motion to approve payments for building fund expenditures for \$10,536.03 made by Mr. Schellhaas was seconded by Mr. Kircher. Motion approved and ordered.

Reports from the Officers – Mayor's Report – J. R. Henry reported his report for the month of December totaled \$5,306.06 and for the year 2014, motor vehicle code violations for parking / tickets, vehicle code / magistrate, for ordinance and statute / magistrate, for Allegheny County DUI and for state shared vehicle code totaled \$61,580.57 and the report was within Council packets. Chief of Police/Secretary/Manager – Chief Bruce A. Fromlak reported the Borough's Auditors have been in to start the 2014 audit.

The Chief recommended the \$75,557 Costar purchase of a 2015 Ford F550 dump truck with plow and spreader, which is on the Agenda. Chief advised the Borough will take possession of the new Backhoe for Public Works tomorrow at a cost of \$55,650. The Chief said the Police handled 4,505 incidents in 2014. Report from the Solicitor – Michael J. Witherel had no report for Council. Report from Glenn Engineering – Robert E. Zischkau updated Council on the progress of getting tentative meeting dates with Limerick Construction regarding the intersections along Perry Hwy. Fire Chief Mark Scheller had no report for Council.

Reports from the Committees - Finance Report – Bryan S. Kircher reported wage tax collection deposits for December were \$1,386.27, with the Borough's net proceeds at \$693.14. A total of \$92,829.06 was deposited into the general fund checking account by Keystone Collections. Our liquid fuel checking account had a balance of \$166,205.91 as of December 31<sup>st</sup> and earned \$7.51 interest. Our building fund money market account had a balance of \$33,438.79 as of December 31<sup>st</sup> and earned \$1.51 in interest. Our general fund money market account had a balance of \$950,226.40 as of December 31<sup>st</sup> and earned \$39.42 in interest. Our local services collection deposits totaled \$239.00 for December. The Borough's net proceeds were \$216.02. Business and mercantile collection deposits totaled \$302.43 for December. The Borough's net proceeds were \$151.22. Real Estate tax collection deposits in December totaled \$7,759.79. Property and Purchasing Report – Eugene Borio was absent. Public Works Report – Robert D. Schellhaas reported Public Works had completed 17 work orders in December 2014. The Crew is changing faded street – 5 sweeping signs, doing street sweeping and filling holes with cold patch. The Crew completed 332 work orders in 2014, along with repairing 13 storm sewers, while cleaning out 33. The Road Crew used 87 tons of hot mix patching holes in 2014. Mr. Aguglia had no report for Police and Public Safety and Mr. Kircher had no Budget / Administration report. Fire and Water Report – Donald E. Mikec reported that the West View Volunteer Fire Department handled 30 calls in December of 2014 for an average of 143.95 man hours. The WVVFD responded to 337 incidents in 2014, averaging 28 per month at 1,492.66 man hours, with an average of 124.4 per month. Public Relations and Recreation Reports – Ms. Steele had no report for Council. Junior Council Members Babjak and Hintemeyer were absent.

There was no audience participation and no unfinished business and, under new business, Mr. Schell requested Council consider changing the April 9<sup>th</sup> meeting of Town Council to Thursday, April 2<sup>nd</sup>. Motion to advertise the change of meeting date for Thursday, April 2<sup>nd</sup> was made by Mr. Mikec and seconded by Mr. Aguglia. Motion approved and ordered.

Agenda – Item # 1 – Council to consider the purchase of a 2015 Ford F550 Dump Truck with Plow and Spreader. The Chief explained the purchase is for the Department of Public Works through Costar Contract #025-125 through A & H Equipment. The original quote was for \$76,031.00 and \$474 had been knocked off of the total price. Chief Fromlak requested Council consider this purchase at a total cost of \$75,557.00. Motion to approve the purchase was made by Mr. Kircher and seconded by Mr. Mikec. Motion approved and ordered. There were no announcements.

Adjournment – Mayor Henry requested Council retire to an executive session to discuss a personnel matter. President Schell advised no further business would be discussed when Council returned from the session, other than adjournment.

Council retired to executive session at 7:13 p.m.

At 7:39 p.m. Council returned from session and Motion to adjourn was made by Mr. Kircher and seconded by Ms. Steele. Motion approved and ordered. The Meeting adjourned at 7:39 p.m.

## REGULAR MEETING MINUTES – FEBRUARY 12, 2015 - BOROUGH OF WEST VIEW

Minutes of the regular meeting of the Town Council of the Borough of West View held Thursday, February 12, 2015 in Council chambers at 441 Perry Hwy., Pgh., PA 15229. The meeting was called to order at 7:00 p.m. by President Barry G. Schell, followed by a moment of silent prayer and the pledge of allegiance to the flag. Chief Fromlak conducted roll call. Members present were: President Barry G. Schell, Vice President William F. Aguglia, Members Donald E. Mikec, M. Kimberly Steele, Bryan S. Kircher, Robert D. Schellhaas, Jr. and Eugene Borio. Also attending were: J. R. Henry, Mayor, Chief of Police/Secretary/Manager Bruce A. Fromlak, Assistant Secretary Patricia A. Rapp, Solicitor Michael J. Witherel, Robert E. Zischkau from Glenn Engineering and Fire Chief Mark W. Scheller. Junior Council Members Adam Babjak and Madison Hintemeyer were absent.

Motion to approve the minutes of the regular meeting of Town Council on January 8, 2015 made by Mr. Aguglia was seconded by Ms. Steele. Motion approved and ordered. Motion to approve payments for general fund for net pay and payroll withholding for \$137,186.84 made by Ms. Steele was seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments to vendors for \$66,426.09 made by Mr. Aguglia was seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments to vendors for \$66,426.09 made by Mr. Aguglia was seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments for liquid fuel fund expenditures for \$4,741.20 made by Mr. Mikec was seconded by Mr. Aguglia. Motion to approve payments for building fund expenditures for \$4,408.29 made by Mr. Borio was seconded by Mr. Mikec. Motion approved and ordered.

Reports from the Officers – Report from the Mayor – J. R. Henry, Mayor reported the January 2015 motor vehicle code violations totaled \$3,207.13. The Mayor updated Council about proposed changes to the Route 19 and Highland Avenue intersection, being the addition of left hand stacking lanes on both Highland and north on Perry. The \$70,000 Highland project would be funded through the Highland project developers, but the Mayor would like to have the Perry work done at the same time, which would be at the Borough's cost. Though the cost for the project is estimated high at \$200,000 by Wooster (traffic engineers for the developer and financing is currently available through Pennsylvania infrastructure banking for a 1.64% interest rate. The Mayor would like Council to add this as Motion Item #9 under the Agenda in order to have the Manager, Solicitor and Engineer pursue funding and move forward with paperwork to have this tentative project proceed. The Mayor would like to have the project run concurrently with the Highland project and both would be completed approximately within a year.

Chief of Police/Secretary/Manager Report – Chief Bruce A. Fromlak addressed the sign replacement program within the Borough. We are required to conform our street signs to federal requirements and the Chief had samples of conforming signs for Council and the Audience to view. The signs must begin being installed by 2016 and completed by 2018 at a cost of approximately \$7,000 for the entire Borough, not inclusive of the cost of the break-off posts for each sign. Report from the Solicitor – Michael J. Witherel reported on the lease agreement within Agenda Item #3. Mr. Witherel would like Council to consider Item #3's approval, contingent upon changes made to this lease by both himself and the Chief. Report from Glenn Engineering – Robert E. Zischkau had no report for Council. Fire Chief's Report – Mark W. Scheller – Chief Scheller reported on the Wisconsin trip to Pierce Manufacturing that he and some of the members of the WVVFD had taken to sign paperwork and see the progress of their new Ladder Truck. After the Chief attends a meeting with their Representative to view graphics for the truck, production will begin and Chief Scheller is anticipating the truck's delivery in July or August. The WVVFD is having a Cash Bash in April and tickets for this fundraiser are still available.

Reports from the Committees – Finance Report – Bryan S. Kircher said the wage tax collection deposits were \$775.83 for January with the Borough's net proceeds at \$378.92. A total of \$42,055.14 was deposited into the general fund checking account by Keystone Collections. Our liquid fuel checking account had a balance of \$65,023.60 as of January 31<sup>st</sup> and earned \$2.81 in interest. Our building fund money market account had a balance of \$33,440.17 as of January 31<sup>st</sup> and earned \$1.38 in interest. Our general fund money market account had a balance of \$950,271.89 as of January 31<sup>st</sup>, earning \$45.49 in interest. Our local services collection deposits totaled \$4,516.97 for January. The Borough's net proceeds were \$4,006.76. Business and mercantile collection deposits totaled \$29,682.85 for January. The Borough's net proceeds were \$14,856.43. Real estate tax collection deposits in January totaled \$14,876.11. Mr. Borio had no

report for Property and Purchasing. Public Works Report – Robert D. Schellhaas reported the Public Works completed 30 work orders in January and have used 680 tons of salt. The Crew repaired the steps on Glenmore and has taken down all of the Christmas decorations. Police and Public Safety Report – William F. Aguglia – Mr. Aguglia said that all of the Officers have completed their mandatory in-service training at the County Police Academy. Officers Chris Mann and Mike Stern are to attend a 5-day class March 2-6 at the Allegheny County 911 dispatch center for new County wide reporting system evaluation. Officer Stern will attend a 2-day class on March 24-25 to be certified Remington armor. Mr. Aguglia feels the police have been very visible in the Borough and have been patrolling the streets very well.

Mr. Kircher had no report for Budget / Administration. Fire and Water Report – Donald E. Mikec reported the West View Volunteer Fire Department responded to 28 calls, using 158 man hours in January. Mr. Mikec questioned Chief Scheller if the WVVFD will sell the old ladder truck. The Chief said the Department is running a for sale ad and if the truck should sell before the new truck is delivered, the Chief will rely on mutual aid for ladder truck support. Public Relations Report – M. Kimberly Steele – Ms. Steele said the next Crime Watch meeting will take place on Monday, March 9 and Brian Opiela will present a program on computer safety. For her recreation report, Ms. Steele said the Borough Crew has been working on an ice skating rink at Bronx field and extended kudos to Rich Rapp for his hard work and also to the Public Works for their efforts with the rink. If all goes well, skaters will be able to use the rink during daylight hours. Junior Council Members Austin Babjak and Madison Hintemeyer were absent.

Audience – President Schell welcomed Residents to address Council. Jim Barr from 200 Frankfort said he did not believe tonight's meeting was posted on the Borough's website. The Chief said it is posted in the yellow and red box on the left side of the webpage. Mr. Barr said he heard Bellevue Borough had seen two coyotes on their basketball court and questioned the proposed left hand turn Highland intersection project and questioned what is now occupying 5300 Perrysville. The Mayor said it is the former Boyle Carpet building. The Chief said the Borough is looking to rent the lower level of that building for a warehouse only to house the Road Crew and the Fire Department's equipment, materials and supplies. Mr. Barr apologized and said the thought the DPW was the State and the Chief explained the Borough has its own DPW who maintains the roads, salts streets, etc. Mr. Barr questioned if the Borough knew of any smaller municipalities that did their own solid waste pickup like Munhall does? The Mayor said no and President Schell said of the 25 municipalities in the NHCOG, all bid out their pickup. Mr. Barr questioned Chief Scheller on how a cash bash works and why they don't hold a gun bash. Chief Scheller explained the specifics of the cash bash and said the WVVFD takes in more money on the cash bash. Mr. Barr was in front of Council for 6.38.08 minutes.

There was no unfinished business or new business. Agenda – Item #1 – Council to consider Resolution #1421. Motion to read the title only for #1421 made by Mr. Aguglia and seconded by Mr. Kircher. Motion approved and ordered. Chief Fromlak read #1421, which is a Resolution applying for \$112,625 in RAAC grant money through the NHCOG for improvements to Bronx Field. Motion to adopt #1421 made by Mr. Aguglia was seconded by Mr. Mikec. Motion approved and ordered. Item #2 – Council to consider purchasing 14 Glock 21 GEN 4, .25 caliber sidearms with holsters and magazine pouches for the Police Officers in the amount of \$11,800 through CoStar Contract #012-071 through Markl Supply, with the trade in value of \$250 per old weapon. President Schell said his is a budgeted expense. Motion to approve made by Mr. Schellhaas was seconded by Mr. Aguglia. Motion approved and ordered.

Item #3 – Council to consider renting the first floor of 5300 Perrysville Road for 5 years for \$1,000 per month for 2,700 square feet. This area would be used as a warehouse for the DPW. Motion to approve the rental, contingent upon review and approval from the Solicitor and Chief of Police made by Mr. Aguglia and seconded by Ms. Steele. Motion approved and ordered. Item #4 – Council to consider a 5-year appointment to the Municipal Authority of the Borough of West View through December 31, 2019. Motion to reappoint Joseph J. Nowark was made by Mr. Mikec and seconded by Mr. Aguglia. Motion approved and ordered. Item #5 – Council to consider a 5-year appointment to Ross/West View Emergency Services Authority through December 31, 2019. Motion to reappoint Joseph Dinkel was made by Mr. Mikec and seconded by Mr. Borio. Motion approved and ordered. Member Bryan Kircher abstained from the vote. Item #6 - Council to consider a 5-year appointment to the Recreation Board through December 31, 2019. Motion made by Mr. Steele to reappoint Misty Hollinger was seconded by Mr. Kircher. Motion approved and ordered.

Item #7 – Council to consider a yearly appointment to the Vacancy Board through December 31, 2015. Motion made by Ms. Steele to reappoint Daniel Dannenmueller was seconded by Mr. Borio. Motion approved and ordered. Item #8 – Council to consider two 2-year appointments to the Three Rivers Wet Weather Demonstration Program through December 31, 2016. Motion to reappoint William F. Aguglia and Bruce A. Fromlak was made by Mr. Borio and seconded by Mr. Kircher. Motion approved and ordered. Item #9 – Council to consider authorizing the Borough Manager, the Solicitor and the Engineer to move forward with the paperwork to get financing up to \$200,000 for the stacking lane project, northbound on Perry Highway at Highland Avenue. The Mayor had said this work would run concurrently with the Highland Avenue stacking lane project and financing will be pursued through PA Infrastructure banking at 1.64% interest rate. Motion made by Mr. Kircher was seconded by Mr. Borio. Motion approved and ordered.

Announcements – Reminder that the regular meeting of Town Council for Thursday, April 9<sup>th</sup> has been cancelled and rescheduled for Thursday, April 2<sup>nd</sup>. Adjournment – President Barry G. Schell thanked everyone for attending the meeting and requested a motion to adjourn.

Motion to adjourn made by Mr. Kircher was seconded by Mr. Aguglia. Motion was approved and ordered.

Minutes of the regular meeting of the Town Council of Borough of West View held Thursday, March 12, 2015 in Council Chambers at 441 Perry Highway, Pittsburgh, PA 15229. The meeting was called to order at 7:00 p.m. by President Barry G. Schell, followed by a moment of silent prayer and the pledge of allegiance to the flag. Roll call was taken by Chief Fromlak. Members of Town Council present were: President Barry G. Schell, Vice President William F. Aguglia, Members Donald E. Mikec, M. Kimberly Steele, Bryan S. Kircher and Robert D. Schellhaas. Member Eugene Borio was absent. Also attending: J. R. Henry, Mayor, Chief of Police Bruce A. Fromlak, Secretary/Manager, Assistant Secretary Patricia Rapp, Robert E. Zischkau from Glenn Engineering and Attorney Matt Kalina. Solicitor Michael J. Witherel and Fire Chief Mark W. Scheller were absent, along with Junior Council Members Austin Babjak and Madison Hintemeyer.

Mayor Henry introduced House of Representative Adam Ravenstahl attending in the audience and welcomed him to the meeting on Council's behalf.

Motion to approve the minutes of the regular meeting of Town Council on February 12, 2015 made by Mr. Aguglia was seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments for general fund for net pay and payroll withholding for \$146,612.45 made by M. Steele was seconded by Mr. Mikec. Motion approved and ordered. Motion to approve payments to vendors for \$95,659.47 made by Mr. Aguglia and seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments for liquid fuel fund expenditures for \$4,745.01 made by Ms. Steele and seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments for building fund expenditures for \$6,695.91 made by Mr. Mikec was seconded by Mr. Aguglia. Motion approved and ordered.

Reports from the Officers – Mayor's Report – J. R. Henry, Mayor, reported the total for February's vehicle code violations were \$3,911.10. The Mayor reported that West View Water Authority would be increasing rates by 26%, due to their new debt service for the proposed plant in Beaver County, to help cover a 105 Million bond issue. The Mayor said WVWA delivers a high quality water and Residents will see the increase in June of 2015. Chief of Police / Secretary / Manager's Report – Chief Bruce A. Fromlak reported the Borough's agility agreement with PennDot has been approved and announced the Borough would be taking part in the Great American cleanup by having a cleanup day on Saturday, April 25<sup>th</sup> from 9:00 a.m. until noon, meeting behind the VFW on Center. The Chief thanked Resident Kathy Karnavas for her efforts with organizing the cleanup. The Chief reported on a CONNECT Utility Summit that both he and Mr. Zischkau attended. The Chief said they were able to receive helpful information from the utility companies and had discussed important material regarding the utility companies digging up streets prior to the Borough's street paving projects.

The Chief reported on March 14<sup>th</sup> between 10:00 p.m. and 3:00 a.m., West View and Ross PD will be participating in a roving DUI 10 vehicle task force and advised everyone to be safe this St. Patrick's Day weekend. The Chief extended his congratulations to Council and the Mayor for the Borough of West View earning the "2015 Banner Community" status through the Allegheny League of Municipalities. The Borough earned this distinguished Award by being progressive and proactive in the Community. The Chief thanked Patty Rapp for submitting all of the necessary information to ALOM so West View Borough could be considered for the 2015 Banner Community and the Award will be presented in the near future.

Report from the Solicitor – Michael J. Witherel was absent – Mr. Matt Kolina reported on the proposed Amnesty Tax program West View Council is to consider in conjunction with Ross Township and the North Hills School District. The Amnesty program would apply to all business privilege and/or mercantile taxes that are delinquent and would give businesses an opportunity to come forth and pay delinquent taxes and interest, but

the penalties would be waived between June 1, and December 31, 2015. Council would consider approving this resolution at next month's meeting, but it is necessary to have all three, being West View, Ross and the NHSD, work in conjunction by passing collating resolutions.

Report from Glenn Engineering – Robert E. Zischkau reported on the CONNECT Utility Summit and said West View is more proactive with their paving programs than other municipalities and hopes for the best with sharing 3-5 year digging plans with the utility companies, which would more than likely be coordinated through the NHCOG. The purpose would be to avoid digging up a newly paved road. Mr. Zischkau addressed the PIB loan documentation that is being worked on and will be forwarded onto John Johnson of Harrisburg. The PA infrastructure banking loan of 1.625% for up to 10 years, if received by the Borough, will fund the Perry Highway/Highland Avenue intersection and the Borough is looking to receive up to \$200,000. Fire Chief Mark Scheller was absent and had filed a written report.

Reports from the Committees – Finance Report – Bryan S. Kircher said the wage tax collection deposits for February were \$1,787.42, with the Borough's net proceeds at \$893.71. A total of \$50,667.92 was deposited into the general fund checking account by Keystone Collections. Our liquid fuel checking account had a balance of \$65,024.24 as of February 28<sup>th</sup> and earned \$.64 in interest. Our building fund money market account had a balance of \$33,440.50 as of February 28<sup>th</sup> and earned \$.33 in interest. Our general fund money market account had a balance of \$775,300.11 as of February 28<sup>th</sup> and earned \$28.22 in interest. Our local services collection deposits totaled \$9,669.31 in February. The Borough's net proceeds were \$8,739.58. Business and mercantile collection deposits totaled \$8,109.50 for February and the Borough's net proceeds were \$4,054.75.

There was no property and purchasing report due to Mr. Borio being absent. Public Works Report – Robert D. Schellhaas reported the Public Works Department completed 25 work orders in the month of February. 557 tons of salt have been ordered to date and the DPW has been cold patching holes in the Borough's roadways. The DPW had both the bucket truck and the aerial inspected.

Mr. Aguglia had no report for police and public safety and Mr. Kircher had no report for budget/administration. Fire and water report – Donald E. Mikec said the West View Volunteer Fire Department responded to 26 calls in February, using 67.38 man hours, totaling 54 responses year-to-date, with an average of 225.3 man hours. Mr. Mikec reminded everyone of the West View Volunteer Fire Department's annual cash bash, to be held on Saturday, April 11<sup>th</sup> and the \$25.00 tickets are available for purchase. Public Relations and Recreation Report – M. Kimberly Steele reported the next Crime Watch meeting will be held on Monday, April 13<sup>th</sup> and Allegheny County Deputy Sheriff Jason Tarap will present the program.

Audience – President Schell welcomed Residents to address Council. Jim Barr from 200 Frankfort questioned if it was fair to say the Borough was in the water business, who were the sponsors for the CONNECT summit and how the NHSD chose not to appoint him, but someone else who is not from West View, to fill a vacancy on their board. Mr. Barr questioned why the fire whistle blows and why can't his radio monitor fire calls anymore? Mr. Barr was in front of Council for 6.26.4 minutes.

Though the Mayor could not answer the school district question, he answered Mr. Barr's questions by saying in essence, the Borough controls the Authority, as they appoint the board members, who, in turn, services over 33 municipalities and over 54 thousand customers. Mr. Zischkau said the utility companies sponsored the CONNECT summit, i.e. Duquesne Light, Equitable and Peoples Gas. The Mayor said the Borough is very proactive in their paving program and Mr. Zischkau added many municipalities do not pave roads yearly as the

Borough does. The Mayor explained the fire whistle blows to alert firefighters of a call in case they do not have their pager. The radio frequency changed to ultrahigh band and the Chief said he could furnish Mr. Barr with the 6-digit frequency, as long as he did not have a crystal radio. There was no unfinished business and, under new business, President Barry Schell reminded everyone the next meeting of Town Council would take place at 7:00 p.m. on Thursday, April 2<sup>nd</sup>.

Agenda – Item #1 – Council to consider an appointment of a Delegate and an Alternate Delegate to the MRM Property & Liability Trust. Motion to appoint Barry G. Schell as Delegate and William F. Aguglia as Alternate Delegate for 2015 made by Mr. Kircher and seconded by Mr. Mikec. Motion approved and ordered. The meeting was called to order by President Barry G. Schell at 7:00 p.m., followed by a moment of silent prayer and the pledge of allegiance to the Flag. Chief Fromlak conducted roll call. Members of Town Council present were: President Barry G. Schell, Vice President William F. Aguglia, Members M. Kimberly Steele, Donald E. Mikec, Bryan S. Kircher, Robert D. Schellhaas and Eugene Borio. Also attending were: Chief of Police Bruce A. Fromlak, Secretary/Manager, Assistant Secretary Patricia A. Rapp, Solicitor Michael J. Witherel, Robert E. Zischkau from Glenn Engineering and Fire Chief Mark W. Scheller. Junior Council Members Austin Babjak and Madison Hintemeyer were both absent. This meeting had been advertised in the Pittsburgh Post-Gazette, cancelling the regular meeting of April 9<sup>th</sup> and re-scheduling for April 2, 2015. The Chief explained that the Mayor was on route.

Motion to approve the minutes of the regular meeting of Town Council on March 12, 2015 made by Mr. Aguglia and seconded by Ms. Steele. Motion approved and ordered. Motion to approve payments for net pay and payroll withholding for \$145,907.82 made by Ms. Steele was seconded by Mr. Mikec. Motion approved and ordered. Motion to approve payments to vendors for \$183,546.43 made by Mr. Aguglia was seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments for liquid fuel fund expenditures for \$4,684.37 made by Mr. Mikec and seconded by Ms. Steele. Motion approved and ordered. Motion to approve payments for building fund expenditures for \$6,244.55 made by Mr. Aguglia was seconded by Mr. Schellhaas. Motion approved and ordered.

Reports from the Officers – Mayor's Report – J. R. Henry, Mayor – President Schell said the Mayor is in transit and requested a report from the Police Chief/Secretary/Manager. Chief Fromlak said the Mayor was a speaker at the CONNECT Congress meeting. The Chief said the Mayor's Report for March 2015 for motor vehicle code violations was parking violations/tickets \$180.00, vehicle code violations/Magistrate \$2,343.90, ordinance and statute violations/Magistrate \$3,181.58, and \$1,031.24 for Allegheny County DUI, and the total March receipts to \$6,736.72. Manager's Report – The Chief said there was a gas leak at the 300 block of Center Avenue between Hawthorne and Norwich, but it is very close to the Borough's new stormwater management project. The gas company has agreed to replace the line, relocating it under Resident's sidewalks as not to disturb the project.

Report from the Solicitor – Michael J. Witherel reported on Ordinance #1485 which Council will consider under the Agenda. The Ordinance pertains to the Act 511 tax amnesty program that both the School District and Ross Township have adopted. This Ordinance would give businesses the opportunity to come forward to remit delinquent business, mercantile and local services taxes to the Borough/NHSD/Ross with penalty but with no interest for years 2008 to 2015. The purpose of adopting this Ordinance would be to increase revenues in the Borough and Mr. Witherel recommends Council consider approving #1485. Report from Glenn Engineering – Robert E. Zischkau reported he was delighted with the way the Center Avenue green infrastructure performed by significantly reducing water flow and was pleased how well it managed to survive an adverse winter. Everything at the site faired very well and some additional gravel was added to the site.

Mayor J. R. Henry arrived at 7:04 p.m. President Schell welcomed the Mayor to the meeting and advised the Manager had given the Mayor's report. Mayor Henry said he was late due to being at another meeting and thanked Councilman Aguglia for attending also. The Mayor said he will have summary for Council next month for CONNECT, which he said good things are happening. Report from the Fire Chief Mark W. Scheller – Chief Scheller said the new ladder truck has moved into the manufacturing stages and he is expecting a late July

delivery. The Chief reminded everyone of the upcoming cash bash fund raiser scheduled for April 11<sup>th</sup>, <sup>C</sup> proceeds of which will help pay for the truck.

Reports from the Committees – Finance Report – Bryan S. Kircher said wage tax collection deposits for March were \$1,128.59, with the Borough's net proceeds at \$564.30. A total of \$96,774.90 was deposited into the general fund checking account by Keystone Collections. Our liquid fuel checking account had a balance of \$214,676.34 as of March 31<sup>st</sup> and earned \$1.52 in interest. Our building fund money market account had a balance of \$33,440.79 as of March 31<sup>st</sup> and earned \$.29 in interest. Our general fund money market account had a balance of \$550,306.22 as of March 31<sup>st</sup> and earned \$6.11 in interest. Our local services collection deposits totaled \$809.00 for March and the Borough's net proceeds were \$707.71. Business and mercantile collection deposits totaled \$6,885.73 for March. The Borough's net proceeds were \$3,447.87. Chief Fromlak added the Borough recently received the results of the Standard and Poor study of our finances in the Borough and was pleased to report the Borough's A+ rating has risen to AA-. This is good news for the Borough, meaning the Borough is headed in the right direction and is fiscally responsible for tax dollars. Property and Purchasing Report – Eugene Borio had no report for Council.

Public Works Report – Robert D. Schellhaas reported the Public Works completed 25 work orders in March and rebuilt 2 storm inlets, along with cold patching holes in the roads. The Crew repaired 3 sections of guide rail at Ashford and Center. Mr. Schellhaas said 344 tons of salt were used during the month of March and said the Borough had purchased 2,639 tons of salt over the winter. Police and Public Safety Report – William F. Aguglia – Mr. Aguglia said Officer Stern attended a 2 day course, becoming a certified Remington armorer, which will allow him to fix and maintain weapons in-house. Mr. Aguglia said 5 of our Officers participated in an active shooter training on April 2<sup>nd</sup>, which is a joint training exercise with several other municipalities. Mr. Aguglia said 5 Officers will be attending a state mandated sobriety checkpoint training on April 9<sup>th</sup>.

Budget/Administration Report – Bryan S. Kircher – Mr. Kircher wanted to follow up on the Chief's report on the Standard and Poor change in the Bond rating for the Borough. Mr. Kircher commended the Chief and Administration and Council for their efforts to keep the Borough heading in the right direction. Fire and Water Report – Donald E. Mikec – Mr. Mikec reported the West View Volunteer Fire Department responded to 34 incidents in March, with 88 year-to-date. March's man hours were 127.06 and 352.36 year-to-date. Public Relations & Recreation Report – M. Kimberly Steele reported the next Crime Watch meeting will take place on Monday, April 13<sup>th</sup> and the program will be given by Allegheny County Officer Jason Tarap. Officer Tarap will discuss home and vehicle protection/safety and how to hire reputable contractors.

Audience – President Schell welcomed Residents to participate. Cathy Lang from West View Towers addressed the poor condition of sidewalks in the Plaza, saying some are in horrendous conditions, which makes it dangerous for her to maneuver her wheelchair along West View Park Drive. Ms. Lang had a specific problem between Dunkin Donuts and KFC, and she had an accident by falling in front of Wendy's in November of 2014. She questioned who is responsible and Ms. Lang's father also addressed Council regarding the curb cuts and their condition. The Mayor advised Chief Fromlak will follow up on this matter, as the sidewalks are the responsibility of the businesses, and by furnishing her phone number to the Chief, he would keep Ms. Lang in the loop on the progress of the sidewalks. Ms. Lang was in front of Council for 7.26 minutes.

Jim Barr from 200 Frankfort addressed Council, questioning why 2015 Council minutes are not online, expressed his opinion that it is unconstitutional for 5 officers to participate in DUI checkpoints, questioned Agenda Item #2, questioned the Standard rating, questioned why the Mayor scheduled a CONNECT meeting conflict with tonight's meeting and the Center Avenue gas line and questioned the Fire Chief regarding the sale of the old ladder truck and who would want it? Mr. Barr was in front of Council for 5.16 minutes. Mayor Henry said he will not debate Mr. Barr's opinions but said Council supports checkpoints and they are constitutional. He addressed the Center Avenue green project, stating that for the Borough's cost of less than \$10,000, it was a great opportunity to be a model community for its' proactive addressing of the water flow problem and the system effectively has deflected 250,000 gallons of water from the sewer system. Minor maintenance is needed for this area. Mr. Henry said the Standard and Poor rating has no impact on the Borough other than proving the Borough is under good stewardship and the Council and Manager are being fiscally responsible. Chief Scheller said many rural areas with less revenue will be interested in purchasing the old ladder truck and he has no doubt that it will sell. Bill Graff from 374 Center addressed Council to request they consider replacing the old sanitary line and rebuild the catch basins in front of their homes since they will be relocating the gas line and the sidewalk area will be open. The Chief and Mayor and Mr. Zischkau agreed this would make sense and President Schell said this matter would be addressed, as it was a good suggestion. Mr. Graff was in front of Council for 1.44 minutes.

There was no unfinished business and under new business, the Chief reminded everyone of West View's annual clean up, scheduled for Saturday, April 25<sup>th</sup> between the hours of 9-Noon. At a cost of \$300 to the Borough, Waste Management is providing dumpsters for the day, inclusive of an electronic recycling dumpster, and the Chief welcomed anyone to meet at the rear of the VFW, who also provides the coffee and water. Waste Management no longer takes electronics but provides a subcontractor to take those items, free of charge. Kathy Karnavas is the primary POC and the Information is on our website and the Mayor thanked Ms. Karnavas for her help. In answering Mr. Barr's other questions, the Chief explained it takes longer to get Council's minutes on the website because the Chief only puts official, signed Minutes/Ordinances/Resolutions on the site. They were sent to the webmaster within the past couple of days and should be on the site. The Mayor said tonight's meeting was re-scheduled with the knowledge that 3 people would be attending the CONNECT meeting that was to begin at 4:30. The Meeting began late, Mr. Fitzgerald spoke longer than scheduled and the Mayor said he was 4 minutes late due to traffic and felt there was no conflict.

Agenda – Item #1 – Council to consider Ordinance #1485. Motion to read #1485 made by Mr. Aguglia was seconded by Mr. Kircher. Motion approved and ordered. Chief Fromlak read #1485, which approves the Tax Amnesty Program in conjunction with the Township of Ross and the North Hills School District to waive penalty for delinquent business, mercantile and LST. This Ordinance was read by title only and Motion to adopt #1485 made by Mr. Aguglia was seconded by Ms. Steele. Motion approved and ordered. Item #2 – Council to consider Resolution #1422. Motion to read #1422 made by Mr. Mikec was seconded by Mr. Borio. Motion approved and ordered. The Chief read #1422, which is a Resolution approving Allegheny County's Vacant Property Recovery Program application for the proposed sale of 280-C-88, which is the vacant property abutting 38 Norwich. This Program was established to help get properties off of the delinquent tax rolls and sell to taxpaying Residents. Motion to adopt Resolution #1422 made by Mr. Aguglia was seconded by Mr. Mikec. Motion approved and ordered.

With no announcements, President Schell wished everyone a safe and happy Easter holiday and requested a Motion to adjourn. Motion to adjourn made by Mr. Aguglia was seconded by Mr. Borio. Motion approved and ordered. The Meeting adjourned at 7:38 p.m.

Reports from the Officers – Mayor's Report – J. R. Henry, Mayor reported the April totals for motor vehicle code violations totaled \$5,881.91. There were no announcements. President Barry Schell thanked everyone for attending and wished all Fathers a Happy Father's Day. With no further business to come before Council, President Schell requested a Motion to Adjourn. Motion to Adjourn made by Mr. Aguglia was seconded by Mr. Kircher. Motion approved and ordered.

Witherel, Robert E. Zischkau from Glenn Engineering and Fire Chief Mark W. Scheller. There was one person in the Audience.

Motion to approve the minutes of the regular meeting of Town Council on June 11, 2015 made by Ms. Steele was seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments for net pay and payroll withholding for \$145,670.47 made by Mr. Kircher was seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments to vendors for \$171,745.69 made by Ms. Steele was seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments for liquid fuel fund expenditures for \$6,667.24 made by Mr. Mikec was seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments for building fund expenditures for \$1,522.70 made by Mr. Mikec was seconded by Mr. Schellhaas. Motion approved and ordered.

Reports from the Officers – Mayor's Report – J. R. Henry, Mayor – The Mayor reported the motor vehicle code violations for June totaled \$6,875.83. The Mayor had sad news, as Joseph Nowark, after serving 25 years on Town Council and 6 years on the Board of the West View Water Authority, has submitted his letter of resignation as a Board Member of the Authority, citing health reasons. The Mayor requested the Chief send Mr. Nowark a letter of thanks for his service. Mr. Henry announced a ribbon cutting ceremony, set for Friday, August 7<sup>th</sup> at 11 in the Plaza at the new Career Training Academy. The function will run from 11 to 3 and Council has been invited to take part in the ceremony. The Mayor commented on the thank you received from the family of Helen Powell, as they were overwhelmed and gratified by Council's kindness in donating \$100 to Mrs. Powell's hospice in Florida after her death. The Borough will host the next CONNECT meeting at the West View Firemen's Building on Thursday, July 16<sup>th</sup>, beginning at 10 am and Council is welcome to attend.

Report from the Chief of Police/Secretary/Manager – Bruce A. Fromlak – The Chief said the speed trailer was used from June 29<sup>th</sup> until July 6<sup>th</sup> on Perry between Horseshoe Bend and McDonald's, tracking over 16,000 vehicles at an average of 35 miles per hour, which needs to be addressed. The Chief said he had spoken with the Borough Engineer and had been advised onset of the Borough's paving project has been set back due to bad weather, backing up the paving company. Report from the Solicitor – Michael J. Witherel reported that it will be necessary for Council to consider accepting Mr. Nowark's resignation letter, with regrets, under tonight's agenda. Mr. Witherel spoke on the North Park Road parcel sale that is on the agenda. The only consideration would be if Council would be interested in selling a small parcel of land at this site, noting this would not approve any sale, as the Developer has not proposed a plan for this area. Our liquid fuel checking account had a balance of \$159,031.28 as of June 30<sup>th</sup> and earned \$1.47 in interest. Our building fund money market account had a balance of \$33,441.62 as of June 30<sup>th</sup> and earned \$.29 in interest. The Borough's General Fund money market account had a balance of \$300,318.91 as of June 30<sup>th</sup> and earned \$3.43 in interest. There were no real estate tax collections in June. Local service tax collections totaled \$13,517.42, with West View receiving \$12,217.64. Business/Mercantile collections totaled \$33,081.28 and we received \$16,655.64.

Vice President Aguglia asked Fire Chief Mark W. Scheller to submit his report, as he had skipped over him. Fire Chief Scheller reported on the status of the new ladder truck, which is expected within a month. Mr. Scheller said he would gladly print out the construction progress pictures for their packets if they would like to see how the build

is progressing. The Chief said they have not been able to sell the old ladder truck to date. A fundraiser is 'planned, which is the Annual Golf Outing at the Shannopin Country Club on August 17<sup>th</sup> and information is available through Joe Assisi at the Borough at 412.931.2800 ext. 112. A second fundraiser will be the July 18<sup>th</sup> Motorcycle ride and Chief Scheller has the information regarding the ride.

Mr. Borio had no report for property & purchasing. Public Works report – Robert D. Schellhaas reported the Publi Works Crew completed 31 work orders in June. They have rebuilt 3 storm inlets and have used 20 tons of hot mix to patch our streets. The Summer Help has been busy cutting grass and trimming and wood carpeting was laid in both Columbia and Farley Parks. Mr. Aguglia did not have a Police and Public Safety Report and Mr. Kircher did not have a Budget / Administration Report. Fire and Water Report – Donald E. Mikec reported the West View Volunteer Fire Department responded to 34 calls in June, using 7996 man hours, with 181 calls to date or 593.08 man hours. Public Relations & Recreation Report – M. Kimberly Steele said 80 children registered for Summer Recreation and they are averaging 30 to 35 Children per day. The Community Day celebration went well, until it was rained out. The Committee will hold Movie Night on Thursday, August 13<sup>th</sup>, where they will show the movie at Bronx Field and will have food available.

There was no audience participation. Unfinished Business – Mayor Henry said he saw the landscaping at Guckert Square and commented how great it looked. Motion to approve payments to vendors for \$65,636.72 made by Mr. Aguglia was seconded by Mr. Borio. Motion approved and ordered. Motion to approve payment for liquid fuel expenditures for \$4,613.90 made by Ms. Steele was seconded by Mr. Mikec. Motion approved and ordered. Motion to approve payments for building fund expenditures for \$3,112.33 made by Mr. Mikec was seconded by Mr. Aguglia. Motion approved and ordered.

Mayor Henry said Cathy Risco resigned from her position at CONNECT to take a new job in healthcare and though they are sorry to see her go, requested the Chief send her a congratulations letter. Chief of Police Bruce A. Fromlak, Secretary/Manager Report – Chief Fromlak reported Duquesne Light has been replacing street lights along Perry Highway between Schwitter and Center with new LED lights and the lights are estimated to last 12 years. The Chief reported on a property maintenance code enforcement program that he instituted, along with the help of Joe Assisi and Patty Rapp. To date, the Borough has saved \$1,920 in code enforcement fees by sending out courtesy property maintenance letters through the Borough office. When complaints are received, they are checked out and verified, then a letter is sent to the property owner, along with a date to comply. Should the owner not comply, then the matter is turned over to the 3<sup>rd</sup> party code enforcer to pursue at the Magistrate. To date, 43 notices have been sent, with 33 being corrected. The Chief thanked both Joe and Patty for their help.

Chief reported on the Hawthorne/Clairmont/Center area property owners that received dye test violation letters. Out of 58 property owners receiving violation letters, 40 have complied and plans to send out additional notices to have the final 18 comply by September 30<sup>th</sup> are being made. The Borough sold the Ford F550 truck through Municipal Bids, which is a free service that auctions vehicles nationwide, allowing the sellers to set a reserve amount. Eleven bids were received and the truck sold to the highest bid of \$19,900 to Stover, Inc. The Mayor added he felt this is a good program and Mr. Mikec questioned where Stover is located, to which the Chief advised it is out of Mechanicsburg. Report from the Solicitor – Michael J. Witherel was absent and Matt Kalina had no report for Council.

Engineer's Report – Robert E. Zischkau followed up on the Chief's report regarding the dye test certification compliance, saying all property owners have received 2 notices to date and a 3<sup>rd</sup> notice will be sent out certified to have those comply. This will correct the problems with the overflow that heads over the hill behind Clairmont/Sciotta Alley. The DEP will be satisfied with 93-95% compliance but the Borough is hoping to have 100% of the properties comply. Ms. Steele questioned the cost to the property owner to comply, which Mr. Zischkau said ranged from \$200 to \$2,000 per dwelling. Mr. Zischkau said the 2015 paving program should begin on Monday, August 24<sup>th</sup> by Victor Paving and was delayed due to the weather.

Mr. Zischkau reported on the deteriorating condition of the Martsolf Avenue Bridge. Fire and Water Report – Donald E. Mikec said the West View Volunteer Fire Department responded to 42 calls in July, using 115.76 man hours. Year-to-date responses are 223, with 708.84 man hours, averaging 32 calls. Public Relations and Recreation – M. Kimberly Steele had no report for Council.

Audience – President Barry G. Schell welcomed residents to address Council. Motion to approve the minutes of the regular meeting of Town Council on August 13, 2015 was made by Mr. Kircher and seconded by Mr. Mikec. Motion approved and ordered. Motion to approve payments for net pay and payroll withholding for \$ 137,459.53 was made by Ms. Steele and seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments to vendors for \$ 79,471.65 was made by Mr. Mikec and seconded by Mr. Aguglia. Motion approved and ordered. Motion to approve payments for liquid fuel expenditures for \$ 4,609.67 was made by Mr. Kircher and seconded by Mr. Aguglia. Motion approved and ordered. Motion to approve payment for building fund expenditures for \$ 20,141.76 was made by Ms. Steele and seconded by Mr. Borio. Motion approved and ordered.

Reports from the Officers – Mayor's Report – President Schell gave the Mayor's report in his absence. Motor vehicle code violations for August totaled \$ 3,792.15. Chief of Police/Secretary Manager Report – Bruce A. Fromlak – Chief Fromlak reported that the paving has been going on throughout the Borough and should be finished by Sept. 11 or Sept. 12. A developer wants to purchase the vacant property across from WVWA for \$1250.00. A motion was made to sell the property for \$1250.00 by Mr. Aguglia and seconded by Mr. Mikec. Motion approved and ordered. Solicitor Report – Mr. Witherel had none. Engineer Report – Mr. Zischkau reported that Allegheny Health department conducted an audit of the combined sewer systems and is confident that the Borough is in compliance. Bids were received for the replacement of Concrete Island and rehabilitation of parapet wall at Municipal Building. He will recommend under agenda. Fire Chief Report – Mark W. Scheller reported that they received the new aerial and it is in service. They are waiting for a few minor items to add. The Fire Department is having a gun a day raffle for the month of November and you can get tickets from any of the firemen.

Reports from the Committees – Finance Report – Bryan S. Kircher read the report for August, with Wage Tax collection deposits for August totaling \$ 350.00 with West View receiving \$ 175.00. A total of \$74,024.77 was deposited into the General fund checking account by Keystone Collections. Our Liquid Fuel checking account had a balance of \$ 159,033.98 as of August 31<sup>st</sup> and earned \$ 1.35 in interest. Our Building fund money market account had a balance of \$ 63,442.36 as of August 31<sup>st</sup> and earned \$ .45 in interest. Our General fund money market account had a balance of \$ 600,323.87 as of August 31<sup>st</sup> and earned \$ 2.26 in interest. Real Estate tax collections in August totaled \$ 378,804.27. Local Service tax collections totaled \$ 10,068.31, with the West View receiving \$ 9,100.25. Business/Mercantile tax collections totaled \$ 9,500.45, with West View receiving \$ 4,770.23. Property and Purchasing Report –

Eugene Borio had no report. Public Works Report – Chief Fromlak read Mr. Schellhaas's report in his absence. Also the recreation committee is getting ready for the Annual Halloween Parade. Fromlak, Secretary/Manager, Asst. Sec. Patricia A. Rapp, Solicitor Michael J. Witherel, Robert Zischkau from Glenn Engineering, Fire Chief Mark W. Scheller and Junior Council Member Austin Babjak. Vice President William F. Aguglia and J. R. Henry, Mayor were absent.

Motion to approve Council's minutes from the regular meeting on September 10, 2015 made by Ms. Steele was seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments for net pay and payroll withholding for \$215,961.21 made by Mr. Schellhaas was seconded by Mr. Borio. Motion to approve payments to vendors for \$78,775.55 made by Mr. Kircher was seconded by Ms. Steele. Motion approved and ordered. Motion to approve payments for liquid fuel fund expenditures for \$4,609.67 made by Mr. Kircher was seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments for \$1,690.34 made by Mr. Mikec was seconded by Mr. Borio. Motion approved and ordered.

Reports from the Officers – Mayor's Report – J. R. Henry, Mayor was absent and Mr. Schellhaas read the Mayor's report for September, 2015 as follows: Motor vehicle code violations – Parking violations / tickets - \$1,070, vehicle code violations / Magistrate - \$960.92, ordinance & statute violations / Magistrate - \$1,616.26, Allegheny County DUI -\$2,955.22, with the total receipts for September 2015 at \$6,602.40. Chief of Police Bruce A. Fromlak, Secretary/Manager's Report – The Chief reported the Police have responded to 3,300 calls year to date, as of September, 2015, with an average of 12.2 calls per day. The Chief reported work will soon begin to replace the island in front of the Borough Building and work will commence on repairing the parapets on the building. The paving project has been completed, other than a few minor items that are being addressed and both he and Mr. Assisi are planning the 2016 paving project. Nine Candidates for the Police eligibility list were scheduled to take the October 8<sup>th</sup> test, with six showing and one not passing the physical test. Five Candidates took the written test and results are expected next week. Solicitor's Report – Michael J. Witherel had no report for Council.

Report from Glenn Engineering – Robert E. Zischkau – Mr. Zischkau said he will conduct a meeting within the next 4 days to discuss the scheduled island and handicapped ramp work. Mr. Zischkau said he is in the process of preparing the hybrid order and will have the report prepared for Alcosan and Council. Report from the Fire Chief – Mark W. Scheller – Chief Scheller reported the Department still has tickets available for their fundraiser. Chief Scheller advised the old ladder truck has not been sold and has 3 parties interested in purchasing the truck. The Chief said 23 Members are attending an Engine Operations class.

Reports form the Committees – Finance Report – Bryan S. Kircher reported wage tax collection deposits for September totaled \$300 with West View receiving \$150. A total of \$90,021.60 was deposited into the general fund checking account by Keystone Collections. Our liquid fuel checking account had a balance of \$159,065.29 as of September 30<sup>th</sup> and earned \$1.31 in interest. Our building fund money market account had a balance of \$63,442.88 as of September 30<sup>th</sup> and earned 52 cents in interest. Our general fund money market account had a balance of \$1,100,328.04 as of September 30<sup>th</sup> and earned \$4.17 in interest. Real estate tax collections in September totaled \$872,381.27. Local service tax collections totaled \$89.98, with the Borough receiving \$81.33. Business/Mercantile collections totaled \$3,481.14 and we received \$1,745.57. Property and Purchasing Report – Eugene Borio had no report.

Public Works report – Robert D. Schellhaas – Mr. Schellhaas said the Road Crew completed 20 work orders in September and said, with the 2015 paving project being complete, the Crew has started the crack filling program. The Crew cleaned and re-piped the storm sewer on Columbia Avenue and Mr. Schellhaas said Rich Rapp and Frank Conley attended a Green Infrastructure Maintenance Workshop. The Crew also repaired a water leak on the Borough's service line. Budget/Administration report – Bryan S. Kircher reported the committee had the draft 2016 budget well underway and will have the printed draft ready for the November meeting. Fire and Water report – Donald E. Mikec – Mr. Mikec said the West View Volunteer Fire Department responded to 39 calls in September, using 401.74 man hours, with the year to date being 297 calls at an average of 33 calls per month and 1,215.25 staff hours.

Public Relations and Recreation report – M. Kimberly Steele – Ms. Steele reported the West View Historical Society will sponsor a Mystery History Night at West View Elementary auditorium on October 9<sup>th</sup> at 7:00 p.m. The Crime Watch meeting will be held at the West View Banquet Hall on Monday, October 12<sup>th</sup> at 7:00 p.m. The Committee will be packing 1,400 goodie bags at the Borough Building on Thursday, October 22<sup>nd</sup> beginning at 5:00 p.m. and volunteers are needed. The Halloween parade is on Monday, October 26<sup>th</sup> at 7:00 p.m. and Halloween will be celebrated on Saturday, October 31<sup>st</sup> from 6:00 – 8:00 p.m. Junior Council Member - Austin Babjak reported the North Hills School District will be sponsoring its' first Fun Run through Make a Wish and donations are being accepted through the High School main office. Chief Fromlak took this time to correct upcoming Resolution #1429 to be \$10,000 in grant funds, not \$155,700.

Audience – President Schell welcomed residents to address Council. Maureen Nagel from 155 Chalfonte Avenue addressed Council regarding her personal interactions, rat baiting, her sick dog, issues with her neighbors she referred to as "haters", people driving the wrong way on a one way and people speeding and people yelling at her. Ms. Nagel spoke of her experience of rats being under all telephone poles and her neighbors emitting ultrasonic high frequency soundwaves in order to hurt her and her dog and was in front of Council for 7:52.12 minutes. Jim Barr from 200 Frankfort said the July and August minutes are not on the website, spoke of a rat and trap in his garden, spoke of a publication supporting the local Police and gave publications for the Chief and Mayor. Mr. Barr was in front of Council for 2:18.03.

There was no unfinished business and no new business. President Schell moved onto the Agenda. Agenda Item #1 – Council to consider Resolution #1428. Motion to read #1428 made by Mr. Borio was seconded by Mr. Mikec. Motion approved and ordered. Chief Fromlak read #1428, which is a Resolution authorizing the distribution of \$125,466.71 of General Municipal Pension System State Aid – Municipal Pension Plan Funding and Recovery (Act 205 of 1984), depositing \$28,266.71 into the Non Uniformed Plan and \$97,200 into the Police Pension Plan. Motion to approve #1428 made by Mr. Mikec was seconded by Mr. Kircher. Motion approved and ordered. Agenda Item #2 – Council to consider Resolution #1429. Motion to read #1429 by title only made by Mr. Kircher was seconded by Mr. Schellhaas. Motion approved and ordered. Chief Fromlak read #1429, which is a Resolution authorizing the filing of an application for \$10,000 in grant funds with the Allegheny County Department of Economic Development to demolish vacant and dilapidated structures. Motion to approved #1429 made by Mr. Schellhaas was seconded by Mr. Mikec. Motion approved and ordered.

Item #3 – Council to consider Resolution #1430. Motion to read #1430 made by Mr. Kircher was seconded by Ms. Steele. Motion was approved and ordered. Chief Fromlak read #1430, which is a Resolution authorizing the filing of and application for \$50,000 in grant funds with the Allegheny County Department of Economic Development to declare certain properties as blighted. Motion to adopt #1430 made by Mr. Mikec was seconded by Mr. Borio. Motion approved and ordered. Item #4 – Council to consider Resolution #1431. Motion to read #1431 made by Ms. Steele was seconded by Mr. Kircher. Motion approved and ordered. Chief Fromlak read #1431, which is a Resolution authorizing the disposition of a vacant parcel of property, Block & Lot #350-R-142, abutting 19 Mineola through Allegheny County's Vacant Property Program. Minutes of the Special Budget Workshop Meeting held Thursday, November 12, 2015, in Council Chambers at 441 Perry Highway, Pittsburgh, PA 15229. The Meeting was called to order at 6:30 p.m. by Vice President William F. Aguglia, followed by a moment of silent prayer and the pledge of allegiance to the flag. Roll call was taken by Chief of Police Bruce A. Fromlak. Members of Town Council present were: President Barry G. Schell, Vice President William F. Aguglia, Members Donald E. Mikec, M. Kimberly Steele, Bryan S. Kircher and Robert D. Schellhaas. Also attending were: Mayor J. R. Henry, Police Chief Bruce A. Fromlak, Secretary/Manager, Asst. Secretary Patricia A. Rapp, Robert E. Zischkau from Glenn Engineering and Fire Chief Mark W. Scheller. Council Member Eugene Borio arrived at 6:36 p.m. and Solicitor Michael J. Witherel arrived at 6:47 p.m.

Vice President Aguglia turned the meeting over to Chief Fromlak, who read the official notice that ran in the Post-Gazette North on October 23<sup>rd</sup>, which announced the Workshop to begin at 6:30 p.m., with the regular meeting to immediately follow. The Chief thanked Mr. Kircher, Mr. Aguglia and Ms. Steele for their support and thanked Ms. Mann and Mrs. Rapp for their help in developing the budget for 2016. The proposed budget is tax neutral, maintaining all services without an increase in the 5.4 millage. Total 2016 proposed general fund budget for both revenue and expenditures is \$3,673,780.

Chief Fromlak said both uniformed and non-uniformed employee contracts allow for a 3% increase for 2016 and both contracts expire at the end of 2016, both with an extension option. Healthcare costs are projected to increase 25% next year and the 18 full time employees who use the Borough's healthcare have selected a higher deductible plan and will each contribute \$500/year. Council Member Kircher added the Police pay 7% and Non-Uniformed pay 5% and will pay an additional \$500/year on top of the percentage. The Chief reported on the balances to date in the general fund checking, money market, building fund and liquid fuels accounts and reported on the projected account changes for 2016. The Chief is not anticipating the need to apply for the \$200,000 TAN but is looking into a \$200,000 line of credit for the building fund. The Chief anticipates future, if not constant repairs to the 75 year old Borough building and the line of credit would aid the Borough.

The Chief reported on individual line items for anticipated expenses in 2016. The Chief intends to replace the 2011 Ford Crown Victoria, having over 80,000 mile, with a new 2016 AWD vehicle. Chief Fromlak plans to hire a new Police Officer to replace a retired Officer and allowed for a \$30,000 cost towards the new ladder truck that is now in service. The Chief would like to replace a 2008 F450 4x4 dump by leasing a new 2016 dump for 3 years, using 25% of funds from liquid fuels. Mr. Kircher added the lease would be at 2.5% interest and Mr. Mikec questioned if this lease was with an option to buy? Chief Fromlak said yes, this was actually through Costar through the COG. The Chief intends to replace the 30 year old leaf collection machine, budgeting \$60,000 for the purchase, as the old machine has mechanical and issues with rotting.

Chief Fromlak said the Road Crew has been replacing signs throughout the Borough to meet federally mandated regulations on roadway signs, which addresses reflectivity and size of lettering. The Chief is looking into the possible purchase of a LED information sign. The Chief noted a special account, Perry / Highland Project for \$215,000, which is the 2.6% PIB loan for the intersection upgrade and said he anticipates an increase in real estate tax income in 2016. The Chief reported on the 5 lease agreements in place for the Borough Building and said securing a 10 year lease through Allegheny County for the Magistrate has been a slow process but is moving in a positive direction. Chief explained the \$120,944 decrease in the building fund repairs and maintenance account over 2015, which had been the costs from heating/air conditioning

replacement and the Police Department remodel. Vice President Aguglia questioned Mr. Zischkau if there was an anticipated startup for the Perry Highway / Highland Avenue intersection and Mr. Zischkau said it has been a slow process, but is hopeful it will begin in 5-6 month, if it passes through Harrisburg, and he would expect work to begin in the spring of 2016.

Mayor Henry congratulated the Chief on a great job and extended cudos to Bryan Kircher and the employees who worked on the proposed budget. Mr. Kircher said the healthcare negotiations with the employees went fabulous and he is pleased the budget will not include a tax anticipation note but will consider the line of credit instead. The tax anticipation note provided revenues to carry the Borough through July's real estate tax collections and normally entails around \$9,000 in interest, which the Borough avoided paying in 2015. The Mayor added the savings in interest alone would work if the line of credit would provide cash flow until July. The Mayor said he is pleased the Chief is staying on top of street paving and questioned if the Allegheny County plans to adjust the Borough's 1 mill = 296,300? Chief said no, it is the same as last year and has been locked in by Allegheny County. Chief Fromlak addressed the MMO's for the pension funds, saying it appears the non-uniformed pension contribution may go down in 2016, as it is 106% funded, with the Police plan being 112% funded. Mockenhaupt feels the plans are in amazing condition and the Borough received around \$126,000 through the State for our pension plans in 2016.

Mayor Henry was very pleased with the proposed budget and again, extended cudos to all.

With no further comments regarding the 2016 proposed budget, Vice President Aguglia requested a Motion to adjourn. Motion to adjourn was made by Mr. Mikec and seconded by Ms. Steele. Motion was approved and ordered by Council.

Meeting adjourned at 6:57 p.m.

Reports from the Officers – Report from the Mayor – J. R. Henry, Mayor – Mayor Henry announced the reason for the historic attendance at tonight's Council meeting was due to honoring and officially recognizing Council President Barry G. Schell. The Mayor commended the three West View Volunteer Firefighters for their heroic actions at a fire scene in Ross Township in August, which lead to the rescue of an individual that was trapped. The Mayor was honored to be able to commend the three men and was extremely thankful for their service. The Firefighters were applauded by all. The Mayor reported on the special meeting that was held in November regarding the proposed closing of vehicular traffic on the Martsolf Avenue Bridge, to become effective April 1, 2016. The Bridge will remain open to pedestrians and will continue to be inspected twice each year by Penndot. The cost to repair the Bridge is beyond the Borough's ability and the Road Crew and the Police will keep a constant

eye on the Bridge for deterioration signs. The Mayor said the total receipts for October 2015's motor vehicle code violations was \$5,059.34.

Chief of Police/Secretary/Manager Report – Chief Bruce A. Fromlak extended his congratulations to President Schell and reported on the Police Candidate Eligibility List progress. The oral and written tests are over and the 5 Candidates that passed will be interviewed on November 24<sup>th</sup>. The Chief reported on the study conducted on Lehigh, as a stop sign was requested due to reported speeding in the 25mph zone. Chief said that out of 11,000 vehicles over a 1 month study, 85% of the vehicles were doing 25 and under, so this matter would be further studied. The Police responded to 3,669 calls to date, averaging 13 per day and Chief reported the Borough recently hired Part Time Officer Jacob Schmitt. The Chief said the curb work in front of the Borough building is done and the parapet work is on-going. The proposed budget for 2016 is tax neutral and remains at 5.4 mills. The paving project is all but complete, with minor sealing along Center needed. The leaf collection is on-going and the Community Clean Up was a success, with 4 30 yard dumpsters being filled, along with 95 electrical items being collected. The next Clean Up will take place in April and Chief thanked Ms. Karnavas for organizing this event.

There was no report from Solicitor Michael J. Witherel. Glenn Engineering – Robert E. Zischkau reported that he does not have the interim consent order yet and would report to Council upon receipt. Mr. Zischkau extended his congratulations to Council President Schell and said he has learned a lot from Mr. Schell. Report from the Fire Chief – Mark W. Scheller – Chief Scheller congratulated Mr. Schell and the 3 Firefighters on receiving their commendation and requested all Firefighters in the Audience stand to be recognized, which they did and were applauded by all.

Reports from the Committees – Finance Report – Bryan S. Kircher read the finance report for October 2015 as follows: Wage tax collection deposits for October totaled \$150 and West View received \$75.01. A total of \$33,261.60 was deposited into the general fund checking account by Keystone Collections. Our liquid fuel checking account had a balance of \$159,036.59 as of October 31<sup>st</sup> and earned \$1.30 in interest. Our building fund money market account had a balance of \$63,443.40 as of October 31<sup>st</sup> and earned 52 cents in interest. Our general fund money market account had a balance of \$63,443.40 as of October 31<sup>st</sup> and earned 52 cents in interest. Our general fund money market account had a balance of \$1,000,335.93 as of October 31<sup>st</sup> and earned \$7.89 in interest. Real estate tax collections totaled \$66,152.69 in October. Local service tax collections totaled \$6,816.59 and the Borough received \$6,161.16. Business/mercantile collections totaled \$28,269.72 and the Borough received \$14,139.86. Mr. Eugene Borio had no property and purchasing report.

Public Works Report – Robert D. Schellhaas said the Road Crew completed 18 work orders in October and have been busy with leaf collection throughout the Borough. The Crews repaired one storm inlet and Mr. Schellhaas remarked how nice the Borough looks, partially due to the leaf collection. Budget/Administration Report – Bryan S. Kircher thanked his committee, Mr. Aguglia and Ms. Steele, along with Chief Fromlak and Mrs. Mann, for their help with the 2016 proposed budget. Fire and Water Report – Donald E. Mikec – Mr. Mikec said the West View Volunteer Fire Department responded to 31 calls in October for a total of 85.05 man hours used. Year to date, the Department has responded to 329 calls, averaging 33 calls per month or 1,300.3 staff hours.

Public Relations and Recreation – M. Kimberly Steele – Ms. Steele said the Halloween Parade was a success, thanking Council, the Road Crew, the Fire Department and Mrs. Rapp for their help. Volunteers packed 1,400 goodie bags for the children. Ms. Steele announced Beth Schellhaas is organizing Community Connection's Celebrate West View, which is light up night on Friday, December 4<sup>th</sup>, between 6 and 8 p.m. Junior Council Member Austin Babjak reported the North Hills Basketball season begins November 24<sup>th</sup>.

Audience – Ron Smart from 237 Clairmont addressed Council regarding Clean Rivers Campaign and the Pittsburgh Water and Sewer Authority, addressing the green infrastructure and source reduction, Alcosan, and discussed sewer bills and their increasing costs and wanted Council to send a letter to the PSWA regarding these matters. Mr. Smart was in front of Council for 3.31.39 minutes. Mayor Henry thanked Mr. Smart for his comments and said the Borough Engineer works along with Alcosan and Girty's Run and must make sure of our decrees first and then will consider his request. Jim Barr from 200 Frankfort addressed the PWSA Study, questioned if there was an update on the consent decree, questioned the street sign replacement and if this was a Federal mandate. Mr. Barr knows a family that received a turkey dinner in a box and wanted to know who is doing this and questioned the costs pertaining to the Perry Highway intersection. Mr. Barr questioned if the draft budget would be on line and if salary increases are budgeted? Mr. Barr was in front of Council for 8.32.9 minutes. Maureen Nagle from 125 Chalfonte addressed Council regarding their passing an Ordinance making it illegal to use high frequency ultrasonic devices in the Borough and spoke at length regarding the harmful effects. Chief Fromlak referred this matter to the Solicitor, but Solicitor Witherel said he has never heard of such an Ordinance but would look into the matter if Council so chose. Mayor Henry added that he sympathized with Ms. Nagle, but Council has received only one complaint, but an Ordinance like this seemed like it would be hard to enforce. Ms. Nagle was in front of Council for 6.30.47 minutes.

There was no old business or new business and Mr. Aguglia moved onto the Agenda. Agenda Item #1 – Council to consider Resolution #1432. Motion to read # 1432 made by Mr. Kircher was seconded by Mr. Mikec. Motion approved and ordered. Chief Fromlak read #1432, a Resolution authorizing the filing of an application for \$47,000 in grant funds with the Allegheny County Department of Economic Development for the reconstruction of Columbia Avenue. Motion to approve Resolution #1432 made by Mr. Schell was seconded by Mr. Mikec. Motion approved and ordered.

Announcements – Vice President Aguglia remarked how nice the Halloween Parade was and how polite the Children in the Parade were. Mr. Aguglia thanked everyone for attending tonight's meeting and requested a Motion to adjourn. Motion made by Mr. Kircher was seconded by Mr. Borio. Motion approved and ordered. The Meeting adjourned at 7:53 p.m.

Minutes of the regular meeting of the Town Council of the Borough of West View, held Thursday, December 10, 2015 in Council chambers at 441 Perry Highway, Pittsburgh, PA 15229. The meeting was called to order at 7:00 p.m. by Vice President William F. Aguglia, followed by a moment of silent prayer with special reflection for President Barry G. Schell, and the pledge of allegiance to the flag. Chief of Police Bruce A. Fromlak conducted roll call. Members of Town Council present were: Vice President William F. Aguglia, Members M. Kimberly Steele, Bryan S. Kircher, Robert D. Schellhaas, Donald E. Mikec and Eugene Borio. President of Town Council Barry G. Schell was absent. Also attending were: J. R. Henry, Mayor, Chief of Police Bruce A. Fromlak, Assistant Secretary Patricia A. Rapp, Solicitor Michael J. Witherel, Robert E. Zischkau from Glenn Engineering and Fire Chief Mark W. Scheller.

Motion to approve the special workshop minutes held November 12, 2015 made by Mr. Kircher was seconded by Ms. Steele. Motion approved and ordered. Motion to approve the minutes of the regular meeting on November 12, 2015 made by Mr. Schellhaas was seconded by Mr. Kircher. Motion approved and ordered. Motion to approve payments for net pay and payroll withholding for \$144,422.36 made by Mr. Mikec was seconded by Ms. Steele. Motion approved and ordered. Motion to approve payments to vendors for \$138,323.01 made by Mr. Mikec was seconded by Mr. Borio. Motion approved and ordered.

Motion to approve payments for liquid fuel fund expenditures for \$4,609.67made by Ms. Steele was seconded by Mr. Schellhaas. Motion approved and ordered. Motion to approve payments for building fund expenditures for \$5,145.18 made by Mr. Mikec was seconded by Mr. Kircher. Motion approved and ordered. Reports from the Officers – Mayor's Report – J. R. Henry, Mayor reported the total receipts for motor vehicle code violations for November 2015 were \$6,518.81. Mayor Henry advised Council on the CONNECT meeting he recently attended and discussed the proposed Alcosan takeover of the Borough's trunk lines. Mr. Zischkau added the takeover by Alcosan would be a winning situation for West View.

Chief of Police/Secretary/Manager Report – Chief of Police Bruce A. Fromlak reported the Police have responded to 386 calls to date, averaging 12.9 calls per day. The Chief said an advertisement will run in the legal ads, announcing the 2016 meeting dates for Council as the second Thursday of each month at 7:00 p.m. Report from Glenn Engineering – Robert E. Zischkau reported he has not received the consent orders from the DEP and will report to Council as soon as he receives them. Report from the Solicitor – Michael J. Witherel added he had checked on the consent orders and only two municipalities have not received their orders to date, with West View being one.

Report from the Fire Chief – Mark W. Scheller – Chief Scheller reminded everyone to water their live Christmas trees and check their extension cords, as both are leading causes for fire during the Christmas holidays. Chief Scheller said a deposit has been received for the old ladder truck from a potential buyer out of Morgantown, WV. The Chief said Santa will be visiting the Borough, with both Company #1 and #2 making their rounds on Monday, December 14<sup>th</sup>. The Chief did not know when #3 Santa was going out.

Reports from the Committees – Finance Report – Bryan S. Kircher – Mr. Kircher read the November report as follows: There were no delinquent wage tax collection deposits in November. A total of \$81,222.82 was deposited into the general fund checking account by Keystone Collections. Our liquid fuel checking account had a balance of \$159,037.94 as of November 30<sup>th</sup> and earned \$1.35 in interest. Our building fund money market account had a balance of \$63,443.94 as of November 30<sup>th</sup> and earned \$.54 in interest. Our general fund money market account had a balance of \$1,000,345.10 as of November 30<sup>th</sup> and earned \$9.17 in interest. Real estate tax collections in November totaled \$42,709.51. November's local service tax collections totaled \$7,983.42, with the Borough receiving \$7,215.78. Business / Mercantile collections totaled \$2,457.62 and the Borough received \$1,228.82. Property and Purchasing Report – Eugene Borio – Mr. Borio had no report for Council.

Public Works Report – Robert D. Schellhaas – Mr. Schellhaas said 20 work orders were completed by the Road Crew in November. The Crew collected 16 loads of leaves, which were taken to North Park and the Crew also collected 147 bags of leaves. The Crew has been busy using cold patch to fill holes in the Borough streets and have put up all of the Christmas decorations throughout West View. Mr. Schellhaas reported the Crew has been distributed door hangers during the week of December 1<sup>st</sup> to residents whose garbage cans were left out on the curb after collection. Budget / Administration Report – Bryan S. Kircher reported the 2016 Budget is to be considered by Council on the Agenda and, with no questions regarding the Budget, Mr. Kircher requested Council consider approving the Budget.

Fire and Water Report – Donald E. Mikec – Mr. Mikec added to the Chief's meeting notice report, stating the exception of the January 4<sup>th</sup> re-organization meeting, which will be held at 6:30 p.m., with the regular monthly meeting to immediately follow. Mr. Mikec said the West View Volunteer Fire Department responded to 24 calls in November, averaging 73.63 man hours, with year-to-date responses totaling 352, averaging 32 per month at 1,373.93 total man hours.

Public Relations and Recreation Report – M. Kimberly Steele said the Crime Watch meeting will take place on Monday, December 14<sup>th</sup> and will discuss addiction to pharmaceuticals. Junior Council Member Report – Austin Babjak had no report for Council. Audience – Mr. Aguglia welcomed anyone wanting to address Council to come to the podium – Dave Urban from 60 Lakewood questioned Mr. Schell's health status, complained of the red Kia parked out front in the handicapped with no plate or placard and was in front of Council for 1.10.98 minutes. Jim Barr from 200 Frankfort questioned Council about the Borough code book and the recodification and Chief advised the current code book can be accessed online at our website <u>www.wvboro.com</u> by clicking on the code button. Mr. Barr questioned Mr. Mikec on the fire and water report, questioned where the old ladder truck was being kept, questioned the federal Alcosan mandate and the mandated 9 minimum controls. Mr. Barr was in front of Council for 7.49.78 minutes.

There was no unfinished business or new business and Mr. Aguglia moved onto the Agenda. Agenda Item #1 - Council to consider Ordinance #1487. Motion to read #1487 made by Mr. Kircher was seconded by Mr. Schellhaas. Motion approved and ordered. Chief read #1487, which is an Ordinance fixing the 2016 tax rate at 5.4 mills. Motion to adopt #1487 made by Mr. Kircher was seconded by Mr. Mikec. Motion approved and ordered. Item #2 - Council to consider Ordinance #1488. Motion to read #1488 by title only made by Ms. Steele was seconded by Mr. Schellhaas. Motion approved and ordered. Chief read #1488, which appropriates specific sums (\$5,562,870) estimated to be required for the Municipal Government for the year 2016. Motion to adopt made by Mr. Kircher was seconded by Ms. Steele. Motion approved and ordered. Item #3 - Council to consider Resolution #1433. Motion to read #1433 made by Mr. Kircher was seconded by Mr. Mikec. Motion approved and ordered. Chief Fromlak read #1433, which is a Resolution authorizing the Police Employees to contribute 2% into the Police Pension Plan for 2016, pursuant to Act 600. Motion to approve #1433 made by Mr. Borio was seconded by Mr. Mikec. Motion approved and ordered.

Agenda Item #4 – Council to consider an appointment to the West View Water Authority Board to replace Mr. Nowark. Motion to appoint Ms. Steele made by Mr. Kircher was seconded by Mr. Schellhaas. Motion approved and ordered. Ms. Steele's term is through December 31, 2019, which is Mr. Nowark's unexpired term. Item #5 – Council to consider appointing a full time Police Officer from the 2015 Police eligibility list. The Chief said all testing has been completed on the candidates and the top Candidate to consider is Michael Bosiljevac, who has been working part time for the Borough since April. The Chief recommended Council consider hiring Officer Bosiljevac full time, with the condition he passes his physical. Motion to

hire Michael Bosiljevac, with the condition, made by Mr. Kircher was seconded by Ms. Steele. Motion approved and ordered. Council congratulated Officer Bosiljevac.

There were no announcements and Vice President Aguglia thanked everyone for attending and wished everyone a Merry Christmas. Mr. Aguglia requested a motion to adjourn. Motion to adjourn made by Ms. Steele was seconded by Mr. Kircher. Motion approved and ordered.
